#### **Purpose**

To oversee the management of council's infrastructural assets, utility services and public facilities.

### **Key responsibilities**

  - Waste and drainage
  - Solid waste, waste minimisation and recycling services
  - o Water
  - o Parks and reserves

## Summary of Contracts Approved Under Delegated Authority

This attachment provides a summary of the award process and works being undertaken for Infrastructure contracts awarded under Chief Executive and General Manager delegated authority.

#### 1.0 Roading

CON18076 Nova Scotia Road Bridge No. 606 Upgrade

#### Introduction

Contract 18076 is for Nova Scotia Road Bridge No. 606 Upgrade of the bridge structure including the re-painting of the superstructure beams, replacement of the diaphragms, pile jacketing, replacement of timber bracing and linkage to ensure a continual level of service to users.

#### **Procurement Process**

Tenders have been evaluated in accordance with the Conditions of Tendering stated in the tender documents. The tender evaluation method is "Price Quality Method Simple (PQM Simple)" in accordance with the New Zealand Transport Agency Procurement Manual (September 2019).

The tender evaluation team **(TET)** consisted of the following members: Richard Kolkman (WSP New Zealand) (Qualified Evaluator and TET Leader) Don Anderson & Zander Cutang (Northland Transportation Alliance) Dewi Todd-Jones (WSP New Zealand)

#### Tenders Received and Evaluated

The tenders were opened on 4 October 2019 using the Tenderlink forum and only one tender was received.

The subject Tender received one submission only and was deemed acceptable for evaluation due to the shortage of contractors bidding for bridge works. The evaluation consists of 2 stages as follows:

Stage 1 of the tender evaluation method involved checking that the non-price attributes



were in accordance with the Tender Document. All tender attributes were addressed to the satisfaction of the tender evaluation team. ACL obtained good grades for each attribute reflecting their satisfactory submission and experience of successfully completing similar projects in the past. The TET also received positive references with regards to the tenderer and the quality of their workmanship on similar projects in the past.

Stage 2 of the tender evaluation involved an arithmetic check on the Asset Construction Ltd pricing schedule. No errors were found in the Tenderers' Schedule of Prices or Form of Tenders.

The tendered sum from ACL was far in excess of the Engineer's Estimate. The difference with Engineer's Estimate is believed to be due to the Contractor being originally from Auckland and supplying prices more akin to those usually seen in the overheated Auckland market. Also, the engineer's estimates were not purely reflective of current market rates hence the big difference between the submitted price and the engineer estimate.

Due to Whangarei District Council not having the funds to complete the works at this price, the TET alongside the Northland Transportation Alliance (NTA) agreed that the process would move to direct negotiations, with a view to reducing the tendered sum to a more reasonable value.

The main reason for receiving only one tender was due to the current workload in the region as well as some major NZTA and Council projects. Contact was made to the main local bridge Contractors and it was determined that retendering was unlikely to bring further tenderers on board.

#### **Direct Negotiations**

ACL were informed that their price was significantly higher than the Engineer's Estimate, and that if the project was to proceed, they would need to review their pricing and allocation of risk with the overall aim of achieving better value for money without impact to quality.

The TET commenced negotiations with ACL where they thought particular scheduled items may be excessive, and as a result ACL resubmitted a tender price of \$439,849.00 (excluding GST) which was deemed acceptable by the TET.

The savings in their Tender Sum has come about by a reduction in their rates for most of the scheduled items. The revised tender sum of \$439,849.00 (excluding GST) also includes an allowance of 9% for provisional works, subject to Engineers approval.

#### **Financial**

The budget for the Nova Scotia Road Bridge No. 606 Upgrade for 2019/20 is \$450,000.00 (excluding GST).



#### Chief Executive Approval

The contract for Nova Scotia Road Bridge No. 606 Upgrade (CON18076) be awarded to Asset Construction Ltd. for the tendered sum of \$439,849.00 (Four Hundred thirty-nine thousand, eight hundred and forty-nine dollars) excluding GST.

CON19061
Minor Roading Improvements Package 19-20

#### Introduction

The works in Otangarei include the implementation of the second (final) stage of traffic calming in the area. In 2018-19, speed bumps were installed in Keyte St and several raised central medians (splitter islands) were installed at many intersections within the Otangarei catchment. This year's works include installation of speed bumps in the remaining western section of Jack St and raised central medians at three remaining intersections in Otangarei.

As part of the recent development in Kensington by the Regent Countdown, they were required to install physical measures in Wallace St and Dinniss Ave, as part of their resource consent requirements. It was stipulated that the commercial delivery vehicles will only be allowed entry to the Countdown site through Manse St/Wallace St intersection, not through Dinniss Ave, because of the residential nature of that area. Roading (NTA) was then requested to implement these works on behalf of Countdown. It was later agreed between Roading and Countdown to install raised central medians (splitter islands) in Wallace St and Dinniss Ave at three intersections, to fulfil Countdown's resource consent requirements. It was agreed that Countdown will pay the Council for the works at Dinniss Ave/Kamo Rd intersection and Wallace St/Countdown site intersection, and that the Council will pay for the works at Dinniss Ave/Wallace St intersection.

#### **Procurement Process**

The engineer's estimate for this contract was \$178,605.00 excluding GST. For a procurement of this value, both WDC's Procurement Policy and NZTA's Procurement Manual allow a closed competition to be used.

The following five contractors were approached and all five expressed an interest in pricing the works and were sent the Tender Documentation:

- Broadspectrum
- Downer
- Fulton Hogan
- Robinson Asphalts
- United Civil



#### Tenders Received and Evaluated

Tenders were closed on 25<sup>th</sup> November 2019. Two tender submissions were received as per below:

#### **Financial**

Countdown has agreed to make a full contribution for their share of works, an amount of approximately \$56k with the balance paid by Roading.

There are sufficient funds available within the Council's Roading Low-Cost Low-Risk improvements 19-20 budget to undertake these works.

It is proposed that a contingency of 5% of the tender price, a sum of \$9,999.23, be allowed to the tendered price to allow for any unforeseen variations, increasing the total contract price to \$209,983.83 excluding GST.

#### General Manager Approval

The contract for Minor Roading Improvements Package 19 - 20 (CON19061) be awarded to Broadspectrum for the tendered sum of \$209,983.83 (two hundred and nine thousand, nine hundred and eighty-three dollars, and eighty-three cents) excluding GST.

## 2.0 Infrastructure Planning & Capital Works

Professional Services	
Reservoir Assessments	

#### Introduction

Water Services conducts condition assessments of its 28 reservoirs in general every five years, the last assessments were undertaken in 2014-15. The previous inspections, subsequent seismic assessments, detailed designs of any remedial works and specification of maintenance activities were undertaken by Opus's local structural engineering staff. Over the last five years they have become very familiar with the various reservoirs.

Ideally, the reservoir assessments are undertaken by an experienced structural consultant with staff familiar with Water Services reservoirs. All the reservoirs need to be inspected and therefore it is beneficial to have a local structural engineer do the inspections to avoid significant travel costs.

Water Services consider the only local consultant who adequately meets these



requirements is WSP (formerly known as Opus International Consultants) and propose to engage WSP directly for the provision of professional structural engineering services.

#### **Procurement Process**

The value of the works is such that the contract can be negotiated with a sole supplier in accordance with Council's Procurement Policy.

The scope of works, programme and fee was directly negotiated with WSP.

The fee (\$98,885 excluding GST and including a contingency of \$2,000.00) and personnel rates offered by WSP are acceptable.

#### **Financial**

The project will be paid out of Reservoir Rehabilitation PJ 00294 - 2736, which has a budget of \$376,497.00 this financial year. To date, \$168,251.00 has been committed for maintenance activities. After committing to this contract for \$98,885 there will be \$109,361.00 for other work.

#### General Manager Approval

The contract for Reservoir Assessments Professional Services be awarded to WSP for the sum of \$98,885.00 (ninety-eight thousand eight hundred and eighty-five dollars and zero cents) excluding GST.


#### Infrastructure Planning

We are working with Waste and Drainage on the renewal of the Whangarei Waste Water treatment Plant discharge consent. The application needs to be submitted by end of 2021.

New consents applications are being developed for Transfer Stations and Closed landfills under the Proposed Regional Plan to meet the 6-month timeframe for submission.

## Infrastructure Development

#### **Development Engineering**



The number of reports completed in November were 18 and 11 in December 2019. The 8-day level of service for engineering report delivery was 17% in November and 18% in December 2019. This decrease in performance is due to additional steps in our process including departmental manager sign off and external geotechnical reviews as this is an identified gap in the consent process. We expect this value to increase as we adjust to the new processes. We continue to rely on external consultants who processed 33% of all applications assessed in November and 73% in December 2019.

Applications received in November included a 96 Lot subdivision in Sands Road and a boat sales yard in Port Road.

Two subdivisions at Te Hape Road has been completed with a third development underway. Stage 3 of WFH at One Tree Point, being 76 residential and 3 commercial lots, is under construction with roading and services work well underway. Engineering design for stages 4 and 5 has been received for WFH – The Landing in One Tree Point.

Engineering plans are being assessed for Bupa Retirement Village in Totara Parklands and 69 Lots at 115 Three Mile Bush Road.

The number of inspections undertaken is increasing as the weather improves and the summer contracting season is underway.

## Waste and Drainage

#### **Operations and Maintenance**

#### Whangarei WWTP resource consent renewal

W&D has extended the baseline ecological monitoring at Limeburner's Creek and surrounding area for the main plant resource consent renewal. In the final report, a recommendation was made to repeat the monitoring during summer of 2019/20 to build a more robust dataset. The majority of the monitoring locations had no previous data and repeat monitoring is considered important to understand natural variation.

The extended monitoring will provide a comprehensive 2 years of data which allow W&D to assess the baseline ecological conditions in Limeburner's Creek as well as in the Whangarei Harbour context. The results will inform the Assessment of Environmental Effects (AEE) which will be submitted along with the WWTP Resource Consent Renewal application, targeted for April 2021.

WDC have also asked a consultant to provide a Best Practicable Options (BPO) review of current plant performance which will also be submitted along with the WWTP Resource Consent Renewal.

#### **Rural WWTP Major Operation & Maintenance**

#### Waipu:

The plant recorded excellent results;

#### Ruakaka:

- A sludge survey was completed in Q3 2019. The operations team decided to de-sludge the irrigation area and clean up the wetland to improve the water quality of the sea bore holes No 2 and No 3;
- Two new surface aerators were ordered to improve plant treatment capacity. The existing aerator unit shall be set aside as a spare it is still operational but quite old;

#### Ngunguru:

- The treated effluent ammonia meets the current Resource Consent requirements. However, the median of 12 values still exceeds the Resource Consent limit. W&D have opted to trial a demo MABR (Membrane Aerated Biofilm Reactor) unit to treat high ammonia levels. The demo will provide WDC with an understanding of MABR technology capabilities in the following areas:
  - Ability to treat ammonia and phosphorus in conjunction with existing oxidation ponds;
  - The plant may be able to treat biological nutrient removal without changing the plant process design and integrations;
- The estimated delivery time of the demo unit is Jan 2020 it is being shipped from Australia. However, the unit
  is approximately 4.00 m high, which makes transporting it by truck from North Port to the plant quite challenging.
  These logistics are still being worked through;

#### Hikurangi:

- The plant is still non-compliant with faecal coliform and has some impacts to the downstream environment;
- In an attempt to find out why the membrane was fouling and whether or not membrane performance could be recovered, one module of the plant was harvested and sent to Australia. It is estimated that the report on findings and further investigation requirements, if any, will be available by end of Jan 2020:



• WDC have updated NRC regarding the entire process of independent testing.

#### Tutukaka:

- The 6-monthly report has been submitted to NRC.
- The step screen is showing signs of wear and the operations team are looking at options for replacement.

#### Oakura:

- The plant was de-sludged.
- Blower time was increased from 60 min to 90 min to prepare for summer peak.

#### Reticulation

There were two recorded spill incidents in Dec 2019. All sites were disinfected.

#### **Solid Waste Operations**

The delivery of blue crates for glass recycling collection has been completed for the whole district, 37,087 new crates have now been distributed. The recycling collections using the additional blue crates for glass has improved as residents have adjusted to the new system. There have been a small number of complaints, but feedback has generally been positive. There have been calls for wheeled bins for all recyclable material and the customer services and communications teams have attempted to explain the rational for separate collection. The new recycling collection truck with a sideloading trough has been delivered and some minor modifications have been identified before further trucks are delivered. The separate crate for glass appears to have reduced the number of accidents that the collection workers are suffering when sorting glass.

The tonnage of recycling collected has remained similar to last year, rural transfer station rubbish continues to decline, whilst kerbside rubbish continues to increase.

#### **Laboratory Report**

During November 2019 the Laboratory analysed 797 samples requiring 2506 tests. 19.6% of the tests were subcontracted and 53% of results were reported within 5 working days. For December 785 samples were analysed for 2530 tests. 15.7% of the tests were subcontracted and 60% of results were reported within 5 working days. Collectively this represents an 7.5% increase on testing performed when compared with the same periods last year.

A Leader and Facebook advertising promotion for E coli testing during November and December was successful in raising the awareness of water quality testing for household water supplies.

#### **Speed Management:**

Formal Consolation has started on the following areas as part of Tranche 1;

- Te Torioa Rd (Legal Unformed Road) Ngunguru, which forms part of the Old Ngunguru Coach Trail.
- Vinegar Hill area
- One Tree Point / Marsden / Ruakaka area
- Waipu area

Submissions are due to close early December, staff will report to Council on our recommendations, taking into account the publics feedback in the New Year.

For Tranche 2 we will focus on Whangarei Heads, the Statement of Proposal will be presented to Council in March/April to enable consultation in April/May.

Tranche 3 will be in mid-late 2020. We will review the Tutukaka Coast (Ngunguru Rd & Russell Rd) and Bream Bay (Cove Rd). These two areas will be reviewed concurrently with Kaipara and Far North to ensure a seamless and coherent approach to both consultation and delivery of speed management.

#### Walking and Cycling (Shared Paths):

- Kamo Shared Path was formally opened on 25 November 2019. We have submitted a business case with NZTA
  for funding for Stage 5, additional links to schools and improvements. The decision on additional funding for
  2019-20 is due late December.
- City Centre including Onerahi link and improvements to Hatea Loop this is being led through a combination of 'Blue Green Network', 'Inner City Development Plan', 'complete streets' and 'Speed Limit Reviews'. Over the next 6-12 months we will produce a SSBC to capture the essential aspects of these workstreams into a single programme of work which we can seek Council and NZTA funding for over the next ~5 years.

#### **NZTA Northland Integrated Cycle Network**

- NZ Transport Agency, with funding from the Provincial Growth Fund (PGF) has completed a Detailed Business Case for 13 Coastal Trails within Northland. This is one of 6 detailed business cases that the agency received funding to complete in Northland, as part of the Twin Coast Discovery Highway and Byways Programme Business Case. The business case identified the economic potential of these trails and prioritise them for implementation. This will enable the councils to leverage off the business case for future funding opportunities such as PGF. Business Case is complete and has been submitted to the NZTA board for adoption and consideration.
- We are now investigating a few low-cost low-risk options to seek co-funding on.
- We are working on a number of Heartland Ride (on-road trail) applications to realise early some of the benefits of the 'completed' off-road network.
- The Waipu Trail is a piece of this wider network.

#### Waipu Walk & Cycle Trust

- Stage 2a Cullen Rd to Waipu Cove Physical works has started, this involves some associated road works to be completed by Council.
- Stage 2b McLean Rd to Cullen Rd The trust is going to apply for a consent to Whangarei and Regional Council
  for the trail to follow the estuary. The outcome of this consent will determine which route we implement; follow the
  estuary or Cove Rd. Noting the estuary option will be cheaper, safer and a better experience, however it may have
  adverse environmental impacts which need to be consider and mitigated (if possible).
- Stage 3 Riverview Place to Cullen Rd the outcome of the consent for Stage 2b will also determine this route.

#### **New Footpaths**

We have awarded most of the works to Broadspectrum and Downers:

- Paranui Valley Rd Stage 1 works are complete, balance Stage 2 currently under investigation and design to be completed early 2020. Construction deferred to 20/21.
- Mackesy Road and Konini Street works to start by Downer March.
- Railway Rd Shared Path (between Okara Dr and Railway Rd carpark) completed in 2019
- One Tree Point Rd design 2019/20. Implement 2019-21



- Pipiwai Rd (near sports grounds). Drainage currently under design with construction early 2020.
- Helifax to Town Centre (Waipu) detailed design almost complete. To be constructed in March 2020
- Albert St (Woods Rd to Clyde St) works deferred until land ownership is resolved between Council and LINZ.

#### **LED Street Light Conversion**

- 1,200 V-Category (arterial road) lights in Whangarei City have arrived on 13 May. Another 360 V-Category lights for rural towns have arrived on 13 December.
- The installation of the V-Category retrofit lights (ie swapping the old light for new LED) being undertaken by Currie Electrical is well underway and is 95% complete. The remaining lights will be replaced early in the new year.
- Tenders are currently being evaluated for the installation of completely new V-Category infill streetlights (ie those requiring new poles). These tenders are expected to be awarded in January. The installation of these lights is expected to commence in late January/early February 2020 and be completed in late 2020.
- We are currently investigating both Auckland Transport's central management system (CMS) and the NB Smart Cities CMS to control the new LED streetlights.

#### **Inner CBD Transport Model**

The optioneering using the Inner CBD Transport Model has been completed and the results of the Complete Streets
Masterplan, One-Way System and individual projects have been received. Further modelling in January will refine
the preferred package of the projects for both the short and long term.

## Parks and Recreation

#### **Operations**

#### **Walking Tracks**

The renewal of the walking tracks within Mackesy Bush has been completed and they were formally opened with a blessing on 12<sup>th</sup> December, attended by about 40 people. Plantpro have made a great job both in the design and the build, this being a steep and challenging site in places. Feedback from users has been positive although the climb up from the Ross Track is slightly daunting with 200 steps. Fitness fanatics will enjoy the additional workout. It is hoped that this work will go a long way towards protecting kauri within this block from dieback disease, there being a substantial number of both mature, semi-mature and young ricker trees.

Our network of walking tracks is generally in excellent condition. Extended dry weather can make the surface loose however and more prone to foot erosion.

The walking track between the Whananaki Coastal Walkway and the Capitaine Bougainville Monument has had to be closed. This route was across private land with no legal agreement and with the prospect of development, the access has been removed. Access to the monument is still legally possible from the beach at low tide, it will be necessary to



construct steps however to negotiate the steep slope up to the monument. WDC will negotiate with developers to agree a new access if possible.

#### **Tree Maintenance**

A major split has been identified in the huge tree in the CBD Mall outside Michael Hill. This was temporarily braced while investigations were made into how best to manage this tree – now removed.

#### **Coastal Structures**

Progress has been made on the scheduled maintenance for 2019/20, the contractor has indicated where the scope of tendered works has changed resulting in only minor increases. Currently the bulk of the works package is programmed to be completed by the end of March 2020.

#### **Sports Fields**

Conditions for turf are now extreme and towards the end of December warm season grasses like couch and kikuyu are struggling. While fields with irrigation are not being watered in order to stress undesirable species out of the sward like *Poa annua*, watering will be needed.

Very positive compliments from Northland Cricket over the preparation and management of the oval for the visiting English Cricket team playing New Zealand A at Cobham Oval in early November. Compliments have been received by our contractor about the condition of the club wickets around the city too.

Much of the summer activity on the fields decreased over the Christmas break, and with mowing regimes requiring less input, there has been a chance for contractor staff to have some time off and catch up on some other tasks.

#### **Parks and Gardens**

November saw a number of thunder storms that saw the western and southern district get saturated, but the rest on the district, including Whangarei city missed a large majority of the rain. The city only saw 44mm in November and that was followed up with 47mm in December. With average temperatures higher than normal and constant windy days, general conditions are getting very dry.

The coastal runs are very busy during the second half of December, with people on beaches, and freedom campers everywhere. The contractor is increasingly required to work around these people. This year they made a specific attempt to finish maintaining all the coastal site by mid-December, so they didn't have to attempt to do maintenance on the coast on the lead up and during the holiday period.

In early November a large fire destroyed the vegetation on Parihaka. About 4ha of scrub and re-generating bush were burnt by the mountain bike tracks adjacent to Abbey Caves Rd. While the fire did little damage to the tracks in the area, for health and safety reasons, we had to close the track for a week while the fire service dampened down the site. The fire has caused some maintenance headaches and opened up some opportunities. The fire killed the majority of the remaining pine trees (left behind to provide shade for the tracks and suppress weeds). We have had to fell these trees to ensure the tracks are safe to use. The bare ground and clear site has opened up the opportunity to do some replanting next winter. The Mountain Bike Club has expressed an interest in helping with this. However, the regrowth of weeds has been phenomenal, and we will need to carry out weed control over the summer to enable replanting to take place. The Club plans to apply to the Matariki Tu Rakau tree planting fund for a grant to pay for the majority of the new trees.





In Cafler Park we installed 2 Friendship seats. These were donated by the Northland Indian Association. The aim of these seats is to reduce the social isolation that can be common in ethnic groups settling in the area.



#### **Playgrounds and Skate Parks**

During November and December, there was a number of vandalism / breakages of play equipment in our playgrounds. At the Town Basin the safety surfacing is starting to break in places. We are trying to do temporary repairs to the matting remains safe until the renewal in 2020.

The new shade sails have been installed at Amber Drive playground that fits the new playground better and will not give kids access onto the sail.

#### Cemetery

A quiet month with only 10 burials. The cemeteries were all looking great for over the Christmas and New year period thanks to the hard-working cemetery team. Our cadet Rawiri left in December as his term ended. Our newest Cadet has proved to be an outstanding worker, taking to all aspects of the job.

Design work is underway to convert one of the houses at the Maunu cemetery into an office while the other house will be removed to make way for parking. A review is underway on the previous Maunu cemetery master plan. The new master plan will be used to prioritised new projects in the next LTP.

At Maunu, the newest service we now offer has been completed and will be used for the first time on Friday the 17<sup>th</sup> of January for a burial service. This is an outdoor chapel planted with wisteria, which once grown will look fantastic.

#### **Botanica**

December visitor numbers: 2,108

Another great month for the team and lots of visitors, with great comments. We had a few maintenance issues, with burst pipes and old watering systems failing, but these were remedied quickly, and the plants have not suffered. A couple of new fountains have been added to the large pond in the fernery, in an effort to get more water movement and prevent algae build up. As well as been functional, they look and sound great.

We have had a couple of weddings through recently and the local rose club has booked a tour.

With the vacant lot next door soon to be cleared and used for staff and visitor parking, and as there will be room for buses, we will be able to encourage bus loads of visitors in the future.


## **Water Services**

#### **Operations**

#### **Rainfall and Water Sources**

It's official! 2019 was the driest year since our records began in 1971 and not just by a small amount. We had over 100mm less rainfall than the previous driest year, 1994. For the first time we had less than 1,000mm of rain in a calendar year with only 916mm failing at Whau Valley. This is more than 40% less rain than average or a massive deficit of 675mm for the year. Even less fell at Wilsons Dam which recorded only 840mm. Only one month, October had more than average rainfall at Whau Valley as shown in the graph below. As a consequence, staff have been running the Hatea River and Poroti sources harder than normal to try and save water in the Dam and use river water while it is available. The intensity of the rain at the beginning of October in the City helped to fill the Whau Valley Dam and it now sits at 89% full. This is just below average for the time of year. However, the dry ground and low river levels mean that the dam level will fall fast without rain soon. The lack of rainfall in Bream Bay over the year sees Wilsons Dam continue to be well below average at 78%. This is the 10<sup>th</sup> consecutive month the Dam has been at a monthly low. As we move into the warmer drier months, we will need to continue maximise our use of river and spring sources while we still can. Already we are seeing levels in the Hatea River and Ruakaka Rivers drop to levels where we are having to limit our takes.





# **Production Report** Compliance

A reticulation water sample taken at Langs Beach showed a disinfection by-product value fractionally over the allowable amount. A second sample taken at the same time was under the allowable amount. Staff will be talking to the drinking water assessors about this result and whether it constitutes a non-compliance. There was also a positive total coliform result at Langs Beach reservoir during December. No e-coli were detected, and chlorine levels were OK so the water was compliant, but the source of the coliforms remain a mystery. The reservoir is going to be thoroughly cleaned as a precaution.

#### Other works

The algal bloom at Wilsons Dam reduced considerably over the winter. However, it has not disappeared completely with the water temperature in the lake not getting below 13°C. The water temperature is now up to 22 °C. The bloom is now back again although not as bad as last summer. The compressors at both dams are running continuously to ensure the water is well mixed and this appears to be preventing the bloom getting worse but other treatment methods will now need to be considered. Staff have been liaising with the NRC about using diatoms to remove the algae. A resource consent has been obtained and trials are planned for the New Year.
