1. Apologies

There were no apologies.

Her Worship the Mayor welcomed the Elected Members and commenced the briefing at 10h43.

2. Reports

2.1 Environmental Scan for the 2018 - 28 LTP

Tony Horton led the presentation on the Whangarei District Environmental Scan for the 2018 – 2028 Long Term Plan. The Environmental Scan serves to provide an overview of the legal, social, economic, environmental and technical environment for the district and identify trends and issues to inform the strategic direction of the Long Term Plan over the next 10 years. The district is growing and changing and Council needs to make provision for an increase in expectations for amenities and levels of service in our District. Factors which must be considered are economic growth, the impact of technology, the importance of water, the environment, new requirements within the district and changing legislation.

A question was asked as to whether there are any skills shortages in the labour market required for the economic growth of the district and if so, whether the filling of these skills shortages has become a key focus for WDC. Tony advised that WDC is aware of the constraints in the labour market in the district and these constraints are considered when marketing the district.

A comment was made that Whangarei is one of the most culturally diverse districts in the country and this should be acknowledged.

With regards to the impact of technology, the question was asked as to what constitutes a "smart city" and what the costs of becoming a smart city would be. Tony advised that the key aspect is how technology can be used to make the city more efficient.

The Environmental Scan will form part of the supporting documents informing the Consultation Document which will be presented to Council in November.

2.2 Growth Model for LTP

Sonya Seutter ran through the presentation on the Growth Model for the 2018-2028 Long Term Plan. The Growth Model runs in conjunction with the Environmental scan. The previous growth model was completed in 2014 for the last LTP.

Statistics NZ released new projections in May 2017. Both Statistics NZ and other agencies have predicted stronger growth than previously estimated. Further indications of stronger growth include the Marsden Point Ruakaka area population tracking above the predicted population growth and the Port Nikau area development set to occur within the next few years which will create a further 14 000 homes in the district. It should be noted that the projections provided by Statistics NZ were only made available to 2043, however figures to 2058 are required to estimate growth.

Questions were asked as to what factors will influence population growth. Factors would include infrastructure and migration into the district. Council was advised that the new census will determine the extent of infrastructure growth and migration numbers and adjust the figures accordingly.

It was pointed out that there is a substantial difference between Statistics NZ's projection and WDC's growth model tracking. WDC'S growth model is significantly lower that Statistics NZ's medium projection. The question was asked as to whether WDC should adjust its growth model. Council as advised that it would be better to stick with the current growth model to remain consistent with the National Policy Statement – Urban Development Capacity (NPS-UDC).

2.3 2018-28 Long Term Plan - Early Engagement Results

Council was advised that the 2018 – 2028 Long Term Plan Early Engagement Results would be dealt with in three sessions.

In the present briefing, Council will look at new community requests obtained from the Early Engagement sessions and from Elected Members.

A question was asked as to whether the solid waste submissions made are included on the list. Council was advised that these submissions have been allocated to the Waste Management and Minimisation Plan.

A comment was made that none of the requests from the Early Engagement sessions bear relation to the Maori community. Council was advised that we have engaged with Maori, including running a Hui, and the requests raised there have been included in the list.

The Elected Members proceeded to list their requests which are included in this report as Annexure "A". Elected Members were requested to e-mail any additional requests to Jill.

Her Worship the Mayor thanked the Elected Members for their contributions and advised the Elected Members that the next briefing session on the 12th and 13th September will focus on prioritising all requests. The session scheduled for the 17th October will be used to review activity profiles with the prioritised projects.

3. Closure of Meeting

The briefing adjourned at 12:18.
