Purpose

To oversee the management of council's infrastructural assets, utility services and public facilities.

Key responsibilities

- Services including the provision, maintenance and capital investment for:
 - o Infrastructure asset management, projects and support
 - o Infrastructure project co ordination
 - Transportation
 - Waste and drainage
 - Solid waste, waste minimisation and recycling services
 - o Water
 - o Parks and reserves
 - o Cemetery
 - Laboratory services
 - Flood alleviation schemes
- Reporting on service delivery, including operational financial performance.
- Reporting on capital projects.
- Operational reporting for the Infrastructure group within Council.

- Procurement general procurement relating to the areas of business of this committee, within delegations.



Summary of Contracts Approved Under Delegated Authority

This attachment provides a summary of the award process and works being undertaken for Infrastructure contracts awarded under Chief Executive and General Manager delegated authority.

1.0 Roading

CON19049

Reyburn Street Bridge No. 706 and Marsden Point Road Bridge No. 102 Upgrade

Introduction

Contract 19049 is for Reyburn Street Bridge No. 706 and Marsden Point Road Bridge No. 102 to undertake heavy maintenance of the bridge's piers by jacketing the selected piles to ensure a continual level of service to users.

Procurement Process

Tenders have been evaluated in accordance with the Conditions of Tendering stated in the tender documents. The tender evaluation method is "Price Quality Method Simple (PQM Simple)" in accordance with the New Zealand Transport Agency Procurement Manual (September 2019).

The tender evaluation team (TET) consisted of the following members:

Richard Kolkman (WSP New Zealand) (Qualified Evaluator and TET Leader)

Zander Cutang (Northland Transportation Alliance)

Dewi Todd-Jones (WSP New Zealand)

Tenders Received and Evaluated

The tenders were opened on 11 October 2019 using the Tenderlink forum and no tenders were received.

Direct Negotiations

As per 'The Government Procurement Rules, Rule (14)(9)(b) (i), (ii) and (iii)', and the 'WDC Procurement Policy' where this contract falls within a 'Negligible Risk' criteria based on the 'Risk Matrix for Goods and Services', the TET engaged the following contractors in the following order to submit quotations for the proposed works in accordance with closed contest procurement rules.

- 1. Steve Bowling Contractors Ltd (SBC)
- 2. Asset Construction Ltd (ACL)

Initially, SBC were engaged directly to submit a quotation for the works as per the original tender document, however, their submitted price was deemed to be high in relation to the Engineer's Estimate. The TET subsequently engaged ACL to submit a quotation as per the works in the original tender documents. ACL's quotation was significantly lower than that of SBC, and within reasonable variance to the Engineer's Estimate.

The tender evaluation consists of 2 stages as follows:

Stage 1 of the tender evaluation method involved reviewing the Non-Price Attribute submission for conformance with the tender document.

Following the assessment of the tenderer's attributes, and obtaining responses to the tender clarification requests, representative non-price attribute grades were agreed by the TET.

Stage 2 of the tender evaluation involved an arithmetic check on the submitted tender prices. No arithmetic errors were found in the tenderer's submitted Schedule of Prices.

The pricing submitted by Asset Construction Ltd (ACL) was considerably lower than that of SBC and within a 11% variance of the Engineer's Estimate.

The quotation sum of SBC at \$372,909.50 (excluding GST) is 61% above the Engineers Estimate. With regards to their submitted price, it is considered that, SBC is inundated with current works within the area and therefore priced in significant 'risk' into their quoted sum due to staff and plant resource acquisition and works management.

The quotation sum of ACL at \$158,818.00 (excluding GST) is 11% above the Engineers Estimate. ACL were requested to clarify the price of three of the scheduled items. The contractor has visited each site, has factored in the risks into his price and made relevant proposals to mitigate these risks.

The Tender with the lowest evaluation sum was from Asset Construction Ltd at \$158,818.00 (excluding GST). The TET had also received positive references with regards to the contractor and the quality of their workmanship on similar projects in the past.

Financial

The budget for the Reyburn Street Bridge No. 706 and Marsden Point Road Bridge No. 102 Upgrade is \$150,000.00 (excluding GST). The increase in budget will be managed within the overall structure's renewal budget of \$1.0m.

General Manager Approval

The contract for Reyburn Street Bridge No. 706 and Marsden Point Road Bridge No. 102 Upgrade (CON19049) be awarded to Asset Construction Ltd. for the quotation submitted at a price of \$158,818.00 (One hundred and fifty eight thousand, eight hundred and eighteen dollars and zero cents) excluding GST.

2.0 Parks and Recreation

CON19040 Ruakaka Sand Ridge Removal

Introduction

This procurement is for the removal of 50,000m³ (out of 90,000m³) of the sand ridge alongside the Ruakaka Sports Fields as the first step to creating two new fields.

Procurement Process

Approval for a variation to the procurement policy was sought and the price was directly negotiated with Earthworx Rural and Civil Ltd.

Earthworx are a WDC H&S approved contractor who have a good track record with us and are available to undertake the work within the required timeframe.

Financial

The cost for the removal of the sand (50,000m³) to the McCathie Road Site is \$478,595.00 excluding GST.



The budget available for the removal of the sand and construction of the sports fields is \$870,000.00 excluding GST.

Once the sand ridge has been removed, the remainder of the budget will be used to topsoil the site and regrass. The area can then be marked out for sports fields. Further budget will be required for improvements such as drainage and lighting to increase the capacity of the fields.

Chief Executive Approval

The contract for **Error! Reference source not found.** (CON19040) be awarded to Earthworx Rural and Civil Ltd. for the contract sum of \$478,595.00 (Four hundred and seventy eight thousand, five hundred and ninety five dollars and zero cents) excluding GST.





The number of applications received in August for Engineering assessment was 18. A total of 15 reports were issued and 6 placed on hold for further information. The 18 applications received for engineering input is lower than the 5 year monthly average of 23.

The 8-day level of service for engineering report delivery was 87% in August. The team has been working hard to improve the delivery times. Reliance on external consultants has dropped significantly as we aim to process most applications inhouse, 100% applications were processed by Council staff in August. The Development Engineers are undertaking an increased number of inspections, we expect the number of inspections to increase over the summer construction period. We are also attending a number of pre-application meetings.

Infrastructure Support

There were 48 contract claims processed for the month of August. This is significantly lower than last month and 17 claims less than August 2019. There were 241 purchase orders processed by the team for August. The trade waste annual fees are coming up with 355 invoices created in August. Business is as usual in other areas with 31 Fast Track Water Meters processed and invoiced.

LTP Infrastructure workstream

Asset Managers continue work on the Activity Management Plans (AMPs) which will inform the first 10 years of the Infrastructure Strategy and Long Term Plan (LTP). Draft AMP projects have been sent to Finance and are part of the decision making for the next LTP. Project prioritisation methods are being worked through for Councillors decision making.

Asset Managers and Finance systems (EB and SPM) will be updated in the iterative process of arriving at a set of Capital projects that will make it into the Draft LTP. The Infrastructure Strategy work is on-going with work taking into account climate change strategies and Audit NZs signalling of expectations in this area.

Health and Safety

Health and Safety Risk Update August 2020

- Traffic Risk Traffic risks and aggressive persons encounters are the two highest risks facing Council staff. A vehicle accident was reported by a staff member when another vehicle sideswiped them, following the driver acting in an aggressive manner, which included both risks. Contractors also reported several near misses involving other drivers. In terms of traffic risks, a positive to report is the Water distribution and Water Operations teams have now successfully reached noncompliance to traffic management requirements. A minimum risk standard for traffic exposure was developed with assistance from Infrastructure staff.
- Policies and procedures: A protocol to enter dangerous buildings following fire or other disaster has been drafted, with help from members of the infrastructure team. Our permit to work, lock out and confined space entry procedures have also had a review and update. As these are mainly used by Infrastructure departments to help keep workplaces safe, we have had representatives from this group assisting with these reviews.
- Moving machinery: A minimum risk standard for working around moving plant and equipment has been drafted and sent out for comment. This will be sent out to contractors shortly for comment as well.
- Injuries we had no serious injuries this month, but one of our contractors dismissed two of their staff for participating in a high-risk activity of trying to retrieve some shoes, hanging from a powerline.
- Slips, trips and falls: There have been several injuries resulting in hospital visits, by member of public who have tripped and fallen on the two traffic sensors at the Forum North carpark. The Northland Transport Alliance have been asked to assist in mitigating this risk as well as continue to paint all the curbs white, so they stand out as a trip risk.
- Energy risk: we had three near misses involving hydraulic or pressurised hoses reported by contractors. This is an unusual trend and will be mentioned to contractors as a potential risk in our next monthly update to them.



Waste and Drainage

Operations and Maintenance

Whangarei WWTP

In the first ten days of August, the plant received fluctuating flows of between 17,000 to 19,500 m³. Rainfall on 11th boosted the flow to its second highest peak of the month, just over 38,600 m³. A steady decline, from 12th to 17th followed, reaching around 19,500 m³. Further rainfall caused the inflow to peak at just over 46,300 m³ on 19th. After that, a gradually decreasing trend was evident until end of the month. Rainfall of 22 mm recorded on 23rd rebounded the flow to its third peak, around 38,500 m³.

Whangarei WWTP Resource Consent Renewal project

W&D team and the consultant have completed the following key activities as part of the Whangarei wastewater treatment plant (WWTP) Consent renewal strategy including the following studies:

- Consenting strategy review: the consenting programme was updated based on work completed and prioritizing steps going forward;
- BPO (Best Practical Option) phase 1: plant assessment report now completed; report highlights areas of non-compliance against current consent limits, areas that need to be focused on going forward with regard to population growth; an initial long-list of options has also been identified. The process flow of the plant was reviewed and updated.
- Nutrient Balance (Water Quality Phase 1): Simplistic mass balance approach looking at plant contribution loads currently and scenarios into the future which will be used to inform discussions with NRC. Reporting for this step shall be incorporated into the next phase of work.
- Planning Review: Review of the legislative framework, highlighting risks with regards to changes through appeals on the PRNP (Proposed Regional Plan for Northland) and MfE proposals for an NES (National Environmental Standard), updated consenting programme, identification of gaps in information (linked to the consenting strategy review work)

W&D will continue the following phase as part of the revised consent strategy:

- BPO stage 2 + sampling plant: Development of long-list options for stakeholder engagement with deliverable being a short list of options. Update to current sampling and monitoring plan to address gaps in the knowledge for consent renewal application (e.g. quantifying storm flows through WWTP) and ongoing operational needs.
- Water quality phase 2: Develop the Water Quality assessment including public health risk assessment, outputs to inform BPO workstream and AEE (Assessment of Environmental Effects).
- AEE Programme Management: a structure for the AEE is being developed based on specific contents and collected from BPO and Water quality phase 2.

Rural WWTP Major Operation & Maintenance

Ngunguru

- UV system and wetland drains were serviced.
- Operations team proposed to install an inlet screen to capture rubbish/rags in the influent.
- A Tee connection and an isolation valve were installed preparing for the inlet screen in the future.
- The concrete slab was prepared for the inlet screen pad and with a new flow meter.
- MABR (Membrane Aerated Biofilm Reactor) feed pump and electrical were hooked up by WDC electrical contractors.
- Pre-commission check list has been sent to our contractor, WDC is waiting for their feedback prior to installing the membrane in the demo unit.

Hikurangi

- WDC engaged a local consultant to work on the plant non-compliance issues.
- We are proposing a 24 month long targeted monitoring programme to assess the plants performance issues.
- The operations team have proposed installing a new inlet screen at the primary pond.



Oakura

- A quotation was received for upgrading the plants UV system.
- The operations team is checking the dimensions to confirm that the proposed unit will fit in the building.

Ruakaka

- Pond reconfiguration project was delayed as material was not ready due to Auckland in level 3 restriction;
- The water level in Pond 2 was dropped to facilitate the installation.
- Ponding was recorded in zone 3 disposal area. This was attributed to a high ground water table and high rainfall. The operations team continue to monitor the ponding. NRC has been updated and is aware of this issue.

Waipu

- Security fence installation progressing well. Most posts have been installed along the Southern boundary.
- · Floating wetland was harvested



Laboratory Report

For August 2020 722 samples were analysed for 2565 tests. 18% of the tests were subcontracted and 51% of results were reported within 5 working days. Overall this represents a 19% increase on testing performed when compared with August 2019.

Maintenance Contracts

We are still busy clearing slips and culverts due to the recent storm events in our network. As a result, there has been a very limited amount of programmed work being carried out. The focus has been on cleaning out blocked culverts and dealing with CRM complaints. Other works apart from routine maintenance and maintenance grading include maintenance metalling unsealed roads, roadside tree pruning, and culvert repairs.

We believe that the probable cause of the faults is moisture entering the electrical connections inside the bridge deck, causing the circuit breakers to trip. We are engaging an independent electrical engineer to review the installation, validate this probable cause and advise on corrective action.

Kerbside rubbish volumes continue to grow faster than kerbside recycling volumes. The Ministry for Environment has indicated a review of New Zealand Waste Strategy is underway and that the Waste Minimisation Act will be reviewed next year. WDC rubbish bags made from a high percentage of post-consumer recycled plastic have been ordered for trial later in the year.

Walking Tracks

The scale of damage following the July 17 storm has been unprecedented. Hardest hit have been the tracks on and around Parihaka and the Western Hills / Coronation Reserve. Engineers have assisted contractors in coming up with solutions where major slips and washouts have occurred. It is recognized that damaged ground remains very vulnerable to further erosion until vegetation regrows again.

The Hatea Walkway and Drummond Track should be open and usable again with care early in September but the Frank Holman Track may well remain closed well into October. The Whananaki Coastal Walkway has three contractors undertaking earth movement, this is a very tricky route due to its narrow form and the involvement therefore of adjacent land owners. Power lines are also affected and Northpower will need to be involved in the restabilization of poles.

A replacement bridge is being designed for AH Reed Alexander Track by expert bridge builders 'Bridge It'. Covid 19 restrictions in Auckland made it difficult for them to get through Auckland so their assessor flew to Whangarei to save time. A new bridge is also being proposed for the Tikipunga cycleway in the corner of the sports park and this was also being designed and costed. Due to consenting, a six month build period is expected, which will coincide with dry weather conditions and firm ground.

The 'shovel ready' redeployment team are making fantastic progress building the new cycleway around Tikipunga Sports Park. The team have formed a really positive unit, undertaking training and getting competency certificates along the way. It is likely that the first stage as far as the new bridge mentioned above, will come in under both time and budget so therefore stage 2 is now being investigated, between Vinegar Hill Road and the Sports Park. It is hoped that this further 1300m of track can be built by Christmas. In turn, this will link with a track being built by developers linking Totara Parkland.

Coastal Structures

34 inspections were completed in August, most of these were for seawalls.

The contractor has priced abutment repairs for Lovers Lane bridge. At present the ground is still too soft for loaded trucks to access the site, conditions will be reassessed next week.

Repair options to AH Reed bridge are being reviewed, aside from price there are health & safety elements to the methodology.

Whananaki North wharf will undergo rehabilitation assessment this week. The survey includes visual assessment, delamination survey, core samples, physical breakouts at steel locations to verify other findings, detailed report and recommendations. Two specialist assessors and representatives from the ratepayers association were onsite on 15th September.

The report may take up to 4 weeks to produce.

Sports Parks

Flood damage to the newly built Tikipunga No.10 field has been accepted by Recreational Service's insurance company. The contract was not concluded with 'As-Built' drawings and therefore remained our contractor's responsibility. Regrading of the sand carpet, reinstatement of sand slit drainage, broadcasting of kikuyu stolon's and rolling will be completed in September in time for warmer growing temperatures. Irrigation will be essential to get the grass growing again and make up the lost establishment time. An intercept drain has been reinstated to prevent future flood occurrence. Meanwhile, the lighting is now close to being commissioned.

A new fence is planned around the Athletics Track at Kensington after storm damage in July. The new fence will have a number of improvements, designed in conjunction with NAGS.

Level 2 COVID 19 restrictions has made the sports season very challenging for most winter codes. Some games have gone ahead but with very limited spectators. This has brought about criticism from some disappointed spectators but generally, the codes must be congratulated on achieving some play and the professionalism with which they have adapted to an ever-evolving playing environment.

Tree planting has been undertaken at both Otaika Sports Park and at Barge Park where over 1000 trees have gone into sites identified in management plans. Honda again sponsored the Otaika planting although the public planting was cancelled due to Level 2 COVID 19 restrictions.

Raised fencing behind the goal mouths at Koropupu has been completed together with a boundary fence to help prevent balls from reaching the stream. Ball retrieval is a H&S concern as well as an inconvenience. The car park at Koropupu has also been reinstated following flood damage where power cables had become exposed.

New bollards have been installed at Morningside adjacent to the road. The temporary waratah fence was unsafe, unsightly and ineffective at preventing encroachments. The installation of lighting towers has been completed at Hora Hora. A crane had to travel on pressure mats to prevent damage to the turf to complete this task. The lights now need to be set up and commissioned and ground restoration completed.

With the winter season due to end at the end of September (school Term 3) our contractors will be preparing the fields for summer games. Renovations should not be too serious thanks to light winter use.

Parks and Gardens

As Recreational Services cleaned up after the storm, the side effect of this was less maintenance was done than normal, around the district. This year has been hard on our maintenance contractors, who take pride in the quality of their work and the state of the district's parks and gardens. With COVID-19 lock down stopping work for a month and now this storm clean up pulling them away from their usual duties, the state of our parks has suffered this year. This should only be a temporary setback, and barring any further distractions, our parks and gardens should be looking good for the upcoming summer.

The lupins that were planted in the annual garden displays around the city have done really well, and while not colourful in a flowery way, have provided a great display. The last of this year's shrub and tree planting were completed in August.

Now the water restrictions have been lifted our contractor has under taken a lot of water blasting of hard surfaces. All the main concrete boat ramps, slippery board walks and mossy path were cleaned.

Playgrounds and Skate Parks

During August, issues on the playgrounds were very quiet. At the change to Level 2 COVID-19 restrictions, the contractor installed the Level 2 signage and QR code signs.

The Ngunguru skate park is open and has been well received by the community. The William Fraser skate park renewal is in full swing. Designs have been sort from Playground suppliers for this year's playground renewals; Taurikura, Marsden Bay and Hedley Place.




Rainfall and Water Sources

August was another wet month with 224mm of rain falling at Whau Valley compared to the average of 165mm. This was the fourth consecutive month with above average rainfall so the total rainfall for the year is now slightly above normal. The rainfall at Wilsons Dam has been normal for the year to date all at 865mm it is a lot less than the



1,181mm at Whau Valley. The Dams are now both full, with Wilsons Dam reaching 100% during August. This is the first time Wilsons has been full since September 2018 and the Whau Valley Dam is full for the first time since December 2018. Both are now above average for the time of year. River flows and aquifer levels have also risen and across the district water sources are back to normal. The long range weather forecast is now for average rainfall over the next few months and if this eventuates we should be in a good position heading into summer.

Other works

The algal bloom at Wilsons Dam continues although levels are lower now during winter. Trials of a new produce to reduce potentially harmful blooms looks promising. Additional dosing equipment and mixture have been ordered and it is proposed to widen the trial area during the up and coming algal growth season. It is anticipated the trial will be ready to continue in October.

The upgrade of the SCADA system is progressing well after delays due the drought and Covid-19. The first of the water treatment plants, Ahuroa, is now on the new system and is working well. The next plant to be done will be Poroti at the end of September. Until all sites are completed staff will need to work with two systems.

A total of 32 service connection leaks were repaired together with 187 main and rider main leaks. The number of leaks remained steady last month mainly due to the wet weather making it more difficult to spot leaks and the ground no longer moving in the dry conditions. The total number is similar to the same time last year. A total of 42 new water connections were installed during the month and 25 meters were replaced after being reported faulty by the meter reader.



Capital Works

Reticulation Programmed Works

The final bit of the Hospital Road water main should be completed by the end of September after some delays due to Covid-19 and the Hatea raw water main taking precedence. The Hatea raw water main is progressing well with the contractor installing the pipe by pipe bursting. This involves pulling the new pipe through the old pipeline even though the new pipe is bigger than the old one. This technique reduces the amount of excavation, reinstatement and backfill material thus reducing the carbon footprint of the project. It is expected to complete the work in September, although the distribution main in Whareora Road is also in need of replacement and this work may follow the raw water main. The next main proposed for replacement is Rewa Rewa Road ahead of the Roading Works in January.

A positive e-coli sample was obtained from the reticulation network in Bream Bay during routine sampling in August. The network was flushed, and samples were taken for three further days as per protocols. All follow up samples were clear. Investigations could not determine what the source of the e-coli was, and all treatment plant outflows were compliant. Provided no more positive results are obtained and enough future samples are taken the zone should still be compliant for the year.
