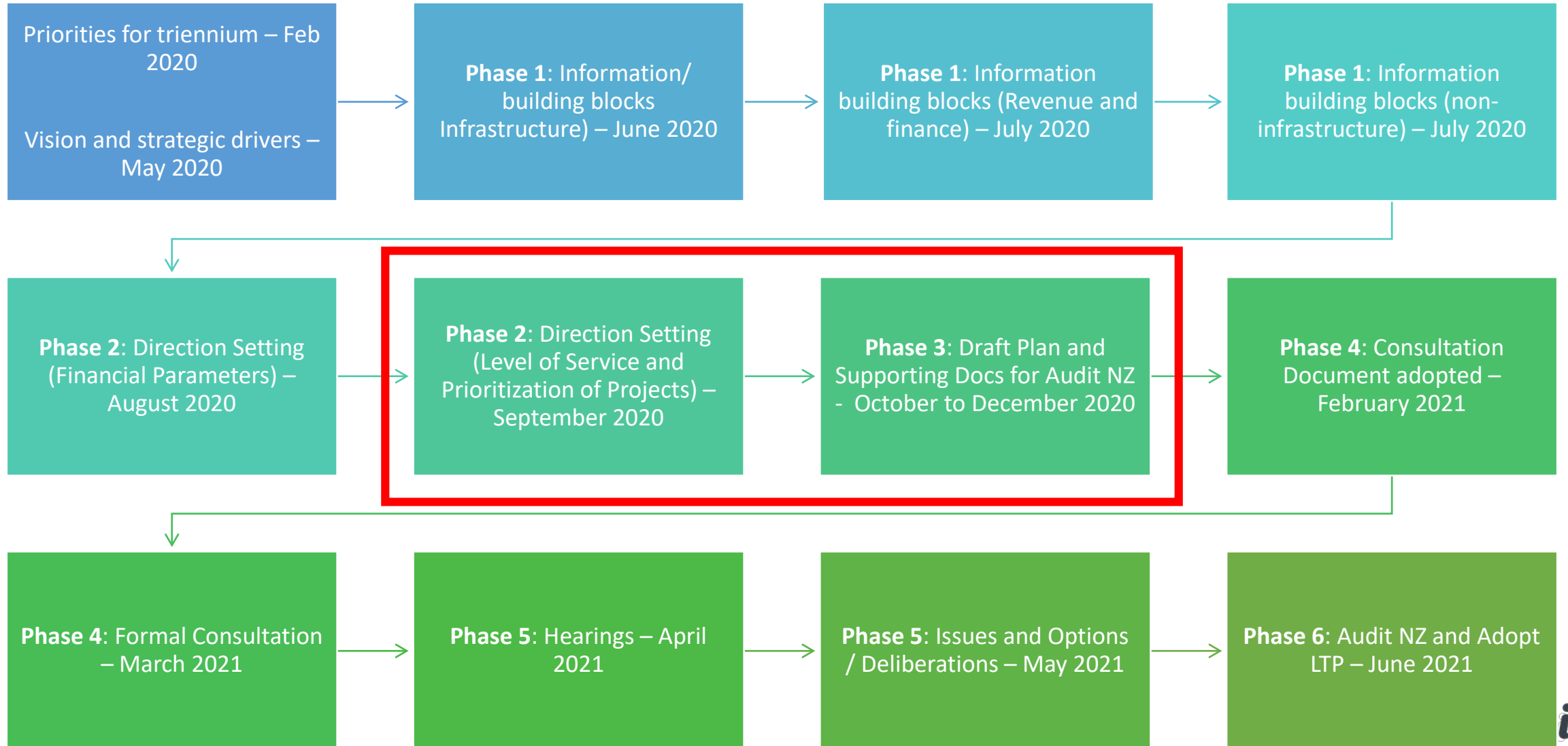

Timeline for the LTP



Critical path

In order to deliver a draft LTP by the end of the year, direction from Council is needed on the programme of the projects (capex and opex).

This direction will enable the following steps to be taken, which are essential for the draft Long Term Plan and the Consultation Document:

- Balanced budget benchmark result for each year
- Balanced budget will help determine the next course of action:
 - Opex cuts to get to a balanced position
 - How many of the 'priorities' can we factor into the budget and/or the appetite for
 - an unbalanced budget
 - further rates increases
- Debt levels
- Activity funding impact statements to determine appropriate levels of targeted rates (which also impacts balanced budget)

The list . . .

The LTP process has been built around your 'strategic drivers', feedback and direction. As such, the Opex and Capex lists cover new funding aligned to:

- The priorities Council developed through strategic sessions at the start of this triennium (adopted in February and reconfirmed in May)
- Councillors requests from the Briefings on 05th, 12th and 25th Aug
- Asset management funding **where this could be directly aligned to a commitment, priority, strategy or decision of Council**

Advice throughout this process has been that we have significant constraints in terms of both the balanced budget benchmark (opex) and our ability to deliver (to be discussed on the 29th). Difficult decisions/tradeoffs will need to be made



Not included at this stage

In addition, some requests relate to direction that Council will make separately to the prioritisation process, or through future LTP processes. These include:

1. **Parihaka Mast** where there is an existing BAU budget of \$900k and a workshop scheduled for 13 October to consider this matter.
2. **Regulatory services** where there is a workshop to work through costs, the potential for enhanced services and options to pay for any changes (i.e. fees/cost recovery) on 07 October.
3. **New Airport Evaluation** where there is \$5m for evaluation in BAU but no additional budget for land purchase provided for. While land purchase is unlikely to be required in the first three years of the next LTP, and there is significant uncertainty around what form this could take, it is anticipated that this would be required in the 2024 – 2034 LTP (if the project is to proceed beyond the evaluation stages).
4. **Commercial Property** where the potential for to include debt capacity for property purchases has been discussed. This was not a specific priority identified by Council but can be covered through consideration of the of the Financial Strategy and PRR

We also haven't included requests made by councillors outside of the process/chambers . . .

Approach to prioritization?

Prioritization will involve:

- Councillors making an individual assessment of your priorities in order to land on a collective view (if you don't genuinely rank your priorities we cannot get this)
- Staff will be 'roaming' for questions/clarification
- Councillors individually score each request via a simple scoring system:

0 = Out

1 = Low priority

2 = Medium priority

3 = High priority

- You are either in or out, if a request is not scored it will receive a 0

With prioritization complete, staff will then collect the lists from Councillors and add up the scores and report back with prioritized list of projects. This may require further refinement.
