Purpose

4.1 Maunu Cemetery Development - Concept Plan

Meeting: Infrastructure Committee

Date of meeting: 12 November 2020

1 Purpose

To formally adopt the Maunu Cemetery Development Concept Plan 2020.

2 Recommendation

That the Committee approves the Maunu Cemetery Development Concept Plan 2020.

3 Background

Maunu Cemetery has been operating for the District since 1886 and is situated 6.5km west of Whangarei in Cemetery Road off State Highway 14. It is set in over 31.5ha of rolling countryside, with bush clad valleys and pockets of remnant native trees.

Approximately one third is currently in use for burial plots, roadways, buildings and the crematorium. The balance is either native bush, leased for grazing or leased for community garden purposes (former Polytechnic site).

Since 2010 the crematorium has been leased to Maunu Crematorium Ltd. This lease is in its second term which expires 2023 with several more 5-year rights of renewal until 2038.

Most of the burial areas are well established with mature plantings and access roads and car park laybys for visitors and access lanes between burial areas for burial preparation and funeral directors.

Three years ago the burial area was extended to the area directly behind the current office. This area doesn't yet have the same character or amenity values as the more established parts of the cemetery.




Figure 1 - General land use

4 Discussion

In 2008 a draft development concept plan was developed and never finalised. There has been no long-term plan for developing new burial areas, internal roading network and landscaping. Some adhoc development was undertaken about 5 years ago with the development of the family burial area.

Over the last year a development concept plan has been finalised. This plan prioritises the various areas to be developed over the next 30 years to meet the growing needs of the Whangarei community.

Based on current demand of around 117 burials per annum an assessment has been made of the areas to be developed over the next 10 years. Much of this development such as new berms, plantings and gardens will be undertaken by the in-house staff using existing capital development funding.

The main capital investment required in the next 5 years will be a new internal road in the north- eastern corner of the Cemetery to service these new areas. In the next 10 years this road will need to be extended south to open up more new areas for burials.

Further details of this development are shown on the attached Maunu Cemetery Overall Concept plan.

4.1 Financial/budget considerations

The 2018-2028 LTP provided for \$190,000 capital development every 4 years for a project described as "Maunu Cemetery development for burials". This is insufficient for a larger roading project and it is proposed that in the next 2021-2031 LTP additional capital funding of \$400,000 be provided for in Yr 5 for the north-eastern accessway.

4.2 Policy and planning implications

From 2018-2043 (25 years) there is predicted to be 23,500 deaths in the district. Based on current trends about 20% would be burials needing around 4,700 plots. From this information we estimate Maunu cemetery has approximately 30 years capacity.

We also know there are changes in how we memorialise the dead such as demand for eco burials and increasing cremations. The percentage of burials could decrease, or increase based on these changing patterns and this will impact on the capacity of the cemetery.

The COVID-19 pandemic reminded us that we need to plan for future burials as they may not always average at the current 117/annum. The pandemic is an extreme event but it would be prudent to be prepared and have suitable infrastructure to provide several years of capacity. This would also allow the new areas to be planted in-advance to create the same character the balance of the cemetery has rather than looking like the paddock the farmer was recently grazing.

4.3 Risks

Because of unforeseen events such as pandemics or natural disasters there is a risk that burials will exceed the normal annual rate leading to burials in areas that do not have supporting infrastructure such as roading and accessways.

Summary of Contracts Approved Under Delegated Authority

This attachment provides a summary of the award process and works being undertaken for Infrastructure contracts awarded under Chief Executive and General Manager delegated authority.

1.0 Roading

CON17038

Contract Variation: Te Matau a Pohe and Kotuitui Whitinga Bridges - Electrical Maintenance 2017

Purpose

To extend the contract period for Te Matau a Pohe and Kotuitui Whitinga Bridges – Electrical Maintenance 2017 (Contract 17038) for 3 years and to increase the contract value to \$647,191.03 excluding GST.

Background

Contract 17038 for the Te Matatu a Pohe & Kotuitui Whitinga Bridges – Electrical Maintenance 2017 was awarded to McKay Electrical Ltd for a price of \$258,876.41 excluding GST on 5 December 2017.

This Contract involved the inspection and maintenance of all the electrical and control systems of these bridges. The contract was let with an initial term of 2 years and a potential roll over of another 3 years based on performance.

A performance appraisal has been undertaken using the Council's PACE evaluation template.

Based on this appraisal, the contractor's performance has been assessed as being adequate with a score of 70%. This equals the minimum score specified in the contract for a contract extension to be considered.

The appraisal was completed with a view to completing the contract rollover in time for December 2019. However significant delays were encountered in negotiations with the contractor, particularly to optimise coordination and timing of inspection and maintenance while providing a cost-neutral outcome.

The delay was compounded by the disruption from the COVID-19 outbreak, resulting in the schedule taking much longer to finalise than envisaged. The maintenance cost during the intervening period has been covered within the existing contract value (\$258,876.41) as only essential work was completed during that time.

Financial

The predicted final value of Contract 17038 will increase by \$388,314.62 excluding GST. This amount has been assessed based on current schedule rates with minor amendments to reflect agreed changes to the frequency or type of maintenance work being undertaken. This reflects lessons learnt in operating bridges over the past years.

The current approved contract value for Contract 17038 is \$258,876.41 excluding GST.

The contract is a measure and value contract and the actual payments to the contractor are based on the quantity of works completed at the tendered schedule rates.

The change in contract value is summarised in the table below:

This increase to the contract will be funded through councils approved Road Maintenance budget over the next three years.



Chief Executive Approval

That the contract for Te Matau a Pohe and Kotuitui Whitinga Bridges – Electrical Maintenance 2017 (Contract 17038) be extended for a further 36 months (3 years) to 31 November 2022 and the value increased by the sum of \$388,314.62 bringing the total contract value to \$647,191.03 (six hundred and forty-seven thousand, one hundred and ninety one dollars and three cents) excluding GST.

Purpose

Seek approval to increase the original contract price to \$455,000.00 excluding GST.

Background

This contract is for Nova Scotia Road Bridge No. 606 Upgrade of the bridge structure including the re-painting of the superstructure beams, replacement of the diaphragms, pile jacketing, replacement of timber bracing and linkage to ensure a continual level of service to users. It was awarded to Asset Construction Ltd. The original contract amount was \$439,849.00 excluding GST.

The increase of costs was due to COVID-19, claimed by the Contractor for the lockdown. The Covid claim has been evaluated and approved by the Engineer.

Financial

A breakdown of the additional costs is provided in the following table:

The winning tenderer was McKay Electrical Ltd.

Award Process

In June 2020, the Whangarei District Council's Chief Executive approved the award of Separable Portions 1 and 2 (Separable Portion 2 being subject to funding) and that Separable Portion 3 shall only proceed once The Far North District Council has approved this work through a separate agenda item to the Far North District Council.

On the 13th of August 2020, the Far North District Council carried the following recommendation;

 approve Council entering into a back to back contractual agreement with Whangarei District Council for the sum of \$1,123,299.12 (excluding GST) for delivery of FNDC Separable Portion 3 within the Whangarei District Council Contract 19017 for LED Streetlight Improvements – Northern Package (V Category).

Financial

Contract CON19017 is between the McKay Electrical and the Whangarei District Council (WDC), who are responsible for paying McKay Electrical as per the terms of the Contract. Payments shall be made to McKay Electrical on a monthly basis during the period of the works. The full amount of the payments made for Separable Portion 3 shall then be invoiced to the Far North District Council (FNDC) who shall reimburse WDC for the full amount the month following. This method of reimbursement shall be finalised through a back to back contractual agreement between WDC and FNDC.

Chief Executive Approval

Separable Portion 3 for LED Streetlight Improvements – Northern Package (V Category) CON19017 be awarded to McKay Electrical for the tendered sum of \$1,123,299.12 (one million, one hundred and twenty-three thousand, two hundred and ninety nine dollars and twelve cents) excluding GST.

Introduction

Cobham Oval carpark is a metalled car park that generally serves events held at either the Cobham Oval cricket grounds or the neighbouring Okara Park rugby grounds. Council has resolved to bring forward capital budget to seal this area and create a high amenity landscaped space with safe pedestrian thoroughfare, stormwater treatment and lighting.

The scope of the physical works will include traffic and pedestrian management, customer liaison, earthworks, modification to site accesses off Okara Drive and Port Rd, drainage and stormwater, landscaping and planting, installation of concrete paths including kerb & channel, asphalt sealing, electrical works (ducting, lighting, CCTV, EV charging) and installation of advertising signage.



Procurement Process

The procurement process was undertaken in two stages.

The procurement process was compliant with the Procurement Policy requirements and was undertaken in accordance with the approved procurement plan dated 02.07.2020.

Stage 1: Expression of Interest

An Expression of Interest (EOI) for the construction of the carpark was publicly advertised on Tenderlink in July 2020.

The EOI requested respondents to submit information to demonstrate compliance with the pre-condition criteria, and to provide answers to non-price attribute questions in the categories Relevant Experience and Track Record in accordance with the approved Procurement Plan.

The pre-condition criteria were pass/fail criteria, and a fail meant the supplier would not make the shortlist. The non-price attribute questions were scored and ranked highest to lowest by the evaluation team. The top four ranking submissions were shortlisted to go through to the RFP process.

Stage 2: Request for Proposal

The four shortlisted contractors were invited to submit a price via a private tender on Tenderlink. The evaluation process for this second procurement stage was lowest price conforming.

Tenders Received and Evaluated

When the tender closed on Friday 11 September 2020 three submissions were received:

Clements Contractors Ltd submitted the lowest price conforming tender. An arithmetic check was undertaken, and no omissions found.



Financial

The budget in the 2020/21 Long Term Plan for the sealing of the Cobham Oval car park is \$788,000.00. This project was bought forward by Council to ensure the car park would be upgraded in time for the 2021 Women's Rugby World Cup. In March the options and estimated \$1.4M cost was reported to Council. A follow up Information Report was received May 21st by Council in response to questions raised at the earlier meeting. The feedback from this meeting was that this project should continue but other projects would need to be delayed.

Budget from Town Basin Car Park to Park and Pohe Island destination playground has been re-forecasted to 21/22 financial year.

The Cobham Oval carpark budget difference of \$510,543.49 will be funded from unbudgeted expenditure.

Chief Executive Approval

The contract for New Cobham Oval Carpark (CON19063) be awarded to Clements Contractors Ltd for the tendered sum of \$1,298,546.49 (one million, two hundred and ninety eight thousand and five hundred and forty six dollars and forty nine cents) excluding GST.

3.0 Water

CON20048 Rewarewa Road Watermain Replacement 2020

Introduction

The 250mm diameter watermain in Rewarewa Road has burst several times over the past 24 months. An analysis of this main has determined that it has reached the end of its design life. Hence, according to analysis of the asset, it is due for replacement.

In addition, NTA are currently planning to rehabilitate Rewarewa Road in the early parts of 2021.

In order to reduce the economic impact of having a watermain burst under a newly rehabilitated road or excavating the newly rehabilitated road in order to replace the watermain, this watermain is to be replaced before the road rehabilitation takes place.

This Contract will comprise of the construction of 875m of DN250 (315 OD) PE watermain and 735m of DN100 (125OD) ridermain in Rewarewa road including connections and reinstatement.

Procurement Process

As per the procurement plan an open tender process was used. The contract was publicly advertised on Tenderlink on 03 September 2020 and closed on 25 September 2020 at 15h30.

Tenders Received and Evaluated

Four tenders were received as follows:

The evaluation method was lowest price conforming.



The United Civil Construction tender was found to be conforming. United Civil Construction have in the past delivered similar contracts and shown to have the required resources to undertake the work.

Financial

An adjustment has been made to the lowest tenderers price. This is to compensate for the tenderer substituting item 1.7 of the schedule of prices (traffic management), with a new similar item (item 6.3) having a shorter duration. It is possible that the contract will run to the full duration, hence the need for traffic management may be required for the full duration of the contract. This does not alter the tenderers competitive position or any of the rates provided.

After adjustment, the lowest tender is 12% lower than the Engineers estimate. This is believed to be realistic and market related.

An amount of \$1,200,000.00 was allocated to this project under the Three-waters reform grant funding secured via the signing of the Three-waters reform Memorandum of Understanding (MOU) by Whangarei District Council.

Chief Executive Approval

The contract for Rewarewa Road Watermain Replacement 2020 (CON20048) be awarded to United Civil Construction for the tendered sum of \$1,044,011.37 (One million, forty four thousand, eleven dollars and thirty seven cents.) excluding GST

2 Recommendation

3 Background





The number of applications received in September for Engineering assessment was 29 compared to 18 in the previous month. A total of 17 reports were issued and 7 placed on hold for further information. The 29 applications received for engineering input is higher than the 5 year monthly average of 24.

The 8-day level of service for engineering report delivery was 76% in September. The team has been working hard to improve the delivery times. Reliance on external consultants has picked up again as we experience an increase in workload, 86% of applications were processed by Council staff in September. The Development Engineers are undertaking an increased number of inspections, we expect the number of inspections to increase over the summer construction period. We are also attending a number of pre-application meetings.

We receive input from Geotechnical and Stormwater experts as part of the Engineering plan review process due to some sites being subject to high instability risk and flooding hazard areas. Internal staff don't have the expertise to assess these more complex sites.


The Development Engineers have been assisting other departments where there has been a shortfall in staff including the Waste and Drainage and NTA (WDC).



Development Contributions

\$411,000 was received in September. By November we expect to be well over budget. The budget was reduced due to the uncertainties of a Covid-19 economy.

30 applications were assessed as requiring contributions in September, these include staged consents. Work on the Policy review is ongoing, with the model ready to be populated with LTP projects for initial charge calculations.



Infrastructure Support

There were 53 contract claims processed for the month of September. This is slightly higher than last month and 10 claims less than September 2019. There were 516 purchase orders processed by the team for September which is considerably higher than last month due to the number of annual NRC consent fees. Business is as usual in other areas with 35 Public Utilities processed.

Work has begun with the Water and Waste departments to process Public Utility applications digitally. The team has had a reshuffle with staff leaving and others returning to work from extended leave.

Capitalisation of Assets

The financial year is under way with a current year spend of \$5,990,411.63 which includes \$2,380,306.74 of work carried out for the new Water Treatment Plant. LTP figures are still being finalized and the graph will be updated to show 2020-2021 LTP balances. August is showing a total WIP balance of \$36,093,518.19 across Water, Waste and Parks, which includes \$22,145,475.22 spend to date on the new Whau Valley Treatment Plant. Part of the remaining balance (3,491,337.62) is prior year projects waiting to be capitalised.

SIGMA Project

Progress has been made and certain parts of the project are coming together nicely. Key Business Users are making decisions as a group which gives more certainty around processes and data. We are working together as a team to ensure we get the best outcome for the project after go-live to produce a good working system once up and running. Agreement for team to have data mapping completed by end or October.

LTP Infrastructure workstream

Asset Managers continue work on the Activity Management Plans (AMPs) which will inform the first 10 years of the Infrastructure Strategy and Long Term Plan (LTP). Draft AMP projects have been sent to Finance and are part of the decision making for the next LTP. Project prioritisation methods are being worked through for Councillors decision making. Once final decisions from council are confirmed (mid to late October) asset managers will finalise plans. Asset Managers and Finance systems (EB and SPM) will be updated in the iterative process of arriving at a set of Capital projects that will make it into the Draft LTP. The Infrastructure Strategy work is on-going with work taking into account climate change strategies and Audit NZs signalling of expectations in this area.



Health and Safety

Health and Safety Risk Update August 2020


- Traffic Risk Several departments logged department hazards on request on the risk of working in the road corridor. This makes the risk more visible and in a management system that receives regular review. Having staff trained and with current traffic management plans is an area that we have to remain vigilant about.
- Training: Several staff undertook confined space entry and work at height compliance training.
- Procedures: An entry into Dangerous buildings and hazardous sites protocol was developed, as some
 Infrastructure team members must visit these sites. An enquiry is being made into government run training and if
 this could be made available to Council staff in Northland.
- Reported incidents: There was only one near miss incident reported by staff this month, regarding use of a boat on Wilsons Dam.
- Contractors reported six medical treatment incidents;
 - Four involving Northland Waste runners; dust in eye, hit knee on door injury, hit in face by bouncing bottle
 and one involving a thumb being bent backwards
 - o One involving a Recreational services staff member who cut their finger with a pruning saw
 - o One involving a Downer worker who rolled his ankle on a kerb

Waste and Drainage

Operations and Maintenance

Whangarei WWTP

For the first six days of September, the inflow dropped consistently from its peak – around 17,000 m³ – to around 14,300 m³. Rainfall of 7.2 mm on 7th boosted the flow back up to around 15,500 m³, thereafter it steadily reduced. On 26th the flow reached its low point for the month, which was just above 11,000 m³. A three-day rain event starting on the 27th with a recorded total rainfall of 16 mm elevated the flow to just above 12,000 m³. In general, September witnessed a gradually declining flow trend to the plant.

Activities carried out at the main plant during September included:

- The generator was serviced at Okara pump station
- The Kioreroa Rd rising main replacement was completed.
- New water tank to supply water for dewatering units was installed including: water level indicator, ballcock valve.
- 2 new actuators were ordered for the grit vortex chamber at the inlet work.
- Secondary clarifier No 1 had the wash water pump motor bearings fail. Replacement was ordered.
- Primary clarifier no 3 was pumped out so investigation could be carried out. No issued identified. While No 2 received new reconditioned drive gearbox and new motor.

Whangarei WWTP Resource Consent Renewal project

W&D team met with the consultant at the main plant to review the current monitoring plan and completed the gap analysis.



The consultant also prepared a long list of practicable options for the main plant. This includes consideration of future flows and loadings due to population increase (growth in the city). The operations team is working with the Planning team to engage with both community and key technical stakeholders for the consenting strategy.

Rural WWTP Major Operation & Maintenance

Ngunguru

- UV system was serviced.
- Weeds were cut between pond 1 &2. Vegetation was burnt off.
- MABR (Membrane Aerated Biofilm Reactor) demo system was commissioned and became operational on
 25 September after three sheets of membranes were installed by the Operation teams.
- The demo unit is running to treat 7.2 m3/d with air supply of 0.78 Nm3/hr and air mixing of 1.92 Nm3/hr with 10 seconds on and 110 seconds off sequences.
- After stabilizing the demo for approximately 2 weeks, testing will be carried out for process optimization.

Hikurangi

- Aerator No 1 was pulled to side of the pond so our electrical team could investigate an operational problem.
 The problem was identified due to overload. After a service, it was working fine.
- Operations team met NRC monitoring officials to discuss an ongoing monitoring plan to determine how best to achieve full compliance.
- Waste and drainage have sought approval from NRC to extend the monitoring so that the preferred treatment
 option can be identified and implemented. The operations team will install instruments to monitor the plant
 performance at various locations inlet pond, aeration basin pond and wetland.

Oakura

- The lamp indicator for UV system was replaced.
- Sludge pump faulted and was serviced.
- The Pre-UV tank leakage was fixed.

Ruakaka

- The pond reconfiguration project has been completed. The new line was CCTV surveyed and footage has been reviewed.
- The water level in Pond 2 needs to be raised to accommodate the operation of the new surface aerator.
- Ruakaka inlet screen was overloaded. Our electrical contractor is investigating.
- The Zone 3 ponding caused by excessive rainfall and high-water table is now resolved.

Waipu

- Erection of the new security fence was completed.
- The Rapid infiltration basin (RIB) was serviced to improve disposal of treated effluent from our plant.

Tutukaka

- The plant PLC was fully re-booted.
- Longer bolts and wing nuts were installed at the inlet screen inspection hatch.
- Replacement lamp for UV was ordered.
- The annual inspection of all reticulation sand filter pumps was completed. No issues found.
- · Spray completed near bore area.

Portland

Security fencing work to be resumed as ground condition became drier.

Reticulation

There was one recorded spill incident in September 2020.



Laboratory Report

For September 2020 755 samples were analysed for 3447 tests. 29% of the tests were subcontracted and 40% of results were reported within 5 working days. Overall this represents a 22% increase on testing performed when compared with the same period for last year.

Roading - Transportation

Maintenance Contracts

It has been a busy month in September and our crews have been working through our routine work of CRM's and sealed potholes, trip hazards, grates, unsealed potholes, road sweeping, walkways etc

The crews are also still working through all the storm damage from July, they are steadily making progress at completing the work.

Programmed works completed this month were as follows:

- Rehabs and seal extensions have begun on Franklin Road, Ody Road, Pipiwai Road, Pataua North Road, McCardle Road.
- Mill Road –Section 1A (RP 40 to RP 420; Bank Street to Parahaki) Phase 1, left hand side SAC PMB 100mm layer completed. The appurtenant work progressed well, with the removal of the islands at the intersections, Kerb & channel replacement and new subsoil drains. Our stakeholder management have received commended notes from the local residents, who appreciates the correspondence and personal visits to discuss the details of the work. Night work have been reduced by 35% over the construction of section1.
- Westwood Lane pavement and surfacing construction works to resume at the end of October 2020.
- Limeburners Road enabling work starting this month.
- We have had digger crews that have been clearing slips and damage caused by the July storms.
- Line marking in Waipu is 99% completed, One tree Point completed, Ruakaka completed.
- Tangihua Rd Install Bridal Track 720m long.
- Tauraroa Rd Installed swale drain, cut out low shoulder, cleared footpath, filled in pot holes.
- Marsden Point Rd Installed threshold sign.
- Cove Rd Installed threshold sign.
- Konini St Installed concrete swale drain, installed 2 x vehicle crossings.
- Campbell/Hedley Place re-install fence along walkway.
- Flyger Rd/Mititai Rd Re-build shoulder.



- Takahiwai Rd Remove approx. 10m3 of metal from estuary.
- Western Heights Drive repair broken fence.
- Tarewa Rd Lay AC footpath.

High Risk Rural Roads:

- The NTA has developed 14 Standard Safety Intervention applications for key High Risk Rural Roads and
 intersections across Northland. SSI application are simplified Single Stage Business Case (SSBC), tailored for
 Road Safety interventions. The first draft (submitted to NZTA for feedback) was 10 routes across Northland. Work
 has started on the remaining eligible routes. Whangarei routes in the first 14 this will inform future Road Safety
 programmes;
 - Vinegar Hill Rd completed 2019-20, awaiting post-construction Safety Audit, which may recommend further improvements; short term and long term.
 - Whangarei Heads Rd Whangarei Heads Road Standard Safety Interventions (SSI), installation of EMP's completed, curve advisor signage design to occur in 20/21 and other major implement 2021-24.
 - Ngunguru Rd major safety improvements including Murphy's Bend; short term complete, design for medium and long term.

High Risk Intersections (Safety):

 Kamo Rd / Kensington Ave Intersection – implementing camera identification of right-turning vehicles to improve safety (2019-20). Installation of camera is complete and monitoring continues to determine if it has been a success – reduction in number of Kamo Road southbound vs right turn into Nixon St filter phase accidents.

Speed Management:

- Tranche 1 Council has adopted the recommendations report for each of the following areas;
 - I. Te Toiroa Rd (Legal Unformed Road) Ngunguru, which forms part of the Old Ngunguru Coach Trail.
 - II. Vinegar Hill area
 - III. One Tree Point / Marsden / Ruakaka area
 - IV. Waipu Village
- Tranche 2
 - I. 2A Bream Bay (Cove Rd) concurrent with Kaipara's Managawhai area. Consultation planned for Summer 2021-22, with the Hearing and Decisions early-mid 2021, and implementation mid-late 2021.
 - 2B Whangarei Heads. Planning started for consultation for early-mid 2021, implementation (2021-22).
- Tranche 3 (2021-22) Tutukaka Coast (Ngunguru Rd & Russell Rd) and Bay of Islands (Opua / Russell). These
 two areas will be reviewed concurrently with Far North's Russell catchment area to ensure a seamless and coherent
 approach to both consultation and delivery of speed management.

Walking and Cycling (Urban):

- Kamo Shared Path
 - I. Stages 1-4 were formally opened on 25 November 2019.
 - II. Funding for Stage 5 has been approved and the detailed design is underway. Stage 5 includes the final link to Kamo Village. Construction planned for next LTP (2021-24).
- City Centre including Onerahi link and improvements to Hatea Loop Is now part of the City Core workstream.
- 10yr Implementation Plan to bring together the City Core Plan works, our Walking & Cycling Strategy and Blue Green Network Strategies. We have engaged Viastrada to develop a 10-year plan, which will complement these high-level strategies, with more detail and prioritisation of sections. This will take 6-12 months and will inform our next LTP.
- Tikipunga Cycle Trail Stage 1 Council received \$400k from government (Redeployment Fund) as part of the post-COVID stimulus package. This funding is being used to development a gravel trail between Vinegar Hill Rd and Ngunguru Rd, effectively extending the Hatea River Walkway to connect with Totara Parklands river path. Stage 1.
- Council received \$6m from the Crown Infrastructure Projects (CIP) contract (MBIE) to be signed. Works;
 - I. \$0.5m Kamo Shared Path Link to Kensington Park Stadium. Design & Implement 2020-21.
 - II. \$0.5m Tikipunga Cycle Trail (Stage 2) continue path from Ngunguru Rd (Whangarei Falls) to Vinegar Hill Rd, connecting with Totara Parklands River Trail. Includes a 12m bridge. Implement 2020-21.
 - III. \$5m Raumanga Shared Path design (2020-21) and implement over the next 2 years.



Waipu Walk & Cycle Trust

- Stage 2a Cullen Rd to Waipu Cove Physical works is complete, except for the culvert extension works (Council project) planned for 2021-22 and final trail surface See High Risk Rural Roads.
- Stage 2b McLean Rd to Cullen Rd works has started, waiting for the ground to dry further before continuing.
- Stage 3 Riverview Place to Cullen Rd planned for future years as a joint Trust and Council project.
- <u>Future</u>; Waipu to One Tree Point NZTA (Waka Kotahi) are considering funding the complete design of Waipu Village to One Tree Point.

NZTA Northland Integrated Cycle Network (tourism)

Updates on Region;

- Waka Kotahi are considering funding the detailed design for Waipu Village to One Tree Point
- Waka Kotahi are encorporating a cycle trail from Whangarei City to Ruakaka in the NZUP four lanning of SH1 between Whangarei and Ruakaka.

Whangarei Heads Trail

Whangarei Heads Rate Payers Association, with a grant from Council are developing a proposal to build a trail
connecting McLeod Bay and Parau Bay Village. Scheme design is complete, consultation/engagement has started.

Te Matau a Pohe Road Light Replacement

• McRae Global have successfully installed the new luminaires in January. It has been identified from investigations completed so far that the root cause of the problems re. some of the lights not working is not the light fittings. We believe that the probable cause of the faults is moisture entering the electrical connections inside the bridge deck, causing the circuit breakers to trip. We are engaging an independent electrical engineer to review the installation, validate this probable cause and advise on corrective action.

LED Street Light Conversion

- The installation of the V-Category (arterial road) retrofit lights (ie swapping the old light for new LED) being
 undertaken by Currie Electrical is 95% complete. The remaining lights are located in the CBD mall area and require
 modification to the existing outreaches. These modified outreaches have been manufactured and are now being
 installed.
- The Southern V-Category infill streetlight contract (ie those requiring new poles) was awarded to Currie Electrical on 16 March 2020 and is well underway with most of the central city area completed. This portion of the work is due to be completed in December 2020. This contract also includes new streetlights in the southern half of the Whangarei District and all of the new lights in the Kaipara District. This portion of the work will be undertaken in the 2021/24 LTP.
- The Northern V-Category infill streetlight contract has been awarded to Mckay Electrical. This contract includes
 new streetlights in the northern half of the Whangarei District and all of the new lights in the Far North District. This
 work is expected to start in November and has an extended completion timeframe of June 2022 due to budget
 constraints.
- We are currently investigating both Auckland Transport's central management system (CMS) and other "Smart Cities"-type CMS to control the new LED streetlights. Again due to budget constraints, a trial may be done in 2020/21 to confirm whether a CMS system should be rolled out over the network in the 2021/24 period.


Operations

Walking Tracks

Our contractors have been flat out undertaking repairs to walking tracks following the 17 July storm. It has been dry this month aiding repair work. The Parihaka walking tracks are now repaired and open again. The Ross Track required repairs and reinforcing under three bridges, a diversion around a big slip and foundation repairs to the staircase. A major slip has been built over on the Drummond Track. The new routes through Mackesy Bush held up well generally but here too, surface repairs were widespread. The Hatea Walkway has also been re-opened following extensive damage north of Mair Park and three contractors have been working to re-open the Whananaki Coastal Walkway where numerous slips occurred.

The Hatea Walkway between AH Reed and Whangarei Falls is open but requires a lot of repair as do the Coronation Reserve tracks. It is hoped to complete these in October.



The new cycle path around Tikipunga Sports Park is now complete and the 'team' have moved on to start further upstream, focusing on land adjacent to Kamo Pony Club. Fences will need to be repositioned to allow for the additional width required by a cycleway, so this will be quite an undertaking. In addition, a former ox-bow will need to be bridged which will require considerable thought and designing.

Tree Maintenance

Treescape® had one and half crews running on the WDC tree contract this month. A good month on proactive work with very minimal reactive work completed. Now that the reserves are getting drier more reactive work that was unable to be completed during the wetter months will be added into the work program.

A total of 12 streets and 2 Parks were completed in September as part of the regular pruning cycle pruning cycle. Due to the drier weather towards the end of September we have already started Parks and Reserve work.18 CRM's for the month of August completed.

Coastal Structures

The contractor is now up to date having completed 54 inspections across the district. As a new initiative they are providing a report of identified minor issues to aid in decision making.

Lovers Lane bridge abutments were repaired as per specifications, due to the alignment of the Raumanga shared path not yet finalised no further action is required as the future of the existing bridge is uncertain.

Consent for the filling of the sea-caves at One Tree Point has been approved. Pricing and methodology previously supplied will be re-reviewed.

Sports Parks

September brings the end of the winter season and the start of field renovations ready for the summer sports. Cold dry weather has meant that grass growth has been slow but good for preparing cricket blocks. Cobham Oval is slowly growing back following extensive gravel band drainage and scarifying. Pakistan are due to play here in December for two games.

Line marking is also required for touch rugby and softball, both of which are very popular currently.

Hora Hora will get renovated during October and there will be a lot of weed spraying to complete too. The lights here are now nearly complete with some minor additional poles requires around the scout hut and car parks.

The field at Tikipunga that suffered from storm damage has been levelled and re-sown with kikuyu stolons. Dry weather will mean that irrigation will be necessary, as it is essential that the grass gets established quickly if the field is to be available for next season.

The boundary fence around the athletics track at Kensington Park is being renewed and should be complete by late October.

Parks and Gardens

September received 37mm of rainfall with 7mm and 14mm the only good amounts of rainfall received. This is a dry month for September compared to recent years.

The contractor has been very busy trying to keep on top of the spring growth, with the weed growth very fast at present. The annual beds are being prepared for planting (starts after Labour weekend), some of the lupins beds have been removed and others have been deadheaded (to stop the lupins going to seed and cause future weed issues). We have been mulching down the removed lupins to create a compost to add back into the beds at a later date. The contractor has also completed a riparian planting at Barge Park, using left over plants from the Parihaka Fire planting, and planting and mulching a garden beds at Otaika Shops, the Railway Station and Vine Street carpark. They have also continued to do a big push on mulching at various areas around the city and particularly on the South end of town. With another seemingly dry month, they will continue this practice over the coming months.

Grass growth during September was reasonably slow and the contractor has been keeping up and making sure that all grounds are to spec so when the spring growth does finally hit that they are on top of their sites. Since September was dry, the sites traditionally wet over winter were able to dry out and the contractor has been able to mow these sites and they are back up to spec now. Tarewa Park (where new Road layout and bridge construction) has been mown ready for the opening in early October.



Playgrounds and Skate Parks

During September, issues on the playgrounds were very quiet. The Town Basin renewal is going well and on track to be opened by the end of the calendar year.

The Ngunguru skate park is open and has been well received by the community. The Wiliam Fraser skate park renewal is in full swing. And designs have been received from Playground suppliers for this year's playground renewals. The playgrounds are Taurikura, Marsden Bay and Hedley Place. Consultation with schools will take part in October.

Cemetery

A busy month with 11 burials and 20 ash burials taking place. We had another natural burial bringing the total to 5 burials since opening of the area in July 2018. We have now had 8 burials in our family plots with 36 reserved plots for future use.

A meeting was held at the McLeod's Bay cemetery (Whangarei Heads Pioneer Cemetery), with a group of locals interested in maintaining the cemetery. It was decided that a couple of dead trees need to be removed before they fall onto the headstones and a survey done to work out the exact boundaries. This cemetery has a lot of links to the area, with names like Wellington and Urquhart's to name a couple.

The annual meeting with the friends of Maunu cemetery group was held and the old portion of the cemetery has a new lease of life where they started planting last year.

Botanica




Water Services

Operations

Rainfall and Water Sources

After four wet months in a row September was significantly drier than normal. Only 43mm of rain fell at Whau Valley during the month compared with the September average of 143mm. The total rainfall at for both Wilsons Dam and Whau Valley Dam is now slightly less than normal for the time of year. The Whau Valley Dam remains full and Wilsons Dam is now beginning to drop and sits at 99%. It is expected if the current dry weather continues that the dams will start to drop quicker, particularly as demand will increase heading into summer. However, the long-range forecast is for normal rainfall over the next 3 months and if this eventuates all water sources should maintain reasonable levels heading into the new year.







Production Report

Compliance

Other works

The algal bloom at Wilsons Dam continues although levels remain low as water temperatures have not risen much and rainfall remains low. Additional dosing equipment and mixture have been ordered and it is proposed to widen the trial area during the up and coming algal growth season. The equipment should be in an operating by the end of October.


The upgrade of the SCADA system is progressing well after delays due the drought and Covid-19. The first of the water treatment plants, Ahuroa, is now on the new system and is working well. The next plant to be done will be Poroti which will be shut down and switched over in mid-October. Until all sites are completed staff will need to work with two systems.

Distribution Report

Water Statistics 43 Connection leaks repaired 17 Rider/Main leaks repaired 27 New connections installed 45 Faulty meters replaced

A total of 43 service connection leaks were repaired together with 17 main and rider main leaks. The number of leaks rose slightly last month mainly due to the dry weather making it easier to spot leaks. It is anticipated the number of leaks will increase if the dry weather continues and the ground begins to dry out and move. A total of 27 new water connections were installed during the month and 45 meters were replaced after being reported faulty by the meter readers.

Capital Works

Reticulation Programmed Works

The final section of the Hospital Road water main has been completed after some delays due to Covid-19 and is now operational. The Hatea raw water main is also nearly complete and should be available to be used by the end of October. This will allow us to double the amount of water taken from the Hatea river and is a key element in improving our drought resilience.

Poroti Upgrade

The work to install a pipeline between the Maungatapere Water Company's Wairua Pipeline and the Poroti Water Treatment Plant was completed in June. Work is now due to begin on the concept design for an upgraded water treatment plant using money from the Governments 3 water fund. This is an important project to improve the long-term resilience of the City's water supply.



3 Waters Funding Projects

Planning is well underway on projects to be funded through the Governments 3 waters programme. The Capital projects are, Whau Valley Water Treatment Plant stage 2, Poroti Water Treatment Plant Upgrade – Design, Whareora Road watermain replacement, Rewa Rewa Road water main replacement, Kamo Road water main replacement and the installation of filling points.


