4.1 Hearing – proposed amendments to the Camping in Public Places Bylaw

Meeting: Whangarei District Council

Date of meeting: 8 December 2020

Reporting officer: Vita Strohush (Strategic Planner – Bylaws)

1 Purpose

To provide Elected Members with the submissions received on the proposed Camping in Public Places Bylaw and to hear submitters who wish to speak to their submissions.

2 Recommendations

That the Council:

- a) Receives the written submissions on the Camping in Public Places Bylaw as provided in Attachment 1 and Attachment 2:
- b) Hears submitters who wish to be heard on the Camping Public Paces Bylaw.

3 Background

On 22 October 2020 Council adopted a Statement of Proposal for the amendment of the Camping in Public Places Bylaw 2017 and an associated amendment to the Public Places Bylaw 2014. Public consultation opened on 28 October and closed on 27 November 2020.

4 Discussion

Council undertook public consultation on a proposed amended Camping in Public Places Bylaw in accordance with the requirements of the Local Government Act 2002 (LGA). As part of the consultation process Council is required to provide an opportunity for persons to present their views.

At close of the consultation period Council received 207 submissions and one petition with 13 signatures. Copies of submissions received are provided in Attachments 1 and 2. Attachments were divided into two volumes – Volume 1 includes submitters with last names from A to L and Volume 2 goes from M to Y. Councillors will receive copies of any late submissions once they have been processed.

At the time of writing 30 registrations have been received for the Hearing as summarised below:
