Submission Letter On The Proposed New Freedom Camping Bylaw

Your Worship, Mayor Sheryl Mai and Councillors

Whangarei District Council have now proposed it's third, in a row, illegal Freedom Camping Bylaw. How do you feel about that?

This is not fair on the rate-payers who have had to fund all 3 of them. It is not fair on local Vehicle Dwellers who desperately need a legal bylaw to manage the issues associated with our growing group. And it's certainly not fair on Armourguard's Freedom Camping Compliance officers who are required to enforce it, or those involved in the fantastic Ambassador programme who are expected to help manage it.

We, your Whangarei Vehicle Dwelling Community, ask that this new proposal is revoked, at once. No-one should be managed under illegal laws. Ever!

Being 'self-contained' means simply 'having everything you need'. It's about owning responsibility. But the certification process has been used for political gain through a nationwide takeover of public lands by a private camping organisation.

Four years ago, I personally scuppered the new proposed Freedom Camping bylaw on the grounds that it was illegal because it allowed the Certified Self Containment (CSC) Standard.

Whangarei District Council conceded it 'got it wrong' and publicly stated it was a 'legal shambles'. They removed the Certified Self Contained 'Only' Restriction throughout the district and proposed rights for those in tents and non-self contained vehicles as well.

However, they still included the CSC standard as a restriction in their newly ratified Camping in Public Places Bylaw and those campers who were able to attain the standard, were allowed far

more privilege to freedom camp in the District than those without.

So, I created The Whangarei Vehicle Dwellers facebook group and together we refused to be managed under another illegal bylaw. WDC conceded it got it wrong again and without even attempting to challenge us, simply allowed their permanent vehicle dwelling community to basically 'live' full time at Cobham Oval.

Instead, WDC concentrated it's 'Camping in Public Places Bylaw's efforts in ensuring compliance to the more seasonal and fluid stream of domestic and international tourists.

The 'legal shambles' has come about, because this Council took too much advice from a private camping organisation, the New Zealand Motor Caravan Association. Who have taken a self-appointed leading role with council's all around the country, shaping, advising, establishing and promoting an illegal component to Freedom Camping bylaws. Certified Self Contained Freedom Camping Only.

Since 2011, Councils around the country in their panic to come up with solutions, have been coerced into bad decision making by this private organisation. We have allowed them, as expert advisers, to help create a new law, just for themselves. And that is the reason behind the legal shambles. That, is where it has all gone pear-shaped. That, is the very reason why WDC cannot enforce the bylaw against it's own growing group of vehicle dwellers. The bylaw has no teeth. It is useless!

Instead WDC recently admitted that Permanent Vehicle Dwellers fit "outside the scope of the bylaw". It's a big thing to admit! Because if we fit outside the scope of the bylaw, then so does every other legal person in NZ. In fact, it's an admittance that the bylaw itself fit's outside the scope of law.

So here we sit, four years later. A new proposed amended version of the same Camping in Public Places Bylaw, which still includes the CSC restriction. Amended to give even more rights and privilege than ever to those vehicles with CSC while proposing to remove even more rights to those without.

That a private Camping organisation was allowed to create law in this country beggars belief. They created for councils, their very own 'Model' Freedom Camping bylaw to assist with local Council decision making. It, of course, proposed Certified Self Contained freedom camping only. This document was prepared by the NZMCA and public law experts, Chen Palmer, and in consultation with Local Government New Zealand, Department of Conservation and Department of Internal Affairs.

And in it....they slip in the term Self Containment

They state that, 'If local authorities restrict freedom camping at a particular site to self-contained camping only, the following definition of self-contained vehicle may be useful:'

'Self-contained vehicle means a vehicle designed and built for the purpose of camping which has the capability of meeting the ablutionary and sanitary needs of occupants of that vehicle for a minimum of three days without requiring any external services or discharging any waste and complies with New Zealand Standard 5465:2001 as evidenced by the display of a current self-containment warrant issued under New Zealand Standard Self Containment of Motor Caravans and Caravans.'

It was such a delight for me, to find this little add-on...

...NZS 5465:2001. Note that self-contained vehicle is not defined in the Freedom Camping Act and that this is only an example as to how it may be defined."

'May be defined'?

It must be frustrating for those at the NZMCA, who now realise that NO. You cannot re-define the description in an ACT. You cannot just alter it and change the very philosophy and meaning of what it means too freedom camp.

Here's why;

THIS is THE legal description of what it means to freedom camp. According to the Freedom Camping Act 2011 it means to camp in 1 or more of the following:

a. A tent or other temporary structure

b. A caravan.

c. A car, campervan, housetruck, or other motor vehicle.

No-where, not even once, does the FCA ever mention Certified Self Containment. To have this important 'fix-it-all' term left-out entirely from this document, says a great deal.

You see, if we alter and re-label what it means too freedom camp, especially when it enables one group more privilege than others. If we take this right off the poor and give it to the rich, or if you like, we take it off youth on a shoe-string budget and allow it as only a rite of passage for those who can afford a CSC vehicle, it breaches another Act, our rights.

The Human Rights Act 1993 describes

Victimisation

(1) It shall be unlawful for any person to treat or to threaten to treat any other person less favourably than he or she would treat other persons in the same or substantially similar circumstances.

Non-discrimination and minority rights.

Freedom from Discrimination

(1) Everyone has the right to freedom from discrimination on the grounds of discrimination in the Human Rights Act 1993.

(2) Measures taken in good faith for the purpose of assisting or advancing persons or groups of persons disadvantaged because of discrimination that is unlawful by virtue of Part 2 of the Human Rights Act 1993.

To determine whether a bylaw made under this Freedom camping Act is appropriate

(1) A local authority must, before commencing the process for making a bylaw, determine whether a bylaw is the most appropriate way of addressing the 'perceived problem.'

(2) If a local authority has determined that a bylaw is the most appropriate way of addressing the perceived problem, it must, before making the bylaw, determine whether the proposed bylaw;

(a) is the most appropriate form of bylaw; and

(b) gives rise to any implications under the New Zealand Bill of Rights Act 1990.

(3) No bylaw may be made which is inconsistent with the New Zealand Bill of Rights Act 1990.

Making freedom camping elitist and offering more privilege tor self contained luxury motorhomes IS inconsistent and goes against the very intention and purpose of what this Act is about. These new bylaws are NOT appropriate in that we should take toilets away from Freedom campers with no toilets on board and allow these public facilities to only be used at night by vehicles that are already equipped with toilets.

It is NOT proportionate in that it favours one group over another. The have's and the have-not's.

It is NOT consistent with the Bill of Rights because it discriminates against the poor and youth in particular. Those young tourists freedom camping in vans, station wagons and tents who are unaware and ignorant of the trap set for them all around the country. Where they face penalties of up to \$200 fines.

Offering 'NON CSC' vehicles and tenters one night only and giving those with CSC more privileges is not the best way to address the perceived problem. It restricts their right to 'Freedom of Movement'. It victimizes all youth and tourists who choose to see this country on a shoe-string budget.

Lets look at what the intention of what an ACT is in this country.

An Act in New Zealand is designed to;

(a) affirm, protect, and promote human rights and fundamental freedoms in New Zealand; and

(b) to affirm New Zealand's commitment to the International Covenant on Civil and Political Rights

In the New Zealand sixth periodic report under the International Covenant on Civil and Political Rights it discusses Inequality.

'New Zealand aims to ensure an adequate standard of living and provide opportunities for all to participate fully in society, regardless of ethnicity age or gender'.

For the last 4 years the Certified Self Containment Standards legality has been questioned by many individuals and groups. I personally have challenged (on behalf of other freedom campers around the country) over 200 infringement notices written against the illegal CSC standard with a 100% success rate. It seems no Council is prepared to challenge me on CSC being an illegal restriction.

CSC is a 'non-cited Government Standard', so is only voluntary and cannot be written into law as a legal restriction. A 'cited' standard on the other hand, is mandatory and is the only type of Government standard on which laws can be made However, this has not stopped Councils using it as a restriction to freedom camping.

The eco-hypocrisy of CSC is incredible. I know many people with a CSC sticker who never use their own toilet. I have also met literally hundreds of people who have the sticker, but no toilet. Some CSC vehicles have dogs on board....which we must presume poop outside.....wouldn't they? It has been proven time and time again, that a CSC sticker does not a responsible person make. It just tries to say that the vehicle is responsible. And a vehicle should never be held responsible.

When CSC goes wrong and spills, it can be major, as you could well imagine. A traffic accident, or if the underneath plumbing is either hit or has rattled itself undone, the spillage becomes an environmental hazard. I have assisted with 3 of these types of repairs, just in the last year alone.

The CSC standard's certification is only available for a small minority of campers. Over the last few years the NZMCA have made amendments to the standard so that even less amount of

these smaller vehicles are able to meet the criteria.

According to the Freedom Camping Act, camping includes hunting areas, where hunters take motor vehicles to an area where they set up camp for a week-end. As well, There are river-rafter's, fishermen, trampers, Te Arohas Trail walkers, cyclists etc

One could be forgiven for thinking freedom camping, as determined by local Councils and Government, is all about motor-homes & caravans but that is an incorrect perception. Actually motor-homes and caravans make up only a minority of campers as defined by the Act. In denying other groups are covered by the FCA, they deny those groups the ability to lobby against legislation that prevents them from fully enjoying their chosen past-times, whether that is camping, or an activity that chooses to camp as a sideline.

The facilities required by the CSC standard are required for a minimum period of 3 days. So locals and others wanting only a single night down the local beach are still required to meet the requirements. Surfers and fishermen sleeping in their cars while waiting for early morning surf breaks. In that respect, the self containment standard fails to be inclusive of everyone as defined by the Freedom Camping Act.

Recently there has been a complaint made to the Commerce Commission concerning the NZMCA's authority over the amendments made to the standard. The reasoning for these amendments appear to be about removing others rights to meet the standard rather than being driven by any real problems or to make campers safer or more responsible.

One District Council is known to have signage stating that they will only accept Freedom Campers with CSC certification issued only by the New Zealand Motor Caravan Association!

Recently the issue of the possibility of a nationwide data base for CSC vehicles was raised. Claims about fake stickers and questions over the legality of certification of some vans, is actually the most damaging perceived issue currently facing freedom camping.

Many that question the stickers and certification, have little real knowledge of the standard. At times that has not been helped by government websites where recently one stated that a shower was a requirement of self containment certification - It is not and never has been.

A Councillor in New Plymouth has publicly claimed that any camper-van where the cooking can not be done inside, is non- compliant with the CSC standard - That is also incorrect.

Even the Department of Conservation has conceded it got it wrong and have now admitted that the back-country is actually covered by the Freedom Camping Act. This confirms determinations that there was nothing exempting the back country in the Freedom Camping Act. The Department of Conservation has for the past 9 years been advising the back country was not included and has now changed its web sites to reflect that new status.

I am fully aware that WDC was coerced into this illegal component of the bylaw like all the other Districts were. But that was four years ago. Now is the time to correct it. To make available this inalienable right in NZ to freedom camp again, as it always was, for every NZer, every tourist in a tent or van or station wagon or any other vehicle. (THE legal definition in the ACT.) Those that do not prescribe to self containment. Those who cannot, of course, afford a luxury motorhome.

I often go out of my way to meet tourists gathered in station wagons and vans. They are the most lovely, educated and charming of youth. Keen to explore our country and to get to know our people. They would all, of course, prefer to park at places where public toilets are open all night and where there are rubbish facilities. But unfortunately, they find that they are locked out of places with facilities these days. They are often gone early in the morning and there is almost never an issue with rubbish or waste. So long as facilities are provided. I know this because I often stay there with them.

These are the places where they ought to park. There is no mention of these places as being an 'appropriate' place for them to park. Only a perceived problem.

There will only be a problem if we didn't provide them rubbish bins or a loo! We would create the perceived problem. It would be our own fault!

Not once, in the process of creating this new proposed bylaw, has Whangarei Council done a 'proper assessment' of the necessity to make a bylaw, nor did it give any consideration, to places where there is no trouble, where facilities are actually coping just fine.

And it will be blamed again on the type of vehicle we drive. CSC or NON CSC.

But hang on...The Freedom camping Act only describes the word 'Vehicle.' There is no mention, whatsoever, about a Certified Self Contained vehicle, or that it is the only recognized and acceptable 'vehicle' that is allowed to freedom camp. Or that it is an absolute requirement, to freedom camp.

The Freedom Camping act 2011, section 2(1) says it uses the same definition as the land transport act 1998 to define what a 'Vehicle' actually is?

It states that a vehicle is-

(a) A contrivance equipped with wheels, tracks, or revolving runners on which it moves or is moved; and

(b) includes a hovercraft, a skateboard, in-line skates, and roller skates.

In the Freedom Camping Act 2011 it states bylaws must not absolutely prohibit freedom camping

(1) A local authority may not make bylaws under section 11 that have the effect of prohibiting freedom camping in all the local authority areas in its district.

(2) This section is for the avoidance of doubt.

To make a Freedom Camping Bylaw

(1) A local authority may make bylaws by;

(a) defining the local authority areas in its district or region where freedom camping is restricted and the restrictions that apply to freedom camping in those areas:

(b) defining the local authority areas in its district or region where freedom camping is prohibited.

(2) A local authority may make a bylaw under subsection (1) only if it is satisfied that

(a) the bylaw is necessary for 1 or more of the following purposes:

(I) to protect the area:

(ii) to protect the health and safety of people who may visit the area:

(iii) to protect access to the area; and

(b) the bylaw is the most appropriate and proportionate way of addressing the perceived problem in relation to that area; and

(c) the bylaw is not inconsistent with the New Zealand Bill of Rights Act 1990.

(5) The local authority must use the special consultative procedure set out in section 83 of the Local Government Act 2002 (as modified by section 86 of that Act) in;

(a) making a bylaw under this section; or

(b) amending a bylaw made under this section; or

(c) revoking a bylaw made under this section.

(6) Despite subsection (5)(b), a local authority may, by resolution publicly notified, make minor changes to, or correct errors in, a bylaw made under this section, but only if the changes or corrections do not affect;

(a) an existing right, interest, title, immunity, or duty of any person to whom the bylaw applies;

(b) an existing status or capacity of any person to whom the bylaw applies.

Which gives rise to the fact that Councils can only decide where freedom Camping is restricted not where it is only allowed. The Freedom Camping Act gives no right for Councils to dictate where exactly we may freedom camp. Yet this new proposal does exactly that.

In 2013 the NZMCA challenged the Westland District Council to the High Court in a bid to protect the rights of its members to freedom camp.

Councils sought to have a mechanism to deal with the worst offending freedom campers, and that's when the government introduced the Freedom Camping Act 2011.

However the NZMCA believed the Westland District Council had gone too far when they effectively imposed prohibition on freedom camping on all public land and roads within one kilometer of townships. The President, stated "the key priority of the NZMCA was to protect and provide for its members." (read that part again... Slowly). He said "workable bylaws strike the proper balance between protecting local authority areas and respecting the rights of freedom campers. We are looking forward to working with the Westland District Council to find a solution that works. The NZMCA would now be in touch with other councils about the impact of the legal action and would be looking to engage those whose freedom camping bylaws were unlawful and not up to scratch"

If we are to actually address and fix the issues surrounding freedom camping, the first thing that must happen, is we must point out to the self-obsessed NZMCA, that their 'model' bylaw is not lawful or up-to-scratch either.

The NZMCA are responsible for building a fence to protect themselves against a growing tourism industry, not a bridge toward it.

What a shambles alright! The CSC standard is not in law anywhere else in the world. And it hasn't worked here.

Councillors, Unless you can prove me wrong about my research into the legality of CSC. Then by all means, do. If you cannot, you must revoke this proposed bylaw on the grounds I claim

We need to remove the component that makes it illegal and re-think how to create fair social policy that works within the Freedom Camping Act and within your obligations to NZ Bill of

Rights.

This will require an enthusiastic Council who is prepared to listen and make bold new steps by creating the necessary change for the better. I would like to be invited into this future process.

What a great opportunity we all have to correct this injustice once and for all.

C. Woofers and fruit pickers who travel and work. They might have cheap vans, not the best, borderline self contained. We want their labour, so maybe after their first successful job, the people (max 2 per van) can get a permit to park at sites with toilets. Borderline ok......

B. People who drive or buy reasonable sized campervans, up to 4 people. Rigorous checking before given certificates.

A. Big campers. Categories B and A are also growing too fast. Stop the firms, who have for a couple of years. .

NZ long-term traveller category. These people don't pay rates anywhere, so are really freeloading with roads, libraries, parks, stopping areas, toilets, help that councils provide to those less fortunate, etc. Must be big enough to have SC toilet 'in a room'. How can we charge them something? These people have to pay rates the amount of a moderate sized city somewhere to enjoy free travel for ever. HOW? Homeless A different problem. Offer a city carpark and have agencies looking to help these people. We don't want them to live in a car..

The Minister has decided high end is important, so we can now be honest about a policy that got badly out of hand. My advice to the Minister of Tourism would be to change the policy with regard to camping cars. Ban them, take the 'pretend' toilet systems out of the cars. Ban 50% this year, the rest next year. Here is one comment from a local. The growing number of parked camper vans and cars and vehicles littering the waterfront are definite a blot on the beauty of the area... (which is the very thing they come to see). A few tent spaces should be available at Reotahi for Te Araroa walkers only.

In Ocean Beach, do not allow the overflow carpark to be used. Other areas are ok if numbers are policed

No new areas. Spend money policing, especially the ones with 'pretend bathrooms'.

Any areas the locals hate it is probably for a reason - so be hard on problem areas, get the campers who cause trouble on a watchlist, and be prepared to close areas.

Over the summer period portable toilets were delivered to numerous public reserves in the bay to combat the visitors and freedom camper's pollution. These toilets were initially placed at many locations in the bay and after complaints were made; for fear of freedom campers blocking their view, polluting their area and other unforeseen problems, these were moved away, but not from the reserve close to our home. Why were some reserves spared but not the one closest to our property? There are permanent toilets available a short distance away nothing at the other end of the bay.

With addition of the portable toilets we have had to endure sleepless nights, with numerous parties occurring on the reserve where visitors continued to play loud music, light fires, have pets (especially dogs) and entertain to the early hours of the morning. As you can appreciate as an owner of property this is not the sort of behaviour that we should have to endure.

The freedom campers are sometimes self-contained, many are not, they put up tents late at night, stay and then pull down the next morning. I feel that it is unfair on day-trippers, wedding parties and other public users have nowhere to go as there is no room because of these overnight campers. With the majority of the reserve being taken by campers there is no room for daytime visitors. They are having to park on both sides of the roads and verges, children are ducking and diving between cars there will be an accident due to lack of parking.

Living next door to an unregulated campground was not on our radar when we purchased this property and we would appreciate your support in rectifying this matter as we would not like to endure another summer break under these conditions.

The council has a designated area for campers but this is not enforced. We look forward to hearing from you and would appreciate your plan to rectify this problem.

	but I see Councils nation wide have provide boat ramps and

trailer parking for boat owners. Children get play grounds, book lovers get libraries. I don't begrudge this. Motor home ownership is getting huge. Every year rental companies release 100's more onto the 2nd hand market. I really think Council needs to think more inclusive of this market an accept they are coming and any notion we will go to commercial ground -nah! Only if I want power.

The proposals seem to have been drafted by the shouldn't be allowed brigade. Much of it from some sort of prejudice, out moded thinking, perhaps jealousy. Most complaint we hear most often seem to stem from excrement left at places. In all my travels I have seen this once. I give no argument against restricting the non self contained. I also feel like most things in life a bit of monitoring and policing will resolve most issues. Wardens could be appointed with powers to move on any vans that don't comply or causing nuisance like noise, or blocking public access etc.

I therefore submit much of the proposal is disagreeable.

I am not familiar with all locations but will comment on the below that I am. Many of my comments will be relevant at other sites.

Page 29 Ngunguru School. Given that school is closed for the main summer break I can see no hindrance to the school drop off if camping was allowed from last week of December through to Auckland Anniversary weekend. - Always would agree to a limit of nights any van can stay (say 2 max) and yes must be self contained.

Regarding the expansion of the area I suspect a bit of a campaign from the owners across the road, so wonder if there really is an issue. But a 1 night limit year long and perhaps a limit on numbers would be reasonable.

Page 31 - 32 The notion that making a tiny area of asphalt available at sports parks, tucked away from any area of interest to a tourist, is bound to fail. It may serve some purpose so I don't object. I simply do not think this goes in anyway, to appeasing the motor van user needs and wants.

Page 33 It seems to be the thing these days, that if you want to stop something bring out the Dotterels. I can not see how Helena Bay over night parking on the road and reserve areas will effect Dotterels or Health. Day visitors swarming in to enjoy the beach will have a greater impact by far. Overnighting people are no more likely to be disturbing the dunes. If dogs are an issue ban dogs. In all cases I think freedom camping at sites like this should be limited to 1 or two nights. I accept no one should be allowed to establish for longer periods. A revisit time limit could also be imposed.

Page 34 Sandy bay- I feel pretty well feel the same about this as Helena Bay comments above. Seems a bit harsh especially given the surfer type of life style. Cater for them. Once again some simple management methods time limits etc would suffice. If access points are an issue put in a few bollards at key locations. Cars block access too!

Page 35 Otamure Bay. Once again I object to the prohibition. Yes DOC is adjacent but most self contained vanners don't need nor want to pay for a facilities we don't need. Leave that for non - self contained. Once again a night limit. Keep them (the vans) moving on.

Page 35 Whangaumu Street. I have stayed at this location. We were the only van there the 1st night but we are conscious people, we tucked van hard to one side well out of the way. The next day a wedding was held on the beach. About 50 people showed up drank beer and urinated all over the place. When they left they left a few empty beer bottles about. My wife and I collected these up and took them away.

Later that evening one other van arrived, a lady across the road came over to say we aren't allowed to stay. We had internet and showed we could, she left in a huff. We left the next morning as we planned.

My point is - it was the day visitors for the wedding that by far were the biggest nuisance at this location at that time. If it wasn't for us it it would have been left a mess. (We have done this elsewhere as well). Picking on Motor Homes is quite discriminatory and we can actually be a positive. I feel any submission to prohibit at this location is from the lady across the road or people like her who just get a bee in their bonnet. She had a go and neither of us were causing any problem. So can only speculate an exaggerated view point is given. I oppose the prohibition. Of course would support stay limitations. A local empowered to evict any noisy or unsavory activity could be a solution if needed.

Page 37 - Beach Road. I have always been opposed to the current measures. Over the years I have never seen many problems with vanners here. There was one that moved in a bit

long, but once again a time limit would sort that. The whole prohibited area is way over the top. This is one unique area where houses across the road would not have views interrupted and there is plenty of area. I would go further and put a coin operated power supply in a couple of spots and encourage them in. I get the feeling the ban has been the result of mean spirited busy bodies who just can't stand to see someone enjoy themselves. People park their cars in this area all over the place. They fish along the coast day and night. how can a van be any more an issue? A van is just a car with a bed inside and so what if its there at night. at night it is totally deserted. 	Prohibited Areas:
	McAuslin Road, Sandy Bay (note this is Sandy Bay, not Matapouri)
	Agree with prohibiting camping along the whole road reserve as the road is narrow and loose gravel and the only turning point is right at the top dead-end where the popular Whananaki Walkway starts. All parking at the top end should be prohibited to allow a clear turning circle. The rest of the road should allow
	parking on one side only (the left hand uphill side).

The freedom camping problem in McAuslin Rd primarily relates to the DOC marginal strip above the beach access. Council should negotiate for the management and control of this strip (in the same way as Auckland Council controls similar beachside strips which belong to Auckland Transport on Waiheke Island).

This DOC strip should be converted to a reserve and should be enhanced and maintained as a passive recreation area with camping prohibited over the peak season.

Over the years we have noticed a significant increase in both number and size of camping vehicles in this tiny reserve. The scale of vehicles, often with awnings and cars attached, overwhelms the reserve, obstructs nearby residents' views, and prevents daily visitors using the grassy area for access to this end of the beach or for family picnics. This is the only grassed area adjacent to the beach as the rest of the foreshore has been retained with rock walls and needs to be accessed via steps. In order to prevent too many vehicles parking inconsiderately, the sloping garden area needs re-landscaping with low groundcover plants and protecting with bollards.

Out of peak season, this area needs to be restricted to selfcontained vehicles as it is some distance from the toilet block; the number of camping vehicles needs to be limited to a maximum of, say, three at any one time to preserve public access to the grassy reserve and beach; size of camping vehicle may need to be limited to 4m (as proposed at Sandy Bay Toilet Block Carpark) to allow safer manoeuvring; There is currently no signage here at all. Apart from signage about camping restrictions and rubbish removal, this area also needs a "Fires prohibited at all times" sign. Campers and party goers regularly light open fires here. Last summer a pohutukawa limb was scorched and more recently a neighbour's wooden gate was removed and burnt.

Restricted Areas:

Sandy Bay Toilet Block Carpark

Given that is a relatively small area, that self-contained vehicles tend to be large, that there are fewer camping options for non self-contained vehicles and tents than for self-contained vehicles, and the proximity of toilets, this area could be restricted to smaller non self-contained vehicles and tents. Currently, in addition to the influx of sand from time to time noted in the SOP, the ground here gets gouged out by big vehicles which become deep puddles after rain. This area could benefit from some fill and the installation of concrete grass reinforcing paving to provide a more durable but natural-looking surface which would better suit tents and would allow vehicles to manoeuvre without damaging the ground. Until this is done, there should be a limit on the total number of camping vehicles/tents per night, and I support the 4m length limit for vehicles proposed. Don't support peak season date prohibition. This is the very time of year when demand is high and this is the only Council freedom camping available at Sandy Bay. Better active management rather than prohibition is required.

Matapouri Wehiwehi Road Carpark

Don't support prohibition of camping in peak season. This is the very time of year when better active management rather than

prohibition is required.

Woolleys Bay Toilet Block Carpark

I think this already has designated carpark and camping park areas. If not, introduce these or re-assign these so the ratio of parks for day parking and camping better reflects the relative need. At the moment it seems as though campers are at the far end of the carpark from the toilets. It may be better to switch the areas around so campers are closer to the toilets and therefore more likely to use them. Don't support prohibition of camping in peak season. This is the very time of year when better active management rather than prohibition is required. Peak season prohibition may just push the peak season problem to an earlier or later date slot.

Woolleys Bay E Carpark

This is very similar in size and location to the DOC strip in McAuslin Road, Sandy Bay. This could also benefit from some landscaping and land shaping. Agree with camping prohibition as camping vehicles in this area would obstruct local residents' views and this area provides the most level accessible point to the beach on foot.

I am a resident of Wehiwehi Road, Matapouri and wish to state my support for the proposal to restrict camping at the Wehiwehi Road carpark to outside the peak season. The carpark, and the road generally, become highly congested over the peak season, and any steps to ease this would be welcomed by both residents and day parkers. The road is narrow and the carpark is not big, so having camping vans in the area competing for space and facilities is problematic.

As I live only a couple of houses down from the carpark, I also regularly see campervans both camping outside the designated spaces (so that there are more campervans camping in the carpark than the facilities are intended to accommodate) and overstaying (it is not unusual to see a campervan stay for 3 nights). This can happen at any time of the year, but is most pronounced during the peak season.

While this submission specifically refers to the Wehiwehi Road carpark, I am supportive of the broader proposal for seasonal restrictions at other high-use areas.

My wife and I live on McAuslin Road, opposite the small piece of DOC land which has traditionally been used as a parking and picnic area for locals visiting Sandy Bay.

During Xmas and holiday periods and weekends it is becoming more of a camping site. Camper vans of all shapes and sizes race in to get the best spot and then spread out with awnings and sometimes even a second car. As there are no visible rules here, the dogs can roam free, clothes line set up, fires lit, tents spread out towards the beach, and the small hedges and bushes are always visited by the people without toilet facilities.

In fact there are often so many tents and campers that there is very little to no space for beach goers to park or picnic on the grassy reserve. We love seeing families picnic here and spending the day at the beach.

Young people regularly turn up at all hours and have parties around open fires on the grass picnic area or the sandy walk way to the beach and often sleep in their cars overnight. Regrettably they usually leave without cleaning up the fire remains or taking their broken burnt out bottles away.

So yes we would love no camping on the whole area along McAuslin road including the small reserve. According to DOC rules, you cannot camp in a conservation area where freedom camping is prohibited. Prohibited areas are normally near roads where there has been a history of problems caused by inappropriate freedom camping. This would be the case for McAuslin Road.

It would mostly self-regulate if there were 'No Camping' and 'No Fires' signs erected as well as a sign showing the legal rules for dog owners.

When people see no signs they take that as, you can do whatever you like.

And one last thing that would make it a much safer area is to have a speed limit of 30 kmph, to slow down the speed racers sliding around the corners as well as into the car park.

If the length of this submission is a deterrent to the reader then I urge a read of the first few pages before turning to the specific comment on the Bylaw draft at the end of the submission.

I lodge this submission to the Whangarei District Council because of my qualifications and background in this field of recreation and tourism management

I have held a long interest in recreation and tourism, including a 47year career with the Dept of Conservation where I specialised in Recreation Management.

I observed the Ambassador program over the past two summers reasonably closely and whilst I believe it was successful for what it was set up to do, I do not believe Councils approach to Freedom Camping is sustainable in its present form.

As a result of this summer's past trial and assessing what changes are needed going forward, it is suggested that the WDC begin their Bylaw review by asking the simple question "What do we want freedom camping* to look like in, say 5 or 10years' time?"

A scenario well worth while considering could be;

- Tourism is a thriving and well managed industry in Northland
- "Responsible Camping" has replaced the misleading term of "Freedom Camping" to best describe those who travel to Northland requiring toilets and a place to park up free for the night.
- Nationally, the distinction between "responsible camping" and "selfcontained camping" is a well-established and understood.
- Central Government has modified the Freedom Camping Act to include the tightening up of specifications/facilities required to be certified as a "Self-contained" vehicle.
- Local ratepayers and day visitors are not competing for space with "responsible campers" at destinations and popular recreational sites within the District – especially along the Districts coastline.
- Convenient locations and facilities have been set aside for "responsible campers" but are not on popular beaches, or at other popular day visitor sites, nor near existing camping grounds.
- Potential campers are well serviced with digital, easily accessible, up to date and well-presented information on the WDC Responsible Campers sites and associated conditions and expectations in advance of arriving to the District.
- Conflicts between "responsible campers", self-contained vehicles, visitors and ratepayers are minimal and manageable.
- Commercial campground owners are happy and feel supported by Council rather than in competition with as a direct result of their approach to "responsible camping" sites.

If the above outcomes are roughly those sought by Council, then this submission suggests a path for Council to follow to achieve them.

Tourism is a thriving and well managed industry in Northland

"Responsible camping" and "self-contained camping" are a significant component of the tourism industry in Northland. Nevertheless, throughout NZ it is an evolving industry that is currently messy and confusing. Both Central and Local Government need to take the lead to sort out a robust and consistent system that campers and operators are willing to conform to. Only when a welldesigned system is fully understood, promoted, monitored, enforced and seen to be consistently working through-out NZ, will Northland's own tourism industry thrive and reach its full potential.

"Responsible Camping" has replaced the misleading term of "Freedom Camping" to best describe those who travel to Northland requiring toilets and a place to park up free for the night.

In the national discussion, the move towards replacing "Freedom Camping" with "Responsible Camping" needs to be completed and embedded nationally. The mind-set developed over the years that one can camp anywhere in NZ without being self-contained has to stop. This needs to be led nationally by both Government and the tourism industry but also supported and promoted by local government. The connotations around the word "freedom" has morphed into "freedoms of choice" to move around and camp anywhere in NZ free of charge.

Nationally, the distinction between "responsible camping" and "selfcontained camping" is a well-established and understood.

Currently, in the conversations of most New Zealanders there is a lack of distinction made between freedom camping and self-contained camping and yet, the difference is huge.

The obvious difference is that there is a robust system established for the certification of self-contained vehicles to ensure that the environmental footprint arising from their use is minimal.

Most owners, apart from the certified motorhome rental companies, are members of the NZMCA who are generally older and have invested considerably in their rig. The NZMCA is a highly responsible organisation and promote a code of conduct that is based on "respect" - respect for others and respect for the environment. Of significance, the NZMCA have established for its members 43 owned or leased Camping Parks scattered around NZ's hotspots. These Parks lesson the impacts on space and facilities provided by councils.

On the other hand, freedom camping ranges from sleeping in cars, tents, vans with minimum facilities through to campervans that purport to be self-contained but are not.

Central Government has modified the Freedom Camping Act to include the tightening up of regulations/facilities required of a "Self-contained" vehicle to be certified. Arguably the most important step is for central government to regulate the campervan hire industry. The well-established companies who hire out modern, fit-for-purpose and certified motor homes are not the problem. It is the cheap and modified vans that have poured on to the market in recent years which do not contain adequate facilities and are not legally certified. Horror stories abound at the state of some vehicles, how they are fitted out and some of the condition's campers, especially those from overseas, sign-up to.

If all hire vans had to meet appropriate standards and certified annually many of the current issues e.g. toilet waste, would be resolved. The same standards and conditions need to apply to campers with their own vans as well. If vans cannot meet the standard and don't display approved certification, then they fall into the "responsible camping" group and must stay at locations where appropriate facilities are provided.

Local ratepayers and day visitors are not competing for space with responsible campers at popular recreational sites – especially along the Districts coastline.

"Carrying Capacity" and "Quality of Experience" are well established first principles in recreation planning. The provision of, or lack of facilities is a wellused and effective practice to manipulate increasing or reducing pressure on a site to meet carrying capacity and quality of experience goals.

The problem with Councils system that was applied during the 2018/2019 and 2019/20 seasons, is that it promoted and increased competition for space at the Districts hot spots to the point where the carrying capacity was exceeded and the quality of experience was compromised for all users. Ocean Beach was a prime example of this. Tension were created between local ratepayers, day visitors, self-contained vehicles, freedom campers and, in some locations, Te Araroa walkers. The only reason major disruption didn't occur was the success of the Council's "Ambassador" program. However, the program came at a cost to the taxpayer but, more importantly, the need for an ambassador program in the first place is entirely due to Council's approach to freedom camping and more specifically, its decisions on where freedom camping is permitted. It is contended that "Responsible Camping" should not involve being permitted to camp at locations:

• Where day visitors and locals congregate e.g. popular beaches, river swimming holes, sites with limited parking etc. It is argued that if it is good enough for locals and day visitors to travel daily to sites of recreational value then it is good enough for responsible campers to do the same.

The bulk of the effort from the ambassadors went into sorting out these congestion issues. Competition for parking inevitably led to day visitors parking in freedom camping parks and vice versa.

Freedom campers have different needs – more space to spread out tents/ gear/cooking and often evening drinking. Such activities/behaviours are often in conflict with locals and day visitors who are there specifically to enjoy the recreational opportunities that drew them to the site in the first place. • In the vicinity of a commercial camping ground (addressed later in the submission). Nationally, complaints from commercial campground operators at falling patronage have been more frequent during the last two summer seasons due to each Council's interpretation and application of the Freedom Camping Act 2011. It stands to reason that a large part of the camping fraternity will choose a free site over sites that cost, especially if that site has water and toilet facilities.

Convenient locations and facilities have been set aside for responsible campers but are not at popular beaches, or at other popular day visitor sites nor near existing camping grounds.

Central to the "Responsible Camping" solution is for Councils to provide a few, well located and appropriately sized sites for "Responsible Camping". It will be important to get the balance right between these three components.

- <u>Number</u> The number of sites will depend on demand and vary depending on the number and distance of the hot spots within individual Districts. Too many, and the cost of facilities and the maintenance thereof, will escalate. Too few sites, however, could lead to capacity issues. All sites will need some form of compliance regime. From all accounts the combination of the ambassador programme and Armourguard worked reasonably well in the Whangarei District. The number of sites and their location will have a large bearing on the compliance cost.
- Location There is little point in locating responsible camping "hubs" in the more remote locations as they will be the last options to be used. They should be sited reasonable centrally and act as hubs for convenient access throughout the District. They should not be located as previously mentioned;
 - at popular recreation sites,
 - anywhere near commercial camping grounds and,

- where appropriate facilities are lacking or in high demand from locals and day visitors.

Some existing locations that are closer to recreation outlets and have appropriate facilities may well be suitable for set numbers. A good example of this is the freedom camping site at Parua Bay. It is a pleasant open grassland area, on the coast, popular for launching boats, reasonably central but where there is no apparent clash with other recreation user groups.

Locations that could be considered for Responsible Camping Sites in the future are reserves that contain unallocated open space, winter sports grounds, schools and perhaps a confined area at Barge Park. Minimum facilities required are water, toilets and rubbish disposal facilities.

• <u>Size</u> – Sites too large could produce potential ongoing management issues associated with large numbers of younger people located in the one spot, especially in the evenings. Sites too small could lead to capacity issues

which may lead to greater costs in providing for more sites and facilities going forward.

Pending campers are well serviced with digital, easily accessible, up to date and well-presented information on the District's Responsible Campers sites and associated conditions and expectations in advance of arriving in the District.

Providing access to all relevant information prior to campers arriving in the District is critical. Responsible campers need to know;

- Where they can stay,
- for how long,
- associated costs, if any
- the facilities provided and,
- what are the associated conditions and rules (dogs, fires, alcohol bans etc).

Several Apps currently exist that campers regularly use to seek out sites and locations. These need to be exploited to get the right, up-to-date information loaded regularly. Potentially, all the District's Responsible Camping sites and commercial camping grounds could daily load on to these Apps their information on whether they are at full capacity or have vacancies, so that campers could know this information even prior to arriving within the District.

Conflicts between responsible campers, self-contained vehicles, visitors and ratepayers are minimal and manageable.

Of all these user groups, Responsible Campers have the greatest potential to adversely impact on the other groupings. By separating their daytime and overnight activity away from recreational day visitor hotspots and coastal communities, conflicts are minimised and manageable.

Due to Council's approach to Responsible Camping, commercial campground owners are happy and feel supported by Council rather than in competition with. .

Council need to liaise closely with commercial camping ground operators to gain an appreciation of their operational needs. A strong positive relationship should lead to benefits for both parties. There is no point in having spare capacity in commercial camps due to an abundant supply of free camping at Councils responsible camping sites. Indeed, Councils management approach should be working towards filling the commercial camping grounds first and with the Council responsible camping sites picking up the over-flow. Attracting new commercial camping enterprises to the District should also be encouraged and never should ratepayers be subsidising campers' holidays and at the expense of commercial camp operators.

In summary the application of this approach will:

- improve the experience of all user groups due to reducing the pressure on recreational hot spots
- improve the compliance of campers

- reduce WDC compliance activity arising from the better regulated and managed responsible camping activity
- make commercial camping grounds more viable
- less complaints from ratepayers due to separating out overnight camping from inappropriate sites
- lead to more tourism growth as a result of a more attractive, regulated and organised destination.

* "Freedom Camping" has been used when describing the current situation but "Responsible Camping" is used when describing the future situation.

Turning now to the proposed Bylaw changes and the questions Council have requested feedback on. Where there is no comment, my general support can be assumed. The feedback given has been guided by the case made above.

Q1. Are there any areas which should be added to the prohibited and/or restricted areas? If yes, which ones and why should these be included? Based on the above rationale the changes Council are proposing, in general terms, are heading in the right direction. Specific comment;

- a) <u>Self-Contained campers</u> Proposed changes are supported. Selfcontained campers will be well catered for and all proposals seem workable.
- b) Prohibited Camping Areas New prohibited camping sites are supported but further consideration should be given to prohibiting all camping at two other sites, Oceans Beach and Whananaki North. Ocean Beach - One of the busiest destinations within the District for both ratepayers, day visitors and the camping fraternity. It is a known hotspot throughout the summer that has had its fair share of Freedom Camping issues during the last few seasons. Ratepayers and day visitors must travel to Oceans Beach on a daily basis and there is no valid reason why this should not apply to all campers as well. The rationale provided on page 22 to retain camping is not supported (below in red and in particular, the highlighted). The limited parking spaces in such a busy location only compounds the likelihood of "unintended consequences". Campers, who have travelled to Oceans Beach with the intention of camping are more likely to push the bylaw boundaries if they find all the camping vehicle sites full. With the camp apps etc prohibiting all camping at this site would make it clear to campers that they need to make alternative camping arrangements and that they need to treat Oceans Beach as a day visitor site – like everyone else. At the very least Oceans should be closed to camping during the high season. "High use area yearround. Demand increased drastically since 2017 due to population growth in Whangārei Heads. 'Destination' surf beach. Although Ocean Beach is very busy and popular with day users as well as freedom campers, there

are few alternative camping options in the area and therefore prohibiting or significantly restricting freedom camping capacity could create unintended consequences".

<u>Whananaki North</u> – Known to be a camping site causing angst and given there are numerous commercial camping grounds in the near vicinity it should become a prohibited site.

- c) <u>Provision of "Hubs" for non-self-contained campers.</u> Rather than permitting non-self-contained camping at popular beaches where they have, and will continue to be in conflict with ratepayers and other day visitors it is proposed that a small number of "Hubs" be established at appropriate places where they would not be in conflict with other day user groups and locals. Council have identified a few of these hubs for selfcontained campers (Tikipunga Ruby Club, Onerahi Bowling Club) and it is proposed that these and, or, different sites with appropriate facilities are provided for non-self-contained campers – at least during the high season.
- d) <u>Tamaterau site.</u> This is not suitable as a site for self-contained or non-self-contained campers. It is the closest beach to the city of Whangarei and consequently gets a lot of use by day visitors. The parking area is small and quickly gets filled. Non-self-contained vehicles compete with day visitors along the beach front rather than park in their designated spot away from the beach. Furthermore, the parking area is adjacent to a sewage pump station which often smells heavily in summer. The site for tent campers does however work well in practice, so the Tamaterau site could be kept as a tent site only.

Q2. Should Council impose seasonal restrictions on freedom camping at all, some, or none of the proposed key destination beaches, as listed in the proposal?

Definitely some. See also above response within previous question. This could be the game-changer to lessen the adverse impact on ratepayers and day visitors.

Q3. Should Council designate peak-season overflow freedom camping sites at specified Sportsparks as described in the proposal?

See 1(d) above. Yes - this is essential during the peak season as described in the proposal but needs to extend to non-self-contained campers during the high season. If it is the Councils intention to encourage non self-contained campers into commercial camping grounds then, although admirable, camping grounds will not be able to cope with the demand during the high season. This will force the non-self-contained to hide away in locations without toilets and rubbish disposal facilities. The best approach is to provide a few reasonably centrally located "hubs". These could be the same as those set aside for the self-contained campers and/or be in additional to them.

Q4. We also want to know if you agree or disagree with anything else in the proposal, both generally or for specific areas.

 a) <u>Language</u> – Although Council has referred very well to the difference between self-contained campers and non-self-contained campers within the draft bylaw, it needs to continue with this separation generally with its information/publicity.

As stated earlier in this submission, the lumping together of these two very different camping practices under the general term of "freedom camping" has been at the root of most misunderstandings, confusion and misinterpretations of the Act that has led to so much angst throughout the country. Self-contained campers could well be identified as "freedom campers" because they do not require any facilities and they leave no footprint. On the other hand, non-self-contained campers are the exact antithesis of this – they require services and facilities and potentially leave a huge foot-print if they choose to camp elsewhere. Lumping them together sends out all the wrong messages if better control and management is to be achieved.

Making the change from calling all camping "freedom camping" to "responsible camping" as promoted by Kevin Davis would also help to send the right signals to those who own, hire-out and hire non-self-contained campers.

- b) Parua Bay site An excellent initiative to expand this site. This site is ideal for all three camping categories as it is not a destination beach site and thus, does not compete with are user groups and yet it is an ideal base for campers to carry-out day trips to the beaches - like everyone else. However, endeavouring to confine non-self-contained campers to the orange restricted area will create an impossible compliance issue and, the guestion needs to be asked, why not allow non-self-contained campers into the expanded self-contained area? The new "overflow" area will inevitably default to an expanded area and so may as well accept it as such and move on. Further, making this extended area subject to "when ground conditions permit" is not going to work. It must be known to Council that this extension area becomes a bog after any heavy rain. This is bound to happen over summer, and it will only take one down-pour to make this site unusable for the rest of the summer as vehicles churn it up when exiting. During the off-season of 2021, the drainage issue needs to be rectified to provide a dry and firm parking platform in readiness for the 2021/22 season.
- c) <u>Reotahi Map reference: S3-10</u> Council considering providing limited tent sites for Te Araroa walkers is supported. They need somewhere to camp.
- d) <u>Permanent or semi-permanent residence</u> The introduction of 6.5 clause "nothing in this Bylaw allows a person to take up permanent or semipermanent residence on any local authority area" is strongly supported.
- e) <u>Information</u>- Information supplied on Apps, websites, brochures etc needs to be well structured and easily understood. There should be no room for those breaking the rules to blame the information supplied for getting it wrong. Essentially, every camping site must specify which camper type(s)

it is designated for, map identifying zones (or insitu sign) if it is closed during the high season, the number of nights available and fines imposed for breaches.

Hello Tony,

Thank you for receiving our submission.

We are a young family of 4 living in an uncertified but fully self contained house bus. This is our home and currently the only way we see ourselves 'surviving' life, given our present position in the current economic climate. We cannot afford the luxury of even staying at a campsite, which for us is similar to the cost of renting. Instead we freedom camp perpetually, but also responsibly, respecting the same values as the freedom camping act.

Our submission is simply that we do not believe that the requirement to be certified to the self containment standard can legally be incorporated into a freedom camping bylaw. This is on two premise.

1. Through its technical details, the standard goes beyond a threshold of simply ensuring self containment. Not meeting every aspect of the standard, we are living proof that self containment and the goals of the FCA can be acheived without being certified.

2. As evidenced by the very existence of a FCA, we believe the ability to freedom camp is a right. This right should be for all kiwis to access equally. However, requiring certification makes this right inaccessible for many Kiwis either through inappropriate irrelevance to their specific reason or need to freedom camp, or more importantly through their financial means. We would suggest this is discrimination.

To draw conclusion from these two points, if there is an aspect to a bylaw which imposes excessive restriction beyond acheiving the goals of the act and which violates section 19 (let alone other sections) of the Bill of Rights, it likely violates section 2c of the FCA.

We would be prepared to explore this possibility in court should the need arise.

To supplement that line of thought, we recommend Responsible Campers Association Inc's accreditation program instead (perhaps along with the simple requirement of a portable toilet when a public toilet is

not readily at hand). This alternative has many reasons to recommend itself over CSC, as you can find on their website.

Education and responsibility should always be pursued and explored before restrictions.

Submission Letter On The Proposed New Freedom Camping Bylaw

Your Worship, Mayor Sheryl Mai and Councillors

Whangarei District Council have now proposed it's third, in a row, illegal Freedom Camping Bylaw. How do you feel about that?

This is not fair on the rate-payers who have had to fund all 3 of them. It is not fair on local Vehicle Dwellers who desperately need a legal bylaw to manage the issues associated with our growing group. And it's certainly not fair on Armourguard's Freedom Camping Compliance officers who are required to enforce it, or those involved in the fantastic Ambassador programme who are expected to help manage it.

We, your Whangarei Vehicle Dwelling Community, ask that this new proposal is revoked, at once. No-one, should be managed under illegal laws. Ever!

Being 'self contained' means simply 'having everything you need'. It's about owning responsibility. But the certification process has been used for political gain through a nationwide takeover of public lands by a private camping organisation..

Four years ago, I personally scuppered the new proposed Freedom Camping bylaw on the grounds that it was illegal because it allowed the Certified Self Containment (CSC) Standard.

Whangarei District Council conceded it 'got it wrong' and publicly stated it was a 'legal shambles'. They removed the Certified Self Contained 'Only' Restriction throughout the district and proposed rights for those in tents and non-self contained vehicles as well.

However, they still included the CSC standard as a restriction in their newly ratified Camping in Public Places Bylaw and those campers who were able to attain the standard, were allowed far more privilege to freedom camp in the District than those without.

So, I created The Whangarei Vehicle Dwellers facebook group and together we refused to be managed under another illegal bylaw. WDC conceded it got it wrong again and without even attempting to challenge us, simply allowed their permanent vehicle dwelling community to basically 'live' full time at Cobham Oval.

Instead WDC concentrated it's 'Camping in Public Places Bylaw's efforts in ensuring compliance to the more seasonal and fluid stream of domestic and international tourists.

The 'legal shambles' has come about, because this Council took too much advice from a private camping organisation, the New Zealand Motor Caravan Association. Who have taken a self-appointed leading role with council's all around the country, shaping, advising, establishing and promoting an illegal component to Freedom Camping bylaws. Certified Self Contained Freedom Camping Only.

Since 2011, Councils around the country in their panic to come up with solutions, have been coerced into bad decision making by this private organisation. We have allowed them, as expert advisers, to help create a new law, just for themselves. And that is the reason behind the legal shambles. That, is where it has all gone pear-shaped. That, is the very reason why WDC cannot enforce the bylaw against it's own

growing group of vehicle dwellers. The bylaw has no teeth. It is useless!

Instead WDC recently admitted that Permanent Vehicle Dwellers fit "outside the scope of the bylaw". It's a big thing to admit! Because if we fit outside the scope of the bylaw, then so does every other legal person in NZ. In fact, it's an admittance that the bylaw itself fit's outside the scope of law.

So here we sit, four years later. A new proposed amended version of the same Camping in Public Places Bylaw, which still includes the CSC restriction. Amended to give even more rights and privilege than ever to those vehicles with CSC while proposing to remove even more rights to those without.

That a private Camping organisation was allowed to create law in this country beggars belief. They created for councils, their very own 'Model' Freedom Camping bylaw to assist with local Council decision making. It, of course, proposed Certified Self Contained freedom camping only. This document was prepared by the NZMCA and public law experts, Chen Palmer, and in consultation with Local Government New Zealand, Department of Conservation and Department of Internal Affairs.

And in it....they slip in the term Self Containment

They state that, 'If local authorities restrict freedom camping at a particular site to selfcontained camping only, the following definition of self-contained vehicle may be useful:'

'Self-contained vehicle means a vehicle designed and built for the purpose of camping which has the capability of meeting the ablutionary and sanitary needs of occupants of that vehicle for a minimum of three days without requiring any external services or discharging any waste and complies with New Zealand Standard 5465:2001 as evidenced by the display of a current self-containment warrant issued under New Zealand Standard Self Containment of Motor Caravans and Caravans.'

It was such a delight for me, to find this little add-on...

...NZS 5465:2001. Note that self-contained vehicle is not defined in the Freedom Camping Act and that this is only an example as to how it may be defined."

'May be defined'?

It must be frustrating for those at the NZMCA, who now realise that NO. You cannot re-define the description in an ACT. You cannot just alter it and change the very philosophy and meaning of what it means too freedom camp.

Here's why;

THIS is THE legal description of what it means to freedom camp. According to the Freedom Camping Act 2011 it means to camp in 1 or more of the following:

a. A tent or other temporary structure

b. A caravan.

c. A car, campervan, housetruck, or other motor vehicle.

No-where, not even once, does the FCA ever mention Certified Self Containment. To have this important 'fix-it-all' term left-out entirely from this document, says a great deal.

You see, if we alter and re-label what it means too freedom camp, especially when it enables one group more privilege than others. If we take this right off the poor and give it to the rich, or if you like, we take it off youth on a shoe-string budget and allow it

as only a rite of passage for those who can afford a CSC vehicle, it breaches another Act, our rights.

The Human Rights Act 1993 describes

Victimisation

(1) It shall be unlawful for any person to treat or to threaten to treat any other person less favourably than he or she would treat other persons in the same or substantially similar circumstances.

Non-discrimination and minority rights.

Freedom from Discrimination

(1) Everyone has the right to freedom from discrimination on the grounds of discrimination in the Human Rights Act 1993.

(2) Measures taken in good faith for the purpose of assisting or advancing persons or groups of persons disadvantaged because of discrimination that is unlawful by virtue of Part 2 of the Human Rights Act 1993.

To determine whether a bylaw made under this Freedom camping Act is appropriate

(1) A local authority must, before commencing the process for making a bylaw, determine whether a bylaw is the most appropriate way of addressing the 'perceived problem.'

(2) If a local authority has determined that a bylaw is the most appropriate way of addressing the perceived problem, it must, before making the bylaw, determine whether the proposed bylaw;

(a) is the most appropriate form of bylaw; and

(b) gives rise to any implications under the New Zealand Bill of Rights Act 1990.

(3) No bylaw may be made which is inconsistent with the New Zealand Bill of Rights Act 1990.

Making freedom camping elitist and offering more privilege tor self contained luxury motor-homes IS inconsistent and goes against the very intention and purpose of what this Act is about.

These new bylaws are NOT appropriate in that we should take toilets away from Freedom campers with no toilets on board and allow these public facilities to only be used at night by vehicles that are already equipped with toilets.

It is NOT proportionate in that it favours one group over another. The have's and the have-not's.

It is NOT consistent with the Bill of Rights because it discriminates against the poor and youth in particular. Those young tourists freedom camping in vans, station wagons and tents who are unaware and ignorant of the trap set for them all around the country. Where they face penalties of up to \$200 fines.

Offering 'NON CSC' vehicles and tenters one night only and giving those with CSC more privileges is not the best way to address the perceived problem. It restricts their right to 'Freedom of Movement'. It victimizes all youth and tourists who choose to see this country on a shoe-string budget.

Lets look at what the intention of what an ACT is in this country.

An Act in New Zealand is designed to;

(a) affirm, protect, and promote human rights and fundamental freedoms in New Zealand; and

(b) to affirm New Zealand's commitment to the International Covenant on Civil and Political Rights

In the New Zealand sixth periodic report under the International Covenant on Civil and Political Rights it discusses Inequality.

'New Zealand aims to ensure an adequate standard of living and provide opportunities for all to participate fully in society, regardless of ethnicity age or gender'.

For the last 4 years the Certified Self Containment Standards legality has been questioned by many individuals and groups. I personally have challenged (on behalf of other freedom campers around the country) over 200 infringement notices written against the illegal CSC standard with a 100% success rate. It seems no Council is prepared to challenge me on CSC being an illegal restriction.

CSC is a 'non-cited Government Standard', so is only voluntary and cannot be written into law as a legal restriction. A 'cited' standard on the other hand, is mandatory and is the only type of Government standard on which laws can be made However, this has not stopped Councils using it as a restriction to freedom camping.

The eco-hypocrisy of CSC is incredible. I know many people with a CSC sticker who never use their own toilet. I have also met literally hundreds of people who have the sticker, but no toilet. Some CSC vehicles have dogs on board....which we must presume poop outside.....wouldn't they? It has been proven time and time again, that a CSC sticker does not a responsible person make. It just tries to say that the vehicle is responsible. And a vehicle should never be held responsible.

When CSC goes wrong and spills, it can be major, as you could well imagine. A traffic accident, or if the underneath plumbing is either hit or has rattled itself undone, the spillage becomes an environmental hazard. I have assisted with 3 of these types of repairs, just in the last year alone.

The CSC standard's certification is only available for a small minority of campers. Over the last few years the NZMCA have made amendments to the standard so that even less amount of these smaller vehicles are able to meet the criteria.

According to the Freedom Camping Act, camping includes hunting areas, where hunters take motor vehicles to an area where they set up camp for a week-end. As well, There are river-rafter's, fishermen, trampers, Te Arohas Trail walkers, cyclists etc

One could be forgiven for thinking freedom camping, as determined by local Councils and Government, is all about motor-homes & caravans but that is an incorrect perception. Actually motor-homes and caravans make up only a minority of campers as defined by the Act. In denying other groups are covered by the FCA, they deny those groups the ability to lobby against legislation that prevents them from fully enjoying their chosen past-times, whether that is camping, or an activity that chooses to camp as a sideline.

The facilities required by the CSC standard are required for a minimum period of 3 days. So locals and others wanting only a single night down the local beach are still required to meet the requirements. Surfers and fishermen sleeping in their cars while waiting for early morning surf breaks. In that respect, the self containment standard fails to be inclusive of everyone as defined by the Freedom Camping Act.

Recently there has been a complaint made to the Commerce Commission concerning

the NZMCA's authority over the amendments made to the standard. The reasoning for these amendments appear to be about removing others rights to meet the standard rather than being driven by any real problems or to make campers safer or more responsible.

One District Council is known to have signage stating that they will only accept Freedom Campers with CSC certification issued only by the New Zealand Motor Caravan Association!

Recently the issue of the possibility of a nationwide data base for CSC vehicles was raised. Claims about fake stickers and questions over the legality of certification of some vans, is actually the most damaging perceived issue currently facing freedom camping.

Many that question the stickers and certification, have little real knowledge of the standard. At times that has not been helped by government websites where recently one stated that a shower was a requirement of self containment certification - It is not and never has been.

A Councillor in New Plymouth has publicly claimed that any camper-van where the cooking can not be done inside, is non- compliant with the CSC standard - That is also incorrect.

Even the Department of Conservation has conceded it got it wrong and have now admitted that the back-country is actually covered by the Freedom Camping Act. This confirms determinations that there was nothing exempting the back country in the Freedom Camping Act. The Department of Conservation has for the past 9 years been advising the back country was not included and has now changed its web sites to reflect that new status.

I am fully aware that WDC was coerced into this illegal component of the bylaw like all the other Districts were. But that was four years ago. Now is the time to correct it. To make available this inalienable right in NZ to freedom camp again, as it always was, for every NZer, every tourist in a tent or van or station wagon or any other vehicle. (THE legal definition in the ACT.) Those that do not prescribe to self containment. Those who cannot, of course, afford a luxury motorhome.

I often go out of my way to meet tourists gathered in station wagons and vans. They are the most lovely, educated and charming of youth. Keen to explore our country and to get to know our people. They would all, of course, prefer to park at places where public toilets are open all night and where there are rubbish facilities. But unfortunately, they find that they are locked out of places with facilities these days. They are often gone early in the morning and there is almost never an issue with rubbish or waste. So long as facilities are provided. I know this because I often stay there with them.

These are the places where they ought to park. There is no mention of these places as being an 'appropriate' place for them to park. Only a perceived problem.

There will only be a problem if we didn't provide them rubbish bins or a loo! We would create the perceived problem. It would be our own fault!

Not once, in the process of creating this new proposed bylaw, has Whangarei Council done a 'proper assessment' of the necessity to make a bylaw, nor did it give any

consideration, to places where there is no trouble, where facilities are actually coping just fine.

And it will be blamed again on the type of vehicle we drive. CSC or NON CSC.

But hang on...The Freedom camping Act only describes the word 'Vehicle.' There is no mention, whatsoever, about a Certified Self Contained vehicle, or that it is the only recognized and acceptable 'vehicle' that is allowed to freedom camp. Or that it is an absolute requirement, to freedom camp.

The Freedom Camping act 2011, section 2(1) says it uses the same definition as the land transport act 1998 to define what a 'Vehicle' actually is?

It states that a vehicle is-

(a) A contrivance equipped with wheels, tracks, or revolving runners on which it moves or is moved; and

(b) includes a hovercraft, a skateboard, in-line skates, and roller skates.

In the Freedom Camping Act 2011 it states bylaws must not absolutely prohibit freedom camping

(1) A local authority may not make bylaws under section 11 that have the effect of prohibiting freedom camping in all the local authority areas in its district.

(2) This section is for the avoidance of doubt.

To make a Freedom Camping Bylaw

(1) A local authority may make bylaws by;

(a) defining the local authority areas in its district or region where freedom camping is restricted and the restrictions that apply to freedom camping in those areas:

(b) defining the local authority areas in its district or region where freedom camping is prohibited.

(2) A local authority may make a bylaw under subsection (1) only if it is satisfied that

(a) the bylaw is necessary for 1 or more of the following purposes:

(I) to protect the area:

(ii) to protect the health and safety of people who may visit the area:

(iii) to protect access to the area; and

(b) the bylaw is the most appropriate and proportionate way of addressing the perceived problem in relation to that area; and

(c) the bylaw is not inconsistent with the New Zealand Bill of Rights Act 1990.

(5) The local authority must use the special consultative procedure set out in section 83 of the Local Government Act 2002 (as modified by section 86 of that Act) in;

(a) making a bylaw under this section; or

(b) amending a bylaw made under this section; or

(c) revoking a bylaw made under this section.

(6) Despite subsection (5)(b), a local authority may, by resolution publicly notified, make minor changes to, or correct errors in, a bylaw made under this section, but only if the changes or corrections do not affect;

(a) an existing right, interest, title, immunity, or duty of any person to whom the bylaw applies;

(b) an existing status or capacity of any person to whom the bylaw applies.

Which gives rise to the fact that Councils can only decide where freedom Camping is restricted not where it is only allowed. The Freedom Camping Act gives no right for Councils to dictate where exactly we may freedom camp. Yet this new proposal does exactly that.

In 2013 the NZMCA challenged the Westland District Council to the High Court in a bid to protect the rights of its members to freedom camp.

Councils sought to have a mechanism to deal with the worst offending freedom campers, and that's when the government introduced the Freedom Camping Act 2011.

However the NZMCA believed the Westland District Council had gone too far when they effectively imposed prohibition on freedom camping on all public land and roads within one kilometer of townships. The President, stated "the key priority of the NZMCA was to protect and provide for its members." (read that part again... Slowly). He said "workable bylaws strike the proper balance between protecting local authority areas and respecting the rights of freedom campers. We are looking forward to working with the Westland District Council to find a solution that works. The NZMCA would now be in touch with other councils about the impact of the legal action and would be looking to engage those whose freedom camping bylaws were unlawful and not up to scratch"

If we are to actually address and fix the issues surrounding freedom camping, the first thing that must happen, is we must point out to the self-obsessed NZMCA, that their 'model' bylaw is not lawful or up-to-scratch either.

The NZMCA are responsible for building a fence to protect themselves against a growing tourism industry, not a bridge toward it.

What a shambles alright! The CSC standard is not in law anywhere else in the world. And it hasn't worked here.

Councillors, Unless you can prove me wrong about my research into the legality of CSC. Then by all means, do. If you cannot, you must revoke this proposed bylaw on the grounds I claim

We need to remove the component that makes it illegal and re-think how to create fair social policy that works within the Freedom Camping Act and within your obligations to NZ Bill of Rights.

This will require an enthusiastic Council who is prepared to listen and make bold new steps by creating the necessary change for the better. I would like to be invited into this future process.

What a great opportunity we all have to correct this injustice once and for all.

I am fully aware that WDC was coerced into this illegal component into the bylaw like all the other Districts were. But that was four years ago. Now is the time to correct it. To make available this inalienable right in NZ to freedom camp again, as it always was, for every NZer, every tourist in a tent or van or station wagon or any other vehicle. (THE legal definition in the ACT.) Those that do not prescribe to self-containment. Those who cannot, of course, afford a luxury motorhome.

I often go out of my way to meet tourists gathered in station wagons and vans. They are the most lovely, educated, and charming youth. Keen to explore our country and to get to know our people. They would all, of course, prefer to park in places where public toilets are open all night and where there are rubbish facilities. But unfortunately, they find that they are locked out of places with facilities these days. They are often gone early in the morning and there is almost never an issue with rubbish or waste. So long as facilities are provided. I know this because I often stay there with them.

These are the places where they ought to park. There is no mention of these places as being an 'appropriate' place for them to park. Only a perceived problem.

There will only be a problem if we didn't provide them rubbish bins or a loo! We would create a perceived problem. It would be our own fault!

Not once, in the process of creating this new proposed bylaw, has Whangarei Council done a 'proper assessment' of the necessity to make a bylaw, nor did it give any consideration, to places where there is no trouble, where facilities are actually coping just fine.

And it will be blamed again on the type of vehicle we drive. CSC or NON-CSC.

But hang on...The Freedom Camping Act only describes the word 'Vehicle.' There is no mention, whatsoever, about a Certified Self Contained vehicle, or that it is the only recognized and acceptable 'vehicle' that is allowed to freedom camp. Or that it is an absolute requirement, to freedom camp.

The Freedom Camping Act 2011, section 2(1) says it uses the same definition as the land transport act 1998 to define what a 'Vehicle' actually is?

It states that a vehicle is-

(a) A contrivance equipped with wheels, tracks, or revolving runners on which it moves or is moved; and

(b) includes a hovercraft, a skateboard, in-line skates, and roller skates.

In the Freedom Camping Act 2011 it states bylaws must not absolutely prohibit freedom camping

(1) A local authority may not make bylaws under section 11 that have the effect of prohibiting freedom camping in all the local authority areas in its district.

(2) This section is for the avoidance of doubt.

To make a Freedom Camping Bylaw

(1) A local authority may make bylaws by;

(a) defining the local authority areas in its district or region where freedom camping is restricted and the restrictions that apply to freedom camping in those areas:

(b) defining the local authority areas in its district or region where freedom camping is prohibited.

(2) A local authority may make a bylaw under subsection (1) only if it is satisfied that

(a) the bylaw is necessary for 1 or more of the following purposes:

(I) to protect the area:

(ii) to protect the health and safety of people who may visit the area:

(iii) to protect access to the area; and

(b) the bylaw is the most appropriate and proportionate way of addressing the perceived problem in relation to that area; and

(c) the bylaw is not inconsistent with the New Zealand Bill of Rights Act 1990.

(5) The local authority must use the special consultative procedure set out in section 83 of the Local Government Act 2002 (as modified by section 86 of that Act) in;

(a) making a bylaw under this section; or

(b) amending a bylaw made under this section; or

(c) revoking a bylaw made under this section.

(6) Despite subsection (5)(b), a local authority may, by resolution publicly notified, make minor changes to, or correct errors in, a bylaw made under this section, but only if the changes or corrections do not affect;

(a) an existing right, interest, title, immunity, or duty of any person to whom the bylaw applies;

(b) an existing status or capacity of any person to whom the bylaw applies.

This gives rise to the fact that Councils can only decide where freedom Camping is restricted not where it is only allowed. The Freedom Camping Act gives no right for Councils to dictate where exactly we may freedom camp. Yet this new proposal does exactly that.

In 2013 the NZMCA challenged the Westland District Council to the High Court in a bid to protect the rights of its members to freedom camp.

Councils sought to have a mechanism to deal with the worst offending freedom campers, and that's when the government introduced the Freedom Camping Act 2011.

However, the NZMCA believed the Westland District Council had gone too far when they effectively imposed a prohibition on freedom camping on all public land and roads within one kilometer of townships. The President, stated "the key priority of the NZMCA was to protect and provide for its members." (read that part again... Slowly). He said "workable bylaws strike the proper balance between protecting local authority areas and respecting the rights of freedom campers. We are looking forward to working with the Westland District Council to find a solution that works. The NZMCA would now be in touch with other councils about the impact of the legal action and would be looking to engage those whose freedom camping bylaws were unlawful and not up to scratch"

If we are to actually address and fix the issues surrounding freedom camping, the first thing that must happen is we must point out to the self-obsessed NZMCA, that their 'model' bylaw is not lawful or up-to-scratch either.

The NZMCA is responsible for building a fence to protect themselves against a growing tourism industry, not a bridge toward it.

What a shambles alright! The CSC standard is not in law anywhere else in the world. And it hasn't worked here.

Councilors, Unless you can prove me wrong about my research into the legality of CSC. Then, by all means, do. If you cannot, you must revoke this proposed bylaw on the grounds I claim

We need to remove the component that makes it illegal and re-think how to create a fair social policy that works within the Freedom Camping Act and within your obligations to the NZ Bill of Rights.

This will require an enthusiastic Council who is prepared to listen and make bold new steps by creating the necessary change for the better. I would like to be invited to this future process.

What a great opportunity we all have to correct this injustice once and for all.

Your Worship, Mayor Sheryl Mai and Councillors

Whangarei District Council have now proposed it's third, in a row, illegal Freedom Camping Bylaw. How do you feel about that?

This is not fair on the rate-payers who have had to fund all 3 of them. It is not fair on local Vehicle Dwellers who desperately need a legal bylaw to manage the issues associated with our growing group. And it's certainly not fair on Armourguard's Freedom Camping Compliance officers who are required to enforce it, or those involved in the fantastic Ambassador programme who are expected to help manage it.

We, your Whangarei Vehicle Dwelling Community, ask that this new proposal is revoked, at once. No-one, should be managed under illegal laws. Ever!

Being 'self contained' means simply 'having everything you need'. It's about owning responsibility. But the certification process has been used for political gain through a nationwide takeover of public lands by a private camping organisation..

Four years ago, I personally scuppered the new proposed Freedom Camping bylaw on the grounds that it was illegal because it allowed the Certified Self Containment (CSC) Standard.

Whangarei District Council conceded it 'got it wrong' and publicly stated it was a 'legal shambles'. They removed the Certified Self Contained 'Only' Restriction throughout the district and proposed rights for those in tents and non-self contained vehicles as well.

However, they still included the CSC standard as a restriction in their newly ratified Camping in Public Places Bylaw and those campers who were able to attain the standard, were allowed far more privilege to freedom camp in the District than those without.

So, I created The Whangarei Vehicle Dwellers facebook group and together we refused to be managed under another illegal bylaw. WDC conceded it got it wrong again and without even attempting to challenge us, simply allowed their permanent vehicle dwelling community to basically 'live' full time at Cobham Oval.

Instead WDC concentrated it's 'Camping in Public Places Bylaw's efforts in ensuring compliance to the more seasonal and fluid stream of domestic and international tourists.

The 'legal shambles' has come about, because this Council took too much advice from a private camping organisation, the New Zealand Motor Caravan Association. Who have taken a self-appointed leading role with council's all around the country, shaping, advising, establishing and promoting an illegal component to Freedom Camping bylaws. Certified Self Contained Freedom Camping Only.

Since 2011, Councils around the country in their panic to come up with solutions, have been coerced into bad decision making by this private organisation. We have allowed them, as expert advisers, to help create a new law, just for themselves. And that is the reason behind the legal shambles. That, is where it has all gone pear-shaped. That, is the very reason why WDC cannot enforce the bylaw against it's own growing group of vehicle dwellers. The bylaw has no teeth. It is useless!

Instead WDC recently admitted that Permanent Vehicle Dwellers fit "outside the scope of the bylaw". It's a big thing to admit! Because if we fit outside the scope of the bylaw, then so does every other legal person in NZ. In fact, it's an admittance that the bylaw itself fit's outside the scope of law.

So here we sit, four years later. A new proposed amended version of the same Camping in Public Places Bylaw, which still includes the CSC restriction. Amended to give even more rights and privilege than ever to those vehicles with CSC while proposing to remove even more rights to those without.

That a private Camping organisation was allowed to create law in this country beggars belief. They created for councils, their very own 'Model' Freedom Camping bylaw to assist with local Council decision making. It, of course, proposed Certified Self Contained freedom camping only. This document was prepared by the NZMCA and public law experts, Chen Palmer, and in consultation with Local Government New Zealand, Department of Conservation and Department of Internal Affairs.

And in it....they slip in the term Self Containment

They state that, 'If local authorities restrict freedom camping at a particular site to self-contained camping only, the following definition of self-contained vehicle may be useful:'

'Self-contained vehicle means a vehicle designed and built for the purpose of camping which has the capability of meeting the ablutionary and sanitary needs of occupants of that vehicle for a minimum of three days without requiring any external services or discharging any waste and complies with New Zealand Standard 5465:2001 as evidenced by the display of a current self-containment warrant issued under New Zealand Standard Self Containment of Motor Caravans and Caravans.'

It was such a delight for me, to find this little add-on...

...NZS 5465:2001. Note that self-contained vehicle is not defined in the Freedom Camping Act and that this is only an example as to how it may be defined."

'May be defined'?

It must be frustrating for those at the NZMCA, who now realise that NO. You cannot re-define the description in an ACT. You cannot just alter it and change the very philosophy and meaning of what it means too freedom camp.

Here's why;

THIS is THE legal description of what it means to freedom camp. According to the Freedom Camping Act 2011 it means to camp in 1 or more of the following:

a. A tent or other temporary structure

b. A caravan.

c. A car, campervan, housetruck, or other motor vehicle.

No-where, not even once, does the FCA ever mention Certified Self Containment. To have this important 'fix-it-all' term left-out entirely from this document, says a great deal.

You see, if we alter and re-label what it means too freedom camp, especially when it enables one group more privilege than others. If we take this right off the poor and give it to the rich, or if you like, we take it off youth on a shoe-string budget and allow it as only a rite of passage for those who can afford a CSC vehicle, it breaches another Act, our rights.

The Human Rights Act 1993 describes

Victimisation

(1) It shall be unlawful for any person to treat or to threaten to treat any other person less favourably than he or she would treat other persons in the same or substantially similar circumstances.

Non-discrimination and minority rights.

Freedom from Discrimination

(1) Everyone has the right to freedom from discrimination on the grounds of discrimination in the Human Rights Act 1993.

(2) Measures taken in good faith for the purpose of assisting or advancing persons or groups of persons disadvantaged because of discrimination that is unlawful by virtue of Part 2 of the Human Rights Act 1993.

To determine whether a bylaw made under this Freedom camping Act is appropriate

(1) A local authority must, before commencing the process for making a bylaw, determine whether a bylaw is the most appropriate way of addressing the 'perceived problem.'

(2) If a local authority has determined that a bylaw is the most appropriate way of addressing the perceived problem, it must, before making the bylaw, determine whether the proposed bylaw;

(a) is the most appropriate form of bylaw; and

(b) gives rise to any implications under the New Zealand Bill of Rights Act 1990.

(3) No bylaw may be made which is inconsistent with the New Zealand Bill of Rights Act 1990.

Making freedom camping elitist and offering more privilege tor self contained luxury motor-homes IS inconsistent and goes against the very intention and purpose of what this Act is about.

These new bylaws are NOT appropriate in that we should take toilets away from Freedom campers with no toilets on board and allow these public facilities to only be used at night by vehicles that are already equipped with toilets.

It is NOT proportionate in that it favours one group over another. The have's and the have-not's.

It is NOT consistent with the Bill of Rights because it discriminates against the poor and youth in particular. Those young tourists freedom camping in vans, station wagons and tents who are unaware and ignorant of the trap set for them all around the country. Where they face penalties of up to \$200 fines.

Offering 'NON CSC' vehicles and tenters one night only and giving those with CSC more privileges is not the best way to address the perceived problem. It restricts their right to 'Freedom of Movement'. It victimizes all youth and tourists who choose to see this country on a shoe-string budget.

Lets look at what the intention of what an ACT is in this country.

An Act in New Zealand is designed to;

(a) affirm, protect, and promote human rights and fundamental freedoms in New Zealand; and

Page 245 of 340

(b) to affirm New Zealand's commitment to the International Covenant on Civil and Political Rights

In the New Zealand sixth periodic report under the International Covenant on Civil and Political Rights it discusses Inequality.

'New Zealand aims to ensure an adequate standard of living and provide opportunities for all to participate fully in society, regardless of ethnicity age or gender'.

For the last 4 years the Certified Self Containment Standards legality has been questioned by many individuals and groups. I personally have challenged (on behalf of other freedom campers around the country) over 200 infringement notices written against the illegal CSC standard with a 100% success rate. It seems no Council is prepared to challenge me on CSC being an illegal restriction.

CSC is a 'non-cited Government Standard', so is only voluntary and cannot be written into law as a legal restriction. A 'cited' standard on the other hand, is mandatory and is the only type of Government standard on which laws can be made However, this has not stopped Councils using it as a restriction to freedom camping.

The eco-hypocrisy of CSC is incredible. I know many people with a CSC sticker who never use their own toilet. I have also met literally hundreds of people who have the sticker, but no toilet. Some CSC vehicles have dogs on board....which we must presume poop outside.....wouldn't they? It has been proven time and time again, that a CSC sticker does not a responsible person make. It just tries to say that the vehicle is responsible. And a vehicle should never be held responsible.

When CSC goes wrong and spills, it can be major, as you could well imagine. A traffic accident, or if the underneath plumbing is either hit or has rattled itself undone, the spillage becomes an environmental hazard. I have assisted with 3 of these types of repairs, just in the last year alone.

The CSC standard's certification is only available for a small minority of campers. Over the last few years the NZMCA have made amendments to the standard so that even less amount of these smaller vehicles are able to meet the criteria.

According to the Freedom Camping Act, camping includes hunting areas, where hunters take motor vehicles to an area where they set up camp for a week-end. As well, There are river-rafter's, fishermen, trampers, Te Arohas Trail walkers, cyclists etc

One could be forgiven for thinking freedom camping, as determined by local Councils and Government, is all about motor-homes & caravans but that is an incorrect perception. Actually motor-homes and caravans make up only a minority of campers as defined by the Act. In denying other groups are covered by the FCA, they deny those groups the ability to lobby against legislation that prevents them from fully enjoying their chosen past-times, whether that is camping, or an activity that chooses to camp as a sideline.

The facilities required by the CSC standard are required for a minimum period of 3 days. So locals and others wanting only a single night down the local beach are still required to meet the requirements. Surfers and fishermen sleeping in their cars while waiting for early morning surf breaks. In that respect, the self containment standard fails to be inclusive of everyone as defined by the Freedom Camping Act.

Recently there has been a complaint made to the Commerce Commission concerning the NZMCA's authority over the amendments made to the standard. The reasoning for

these amendments appear to be about removing others rights to meet the standard rather than being driven by any real problems or to make campers safer or more responsible.

One District Council is known to have signage stating that they will only accept Freedom Campers with CSC certification issued only by the New Zealand Motor Caravan Association!

Recently the issue of the possibility of a nationwide data base for CSC vehicles was raised. Claims about fake stickers and questions over the legality of certification of some vans, is actually the most damaging perceived issue currently facing freedom camping.

Many that question the stickers and certification, have little real knowledge of the standard. At times that has not been helped by government websites where recently one stated that a shower was a requirement of self containment certification - It is not and never has been.

A Councillor in New Plymouth has publicly claimed that any camper-van where the cooking can not be done inside, is non- compliant with the CSC standard - That is also incorrect.

Even the Department of Conservation has conceded it got it wrong and have now admitted that the back-country is actually covered by the Freedom Camping Act. This confirms determinations that there was nothing exempting the back country in the Freedom Camping Act. The Department of Conservation has for the past 9 years been advising the back country was not included and has now changed its web sites to reflect that new status.

I am fully aware that WDC was coerced into this illegal component of the bylaw like all the other Districts were. But that was four years ago. Now is the time to correct it. To make available this inalienable right in NZ to freedom camp again, as it always was, for every NZer, every tourist in a tent or van or station wagon or any other vehicle. (THE legal definition in the ACT.) Those that do not prescribe to self containment. Those who cannot, of course, afford a luxury motorhome.

I often go out of my way to meet tourists gathered in station wagons and vans. They are the most lovely, educated and charming of youth. Keen to explore our country and to get to know our people. They would all, of course, prefer to park at places where public toilets are open all night and where there are rubbish facilities. But unfortunately, they find that they are locked out of places with facilities these days. They are often gone early in the morning and there is almost never an issue with rubbish or waste. So long as facilities are provided. I know this because I often stay there with them.

These are the places where they ought to park. There is no mention of these places as being an 'appropriate' place for them to park. Only a perceived problem.

There will only be a problem if we didn't provide them rubbish bins or a loo! We would create the perceived problem. It would be our own fault!

Not once, in the process of creating this new proposed bylaw, has Whangarei Council done a 'proper assessment' of the necessity to make a bylaw, nor did it give any consideration, to places where there is no trouble, where facilities are actually coping just fine.

And it will be blamed again on the type of vehicle we drive. CSC or NON CSC.

But hang on...The Freedom camping Act only describes the word 'Vehicle.' There is no mention, whatsoever, about a Certified Self Contained vehicle, or that it is the only recognized and acceptable 'vehicle' that is allowed to freedom camp. Or that it is an absolute requirement, to freedom camp.

The Freedom Camping act 2011, section 2(1) says it uses the same definition as the land transport act 1998 to define what a 'Vehicle' actually is?

It states that a vehicle is-

· ·

(a) A contrivance equipped with wheels, tracks, or revolving runners on which it moves or is moved; and

(b) includes a hovercraft, a skateboard, in-line skates, and roller skates.

In the Freedom Camping Act 2011 it states bylaws must not absolutely prohibit freedom camping

(1) A local authority may not make bylaws under section 11 that have the effect of prohibiting freedom camping in all the local authority areas in its district.

(2) This section is for the avoidance of doubt.

To make a Freedom Camping Bylaw

(1) A local authority may make bylaws by;

(a) defining the local authority areas in its district or region where freedom camping is restricted and the restrictions that apply to freedom camping in those areas:

(b) defining the local authority areas in its district or region where freedom camping is prohibited.

(2) A local authority may make a bylaw under subsection (1) only if it is satisfied that

(a) the bylaw is necessary for 1 or more of the following purposes:

(I) to protect the area:

(ii) to protect the health and safety of people who may visit the area:

(iii) to protect access to the area; and

(b) the bylaw is the most appropriate and proportionate way of addressing the perceived problem in relation to that area; and

(c) the bylaw is not inconsistent with the New Zealand Bill of Rights Act 1990.

(5) The local authority must use the special consultative procedure set out in section 83 of the Local Government Act 2002 (as modified by section 86 of that Act) in;

(a) making a bylaw under this section; or

(b) amending a bylaw made under this section; or

(c) revoking a bylaw made under this section.

(6) Despite subsection (5)(b), a local authority may, by resolution publicly notified, make minor changes to, or correct errors in, a bylaw made under this section, but only if the changes or corrections do not affect;

(a) an existing right, interest, title, immunity, or duty of any person to whom the bylaw applies;

(b) an existing status or capacity of any person to whom the bylaw applies.

Which gives rise to the fact that Councils can only decide where freedom Camping is restricted not where it is only allowed. The Freedom Camping Act gives no right for Councils to dictate where exactly we may freedom camp. Yet this new proposal does

exactly that.

* `

In 2013 the NZMCA challenged the Westland District Council to the High Court in a bid to protect the rights of its members to freedom camp.

Councils sought to have a mechanism to deal with the worst offending freedom campers, and that's when the government introduced the Freedom Camping Act 2011.

However the NZMCA believed the Westland District Council had gone too far when they effectively imposed prohibition on freedom camping on all public land and roads within one kilometer of townships. The President, stated "the key priority of the NZMCA was to protect and provide for its members." (read that part again... Slowly). He said "workable bylaws strike the proper balance between protecting local authority areas and respecting the rights of freedom campers. We are looking forward to working with the Westland District Council to find a solution that works. The NZMCA would now be in touch with other councils about the impact of the legal action and would be looking to engage those whose freedom camping bylaws were unlawful and not up to scratch"

If we are to actually address and fix the issues surrounding freedom camping, the first thing that must happen, is we must point out to the self-obsessed NZMCA, that their 'model' bylaw is not lawful or up-to-scratch either.

The NZMCA are responsible for building a fence to protect themselves against a growing tourism industry, not a bridge toward it.

What a shambles alright! The CSC standard is not in law anywhere else in the world. And it hasn't worked here.

Councillors, Unless you can prove me wrong about my research into the legality of CSC. Then by all means, do. If you cannot, you must revoke this proposed bylaw on the grounds I claim

We need to remove the component that makes it illegal and re-think how to create fair social policy that works within the Freedom Camping Act and within your obligations to NZ Bill of Rights.

This will require an enthusiastic Council who is prepared to listen and make bold new steps by creating the necessary change for the better. I would like to be invited into this future process.

What a great opportunity we all have to correct this injustice once and for all.

Cardinal opportunities for elegance or its opposite vulgarity lie in the ways that council addresses and engages with Papatuanuku (Earth Mother], Ranginui [Sky Father], Tane Mahuta [god of the forest], Tawhirimatea [god of the winds], and Tangaroa [god of the sea], at bottom. As a Maori woman living on ancestral Maori land at Takahiwai, on the southern shore of Whangarei Te Rerenga Paraoa harbour, I am adept at guessing what will be required to safely support life as well as to esteem life that is endangered by people, especially, those seeking to camp without personal responsibility in and to public places.

There are few harsher condemnations against freedom camping in public places than the sadness citizens feel at the arrival of a vehicle at the end of a rural road, for our grief is in almost all cases fuelled more by a distaste for the detritus that will be strewn on the earth than by any hatred of the idea of camping in public space maintained by public taxes. Under the Resource Management Act, at least, councils are required to maintain and protect Indigenous or Native flora and fauna (biodiversity). There has been a serious decline in the country's native plants, animals, and habitats, and councils must do more to address the situation when considering amendments to the Public Places Bylaw. It is one thing, though, to consider amending the bylaw about the elegance of the public space and the vulgarity of freedom camping, but guite another to reconcile the 'freedom' to camp in public places with the Council's present capacity and capability to monitor and enforce the act. Therefore, groups such as the Kaitiaki Rangers and Cultural Ambassadors must be volunteers no longer! Their skills of elegant communication, for example, must be recognised as fulltime, qualified "essential services" in the dunes, on the beach and in the forest.

As housing estates creep closer and closer to the beach, forest, and farms, at Takahiwai, for instance, Council must ensure good laws that will not make the fields, the berm, forest, and the beach inferior to the public camping space. Council owes it to the worms and trees that the public spaces enjoyed by freedom campers will stand as promises of the highest and most intelligent kinds of elegance and happiness to *all* life. In considering amendments to

the bylaw, notions and practices of vulgarity must not be acceptable to the Council.

PROPOSED REVIEW TO THE CAMPING IN PUBLIC PLACES BYLAW 2017 Whangarei District Council

SUBMISSION BY Lang Cove Residents Association (LCRA) 20 Gazelle Way, Lang Beach 4th November 2020

1. Introduction

I am making this submission in my capacity as the Secretary of the Lang's Cove Residents Association Incorporated (LCRA). Additionally, I am a resident of Lang Cove and have a holiday home at 20 Gazelle Way which we live in frequently.

The LCRA is not opposed to Freedom Camping per sei, but we do see a need for greater surveillance, enforcement, and we believe the current penalty for infringing the By Law is not a sufficient deterrent.

The LCRA wants Lang's Beach Prohibited Camping area to remain as there isn't the space nor facilities to accommodate Freedom Camping and currently there is limited parking available for visitors. Furthermore we acknowledge that there are local options, which offer places that Freedom Campers can book into. We ask the WDC at supporting these options or they may disappear, due to the high market value of the land they sit on.

PROPOSED REVIEW TO THE CAMPING IN PUBLIC PLACES BYLAW 2017

- 2. In general, the LCRA supports the intention of the Whangarei District Council (WDC) to increase the number of sites being made available for Freedom Campers, but we believe emphasis should be placed on Self Contained Vehicles rather than non-self-contained vehicles, as experience has shown that these self-contained travellers tend to be tidier, more aware of the rules, and generally take their rubbish with them.
- 3. The LCRA is fully supportive of the WDC proposed amendments that relate to improving Health and Safety.
- 4. The LCRA does not believe the current penalty for infringing the Bylaw of \$200 is a sufficient deterrent and recommends this be lifted to \$300, noting that Section 43 (a)of the Freedom Camping Act, permits a fine not exceeding \$1000.
- 5. The LCRA would like to see the playground parking area on Cove Road to the Western end of Lang's Beach also be included in Schedule 1 of the Bylaw as being a Prohibited Area.
- 6. The LCRA would also like to see a greater presence of a person permitted to enforce the Bylaw, particularly during extended public holiday periods. Recently, there were three or four vehicles parked in the Prohibited area of the Lang Beach car Park for a period of ten days plus. When approached by residents they were advised that the drivers knew their rights and that they could stay. Apart from the incredible inconvenience to visitors to the beach, they also left a considerable amount of rubbish. I attached photographs to show a typical long weekend at Lang's Beach.
- 7. The LCRA would also like to have the contact details of the enforcement officers so residents do not have to approach Freedom Travellers to be told they don't have the authority to move them on.
- 8. The Lang's Beach parking area provides toilet facilities, fresh water and a waste dump station and there is a blue sign opposite to the toilet block indicating the availability of the dump station. The LCRA believes this sign may be a source of confusion for Freedom Campers as many seem to believe it indicates they can park there. The LCRA asks that this sign be moved onto the prohibited area and it be increased in size to include "Prohibited Parking Area".

- 9. In summary, the LCRA supports the WDC to:
 - 9.1. Increase the number of sites in the district for Self-Contained Freedom Camper Vehicles.
 - 9.2. Increase support for local campgrounds, or other areas that provide parking to Freedom Campers.
 - 9.3. Improve the Bylaw with a view to improving Health and Safety in the Camping Areas.
 - 9.4. Increase the penalty for infringing the Bylaw to \$300.
 - 9.5. Make the playground parking area to the western end of Lang's Beach on Cove Road, a Prohibited Area.
 - 9.6. See a greater presence of enforcement officers during public holidays
 - 9.7. Provide the LCRA with the contact details of these officers.
 - 9.8. Change the current sign as recommended which is located opposite the toilet block.

10. We do not wish to be heard at the forthcoming hearing.
