3 Background

The Community Fund is a contestable fund Council offers community groups.

The purpose of the Community Fund is to provide small grants for local projects or events that benefit the wider community or a sector of the community. Examples of ideal projects include festivals, community celebrations, workshops, or working bees that involve volunteer labour.

The maximum allowable grant is \$10,000.

4 Discussion

Eighteen applications were received to Round 1. Fourteen are recommended for a grant. One application was withdrawn and transferred to the Performing Arts Fund by agreement.

Applications include four festivals, four national conferences being hosted in Whangarei, recreational activities and community projects.

4.1 Financial/budget considerations

The available budget for both funding rounds in 2017-18 is \$75,000. This is an increase on previous years' budgets of \$60,000. The total requested in Round 1 is \$59,997.

Budget for 2017-18 \$75,000

Recommended for allocation in Round 1 \$36,188

Remaining for Round 2 \$38,812

While there are several new applicants this Round, the number of applications and the total sum requested is lower than previous funding rounds. The Fund was advertised for the eight weeks that it was open for applications, in Council News in The Leader, on social media, and via email databases.

4.2 Assessment process

The Grants, Concessions and Loans Policy and the criteria for this Fund were used in the assessment of applications. Applications were also assessed based on several factors including priority for the district, likelihood of success, and community need.

4.3 Funding level applied

To manage the limited pool of funds available and to provide some level of fairness to applicants, staff have applied a funding level of up to \$3,500 for festivals and conferences. This is a guideline only, and only applies to this Round. This funding level is consistent with the Christmas parade grants in the 2017-2018 Annual Operating Fund allocations.

Staff are considering funding levels and other minor changes to how community funding is administered, to be discussed with Council at a future date.

5 Applications

5.1 Festivals

A funding level of up to \$3,500 was applied to the following:

- i. Northland Indian Association Diwali Festival of Lights, October 2017, Forum North, Whangarei. Requested \$8,000. Good cultural event; ticketed entry. Expected ticket sales of 450. Recommending \$3,500.
- ii. Northland Chinese Association Chinese New Year Festival, February 2018, Forum North, Whangarei. Requested \$6,739. Good cultural event; ticketed entry. Expected ticket sales of 350. Recommending \$3,500.
- iii. Fale Pasifika Pasifika Fusion Festival, February 2018, Hihiaua Peninsula, Whangarei. Project costs seem overstated. Good cultural event that is free and open to all, in its third year. Recommending \$3,500.
- iv. Whangarei Parents Centre Teddy Bears Picnic, November 2017, Kiwi North, Whangarei. Requested \$2,755. Modest application and good, annual community event. Recommending \$2,755.

5.2 Conferences

A funding level of up to \$3,500 was applied to the following:

- i. Northland Masters Athletics NZ Masters Track and Field National Championships, March 2018, Kensington Park, Whangarei. Requested \$3,629. Good application and event, attracting 160 people to the district for the three-day event. Recommend \$3,500.
- ii. Northland District Rose Society 2017 National Rose Show, November 2017, Forum North, Whangarei. Requested \$4,047. Good application, brings visitors to the district. Recommending \$3,500.
- iii. Pacifica Whangarei (under WINGS) Pacifica National Conference 2018, February 2018, Whangarei. Requested \$3,466. Good cultural event that will bring 150 delegates to Whangarei. Recommending \$3,500.
- v. The Friendship Force of Whangarei (under Positive Living Promotions) National Conference bus tour, February 2018, Whangarei. Requested \$975. Modest support for this conference which will bring 120 delegates to the district, and provides them a short sightseeing bus tour of Whangarei. Recommending \$975.

5.3 Other projects

- NZ Council of Victim Support Groups Inc Volunteers' recruitment, training and expenses. Requested \$3,205. This is to support the Whangarei district's Victim Support team to recruit and train new volunteers. While 70% is funded centrally, local branches need to source 30% themselves. Complements our City Safe partnership. Recommending \$3,205.
- Mountains to Sea Conservation Trust Snorkeling Days at Reotahi, January-April 2018, Whangarei. Requested \$3,550. Regular applicant, seeking to provide 5 guided snorkel days over the 2018 summer as a free community event. This provides for several skilled volunteers, equipment, a coordinator, and marketing. Average of 125 people per day last season. Recommending \$3,000 as comparing the project to the festivals above.
- Tutukaka Coast Youth Sailing Club Learn to Sail Programme and club rebuild, September – December 2017, Tutukaka. Requested \$1,106. This club is reestablishing itself after a long hiatus. The new committee is focused and driven, working towards self-sustainability, and is working with the Men's Shed to restore their boats. Funding is for repair materials and marketing of programme. Good club/programme for all ages, locals and visitors. Very modest and well-presented application. Recommending \$1,106.
- Friends of the Berm @ Takahiwai Group (under Creative Northland) O Matou Taonga Katoa: All Our Treasures. Requested \$2,390. This is a community project to clean up a road berm and bus stop area, including replanting with natives and a mural project involving the local school. The project has been approved by Council's Roading team. Staff have worked with this group to develop their application and will continue to do so

- as the need arises. They were granted \$865 from the Creative Communities Scheme following this application, and deducting this from their request leaves \$1,525. Recommending \$1,525.
- Parihaka Community Landcare (under Kiwi Coast) Community led pest mammal control on Mt Parihaka, all year. Requested \$2,622. Currently receives 3 months' worth of pest control supplies from Council's Parks team. This request is to enable pest control for the full year on this inner-city icon. Good environmental project, community led, and involving students from NorthTec. Recommending \$2,622.

5.4 Recommended for decline

The following applications are recommended for decline based on ineligibility:

- The Royal NZ Foundation for the Blind applied for the purchase of Talking Books to add to their national collection. There is some indirect benefit to the Whangarei community as these are available nationwide, and it does not conflict with Council's own library services. However, it is up for debate whether the purchase of library content is a capital expense and therefore ineligible. Staff acknowledge the worthy nature of the application, but in keeping consistent with our policy, we are recommending this to be declined.
- NorthAble Disability Services applied for the purchase of an all-terrain buggy. While a
 worthy request, capital items are not eligible. In addition, the accounts show the
 applicant has the means to fund this themselves, also ineligible under the Policy.
- Whangarei A&P Society applied to have an educational entertainer at the A&P show.
 Their accounts show the applicant has the means to fund this themselves, ineligible under the Policy. The A&P show demonstrates good benefits for the district, however this particular portion of it did not rate highly in comparison to the other applications.
- Maunu Garden Project Charitable Trust applied for classroom and kitchen renovations. The land and buildings were leased from Council's Parks team, and therefore the applicant should be referred to the 'landlord' for consideration. The current lease is expired and staff will negotiate a new lease with the applicant. These works may form part of that new lease agreement. Staff will also meet with the Trust to determine other needs and opportunities.

6 Significance and engagement

The decisions or matters of this Agenda do not trigger the significance criteria outlined in Council's Significance and Engagement Policy, and the public will be informed via Agenda publication on the website. Grant recipients are also publicised on the Funding and Grants section of Council's website.
