Consultation activities

- Submissions period 28 October 27 November
- 2x notices in Council News
- 2x Facebook posts
- Direct email notification of consultation to stakeholders:
 - previous submitters
 - commercial campgrounds
 - resident and ratepayer associations
 - Maori partners

• 207 submissions

- one submission was supported by a petition with 13 signatures
- 23 people spoke at the Hearing



Feedback summary

- Support for seasonal restrictions
 - 14 submissions in support of seasonal restrictions
 - 8 opposed
 - 8 submitters asking for seasonal restrictions on all beaches
 - Staff recommendation to continue with proposal as consulted on. See Attachment 1.
- Self-containment a dividing issue
 - 21 submissions requesting that only self-contained vehicles be allowed
 - 17 submissions opposing the use of the self-containment standard
 - The self-containment Standard is best practice and is widely used by councils throughout New Zealand. Staff advice is to retain the self-containment standard as per SOP.

• Numerous out of scope requests

- 15x submitters requesting provision of facilities
- 13x operational matters including enforcement and signage
- 5x requesting parking for large motorhomes
- 7x other, including concerns about cost to ratepayers
 - Relevant operational matters have been referred by staff to the Health and Bylaws department and to Parks

Whananaki North

20 submissions requesting further restrictions or prohibitions

11x oppose amendment and seek prohibition

- prohibit FC to protect area and health and safety from rubbish and toileting, hygiene concerns, human waste on reserve, complaints of urinating in sea, nudity
- protect estuarine environment
- prohibit as overcrowded
- prohibit FC to protect access to boat ramp prohibit FC to protect campgrounds

7x seeking seasonal restrictions

- seasonal restrictions to protect health. Hygiene concerns, human waste on the estuary, toilets already busy and then used by campers for washing and dishes, people urinating in the estuary when toilet is busy;
- restrict to outside the peak season. Many vehicles are not truly self-contained. overcrowding
- in peak season, campers intimidating and consume alcohol
- 2x position unclear, but implies greater restrictions
 - limit camper numbers to 3 to reduce pressure on effluent field protect whenua from environmental damage

Whananaki North

- Option of closing the designated site at Whananaki North and removing the area from Schedule 4.
 - general rule would apply clause 6 of the bylaw self-contained vehicles can still camp up to 3 nights
 - response to consultation feedback that there has been human waste in the reserve and estuary.
 - site is no longer "advertised" on the maps same regulation as for the nearby boat launching layby area and the reserve by the school
 - vehicles must be legally parked
 - no tents, but affordable tent camping options are available at the nearby DOC campsite.
