Delegations

- (i) All powers necessary to perform the committee's responsibilities, including, but not limited to:

 - b) establishment of working parties or steering groups.
 - c) adoption of strategies and policies relating to the key responsibilities of this committee (except for those that cannot be delegated by Council under Clause 32(1)(f) of Schedule 7 of the Local Government Act (LGA).
 - d) the approval of expenditure of less than \$5 million plus GST.
 - e) the power to adopt the Special Consultative Procedure provided for in Section 83 to 88 of the LGA in respect of matters under its jurisdiction (this allows for setting of fees and bylaw making processes up to but not including adoption).
 - f) the power to delegate any of its powers to any joint committee established for any relevant purpose under clause 32, Schedule 7 of the Local Government Act 2002.

The Committee does not have:

- I. The power to establish sub-committees.
- II. The powers Council is expressly prohibited from delegating as outlined in Clause 32(1)(a)-(h) of Schedule 7 of the Local Government Act 2002; being:
 - the power to make a rate
 - the power to make a bylaw
 - the power to borrow money, or purchase or dispose of assets, other than in accordance with the long-term plan
 - the power to adopt a long-term plan, annual plan or annual report
 - the power to appoint a chief executive the power to adopt policies required to be adopted and consulted on under the Local Government 2002 in association with the long-term plan or developed for the purpose of the local governance statement
 - the power to adopt a remuneration and employment policy.

How did it go?

Describe the difference your project made to the community:

The Marae project has had a positive impact on the community through increased community engagement and empowerment. By fostering greater consultation and collaboration with stakeholders, the project has instilled a sense of ownership and involvement in the development of the Marae. This inclusive decision-making process has strengthened relationships within the community and promoted a shared vision for the project. Furthermore, the Marae project is expected to bring long-term social and economic benefits to the community. Progress towards building the Marae has the potential to create job opportunities, increase tourism, assist in Civil Defence Aid and promote cultural exchange within the community. By providing a space for cultural gatherings, education, and community events, the Marae project contributes to the overall well-being and resilience of the community.

Did your project go as planned and as outlined in your application?

No, the Marae project did not go as planned as outlined in the application. The original Marae site had to be moved to higher ground due to being situated in a flood-prone area.

This decision was made following a Marae site visit with whanau, owners, beneficiaries, and community members. Representatives from the Department of Internal Affairs (DIA) and Te Puni Kokiri (TPK) attended the meeting to discuss funding and available resources, while Whangarei District Council (WDC) Councillors showed their support and gained an understanding of the new location.

The outcome of the site relocation decision was to move the Marae site to higher ground above the urupa, with the Marae Committee tasked with carrying out the work for the new site. Further surveying, geotechnical reports and architectural designs were required before we were able to submit for Consent. Unfortunately, the project was delayed due to the site relocation, and progress was further hindered by the impact of COVID-19 on the timeline, as well as an increase in building material costs.

We are happy to report that the project is now at Resource Consent stage.

How many people directly benefitted from the project? How many were actively involved?

A total of approximately 200 members directly benefited from the Marae project, experiencing the cultural, social, and economic advantages brought about by its development and activities.

Additionally, the project had a positive impact on the wider community, reaching beyond the hap members to engage and involve a broader group of individuals. This inclusive approach includes whanau, community members, and Whangarei District Council (WDC) members who actively participated in our Site Visits. By involving a diverse group of individuals, the project fostered a sense of unity, pride, and cooperation among participants.

The engagement of the wider community also contributed to a more inclusive and collaborative approach to decision-making and resource-sharing, promoting a sense of belonging and ownership of the Marae development within the community.

What have you learnt through this and what would you do differently next time?

The Marae project taught us the value of having a project manager for smoother coordination and task implementation.

We learned the importance of having a contingency plan to mitigate unexpected issues like COVID-19 and cyclones. In future projects, we will prioritize appointing a project manager and developing proactive contingency plans to enhance project resilience and success.

We also recognize the need to increase our capacity and capability as we heavily rely on volunteers, and finding additional resources to pay for a project manager would greatly benefit our projects and improve their outcomes. These lessons will help improve project management practices and readiness for challenges, ultimately leading to better project outcomes.

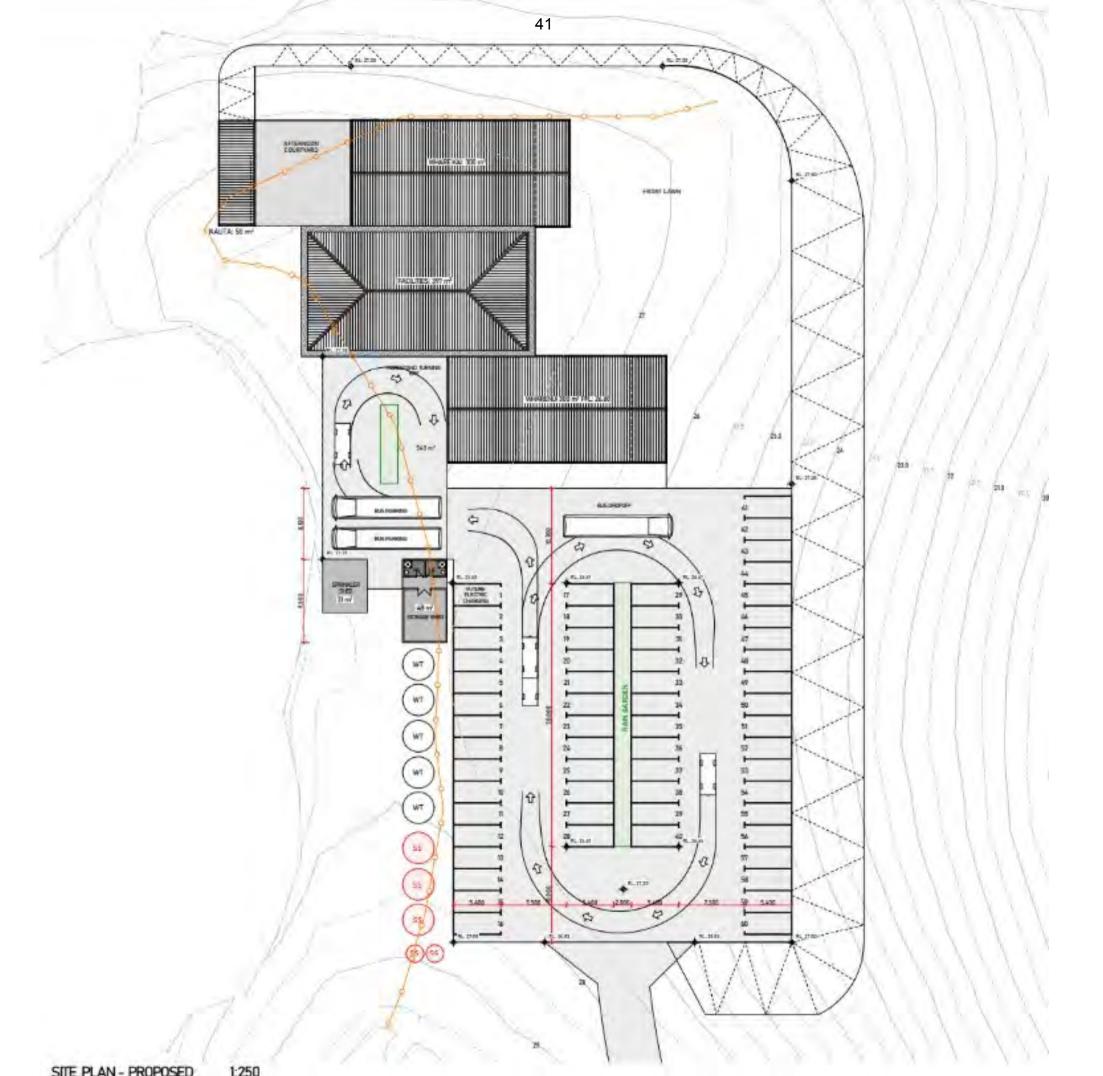


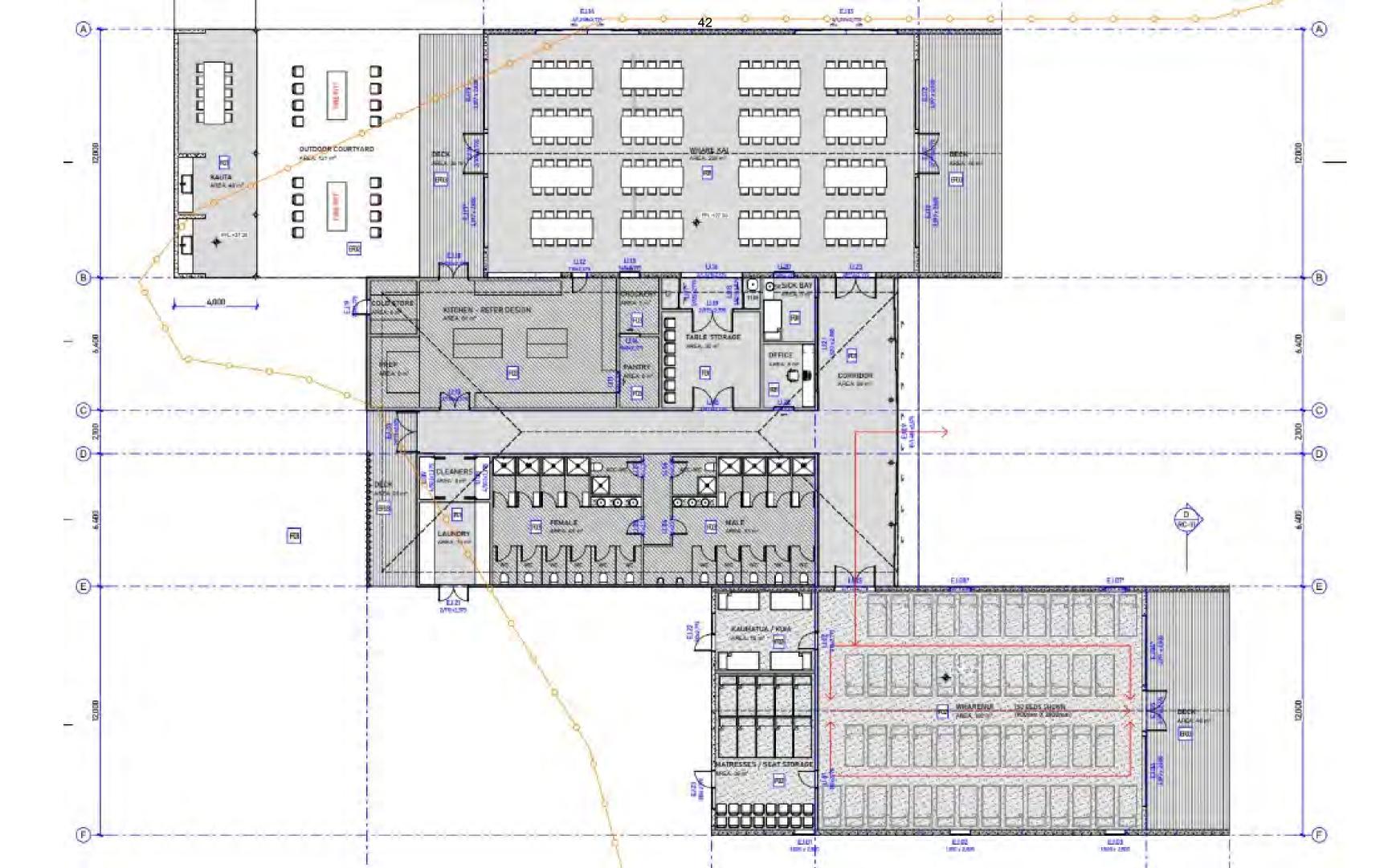

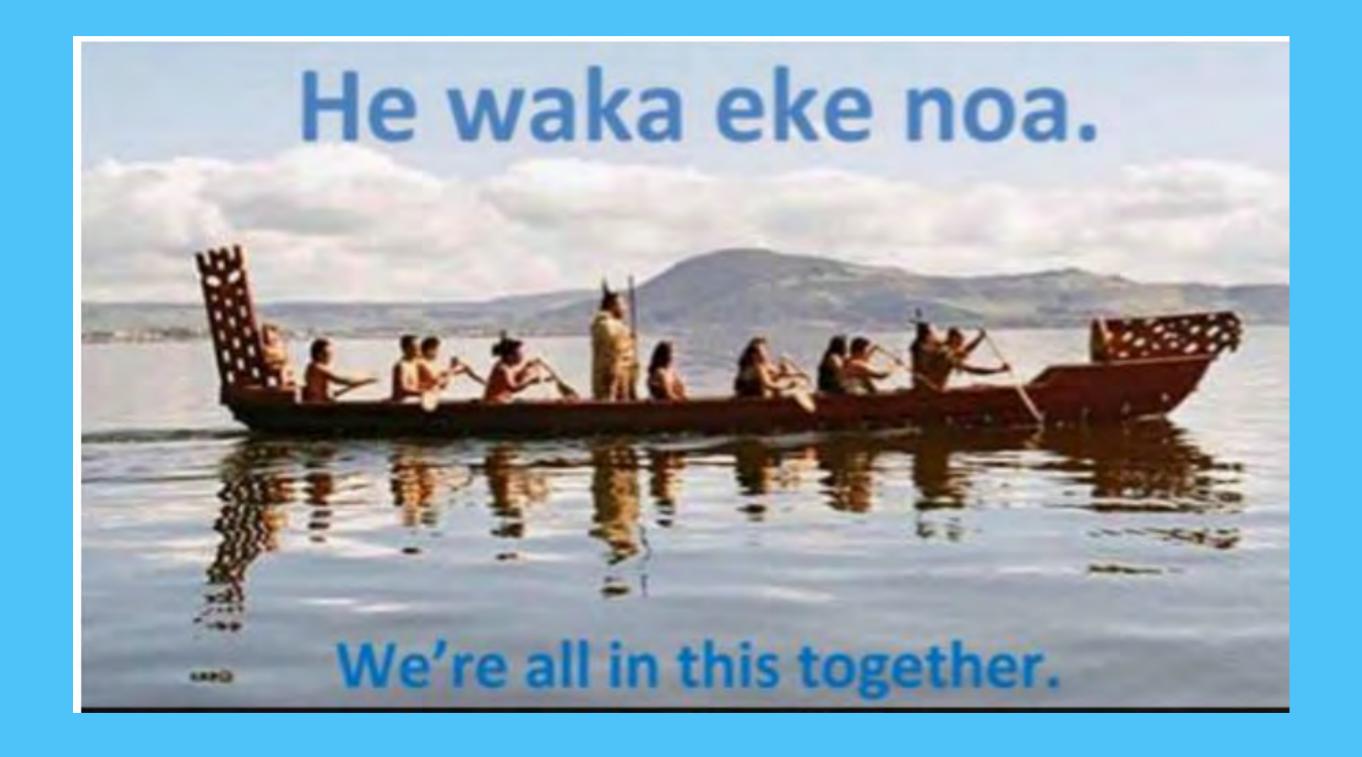

Project Managers Executive Summary

Talharuru Marae is a project that commands a fantastic opportunity for the community involved and is well suited for funders to get behind, with a Resource Consent in hand and a budget in place we look forward to assisting with securing capital to bring to life the reality of what has been proposed.

The Marae project has had a couple of false starts with previous consents and multiple drawing revisions, unfortunately this has resulted in additional time and expenditure, but not without unnecessary progress.

The design that has been decided on, attached within, has been done so in conjunction with the marae committee representatives and necessary changes have been made for the benefit of the project, changes include but are not limited too:

- New location of Marae buildings
- New location and layout of access road
- Increased parking
- Revised parking and turning layout

These changes were proposed, at the sacrifice of additional time due to:

- Resource Consent Approval The new design, under the guidance of professionals provides
 a far more likely approval rating form the council, with likelihood of less amendments being
 required through consultation.
- Construction Cost The revised roading layout, utilizing the existing access road and making improvements significantly reduces the required earthworks and therefore cost of construction.
- Parking Layout with tweaks to the number of parks along with a proposed bus route, the size of the car park has been reduced compared to council requirements, reducing cost of construction and increase in the likelihood of success.

Through design and construction of the preliminary budget, consideration has been placed on the requirement to phase the construction in line with funding milestones and capital availability.



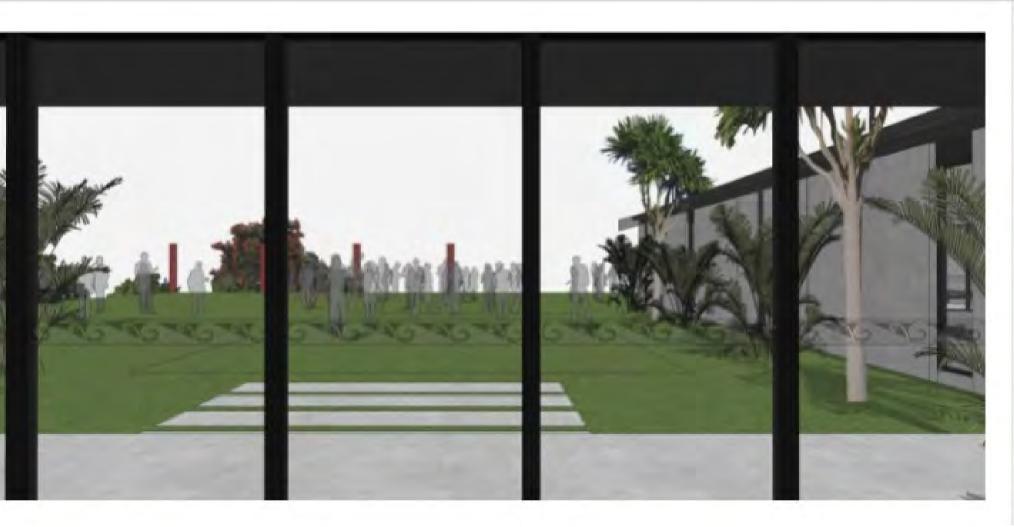
