#### **Purpose**

- f) the power to delegate any of its powers to any joint committee established for any relevant purpose under clause 32, Schedule 7 of the Local Government Act 2002.

- ii. The powers Council is expressly prohibited from delegating as outlined in Clause 32(1)(a)-(h) of Schedule 7 of the Local Government Act 2002; being:

  - the power to make a bylaw
  - the power to borrow money, or purchase or dispose of assets, other than in accordance with the long-term plan
  - the power to adopt a long-term plan, annual plan or annual report
  - the power to appoint a chief executive the power to adopt policies required to be adopted and consulted on under the Local Government 2002 in association with the long-term plan or developed for the purpose of the local governance statement
  - the power to adopt a remuneration and employment policy.

## 4.1 Infrastructure Looking Forward – May 2024

## 1 Purpose / Te Kaupapa

To provide Elected Members with visibility of upcoming approvals, events and gateways in Infrastructure. This includes approvals that will be completed under delegation.

## 2 Recommendation / Whakataunga

That the Committee notes the Infrastructure Looking Forward Paper for May 2024.

## 3 Business Cases / Scoping

**Punaruku Flood Mitigation** – Hapu Committee have led the development of a Business Case which is now costed and ready to be adopted by Council for future implementation.

**Wastewater Administration Building** – Council endorsement of the Business Case for the replacement of the current (asbestos affected) building has been completed and is going through internal checks. The scope and engineers estimate have been reviewed in detail so that we can progress with confidence into construction in the next financial year.

## 4 Engagement

Tutakaka Coast Speed Limit – Consultation starting later in May.

## 5 Design & Consenting

#### 5.1 Contract Award

**John Street** – Award of Professional Services to undertake design development. This contract is currently being reviewed by the Chief Executive who has the delegated authority to approve.

#### 6 Construction

#### 6.1 Procurement Plan Approvals

**Roading Emergency Works** – A panel of Contractors and Consultants who will work collaboratively with the Transportation Team to repair the significant slips from the weather events of 2023. Approval of this Procurement Plan will come to Infrastructure Committee next month.

**Roading Maintenance Contracts** – We are developing the new Maintenance Contracts. This will be steered by the Roading Contracts Steering Group attended by the Infrastructure Chair and Deputy Chair. The first step is bringing on board some additional resource to take us through the establishment of the Procurement approach.

Phase 1 – Strategy:

- · Review and define the current industry specification standards and contract models
- Host "right track workshops" with internal staff, elected members, and other stakeholders
- Develop the strategic direction for the next contract model.

The actual Procurement Plan for the Maintenance Contract will come to Council in July.

The Chair of the Infrastructure Committee is seeking ways in which we can enable contractors to commence work in the new financial year prior to NZTA approval of funding. This will give us a head-start on the window of seasonal work that is very weather dependent.

#### 6.2 Contract Award

**Whale Tail Playground** – Evaluation of the procurement included input from schools for this upgrade of the playground at Ngunguru.

**Separable Portion 3 of current Road Maintenance Contracts –** This is the approval of the final year of our current Maintenance Contracts which will come to full Council for approval. There has been substantial effort from the team and our contractors to improve performance as part of the Contract Rejuvenation process. This has been steered by the Roading Contracts Steering Group attended by the Infrastructure Chair and Deputy Chair.

## 6.3 Works commencing

**Kioreroa Road Wastewater** Main - Construction starting in May with Traffic Management in place.

#### 6.4 Completion

**Onerahi and Parua Bay Sports Fields** – Final preparations are being made ahead of the upcoming winter season.

# 5.1 Recommendation to Award CON22093 Whangarei Urban Traffic Calming – Separable Portion 2 Raumanga South

## 1 Purpose / Te Kaupapa

To award Separable Portion 2 of CON22093 Whangarei Urban Traffic Calming to Asset Construction Ltd for a value of \$917,683.49.

## 2 Recommendation / Whakataunga

That the Infrastructure Committee award Separable Portion 2 of contract CON22093 Whangarei Urban Traffic Calming to Asset Construction Ltd, for the tendered sum of \$917,683.49 (nine hundred and seventeen thousand, six hundred and eighty-three dollars and forty nine cents) excluding GST, taking the total award value of the contract to \$3,643,220.53 excluding GST.

## 3 Background / Horopaki

#### **Project Background**

The purpose of the traffic calming projects is to slow speeding traffic on residential streets to improve safety and provide better pedestrian connectivity.

The traffic calming sites have been identified by the community through petitions and complaints to the Council and the highest priority streets with the greatest safety risk which are eligible for Low Cost Low Risk funding or funded through Waka Kotahi's Transport Choices have been included in this contract.

#### **Contract Background**

These works include the construction of traffic calming devices such as raised pedestrian platforms, footpaths with pram crossings, speed cushions and associated work such as road marking, road signs, drainage and streetlighting.

The Contract was procured via open tender in May 2023 and included four separable portions:

- Separable Portion 1: Onerahi (Raurimu Avenue) was awarded on 3 July 2023 for \$622,979.38
- Separable Portion 2: Raumanga South (Tauroa Street, Fairburn Street) this recommendation.

- Separable Portion 3: Raumanga North (Murdoch Crescent) was awarded on 3 July 2023 for \$772,557.66
- Separable Portion 4: Kamo (Clark Road) was awarded on 20 December 2023 for \$1,330,000.00.

The award of Separable Portion 2 (SP2) completes the Raumanga portion of the works which were started under Separable Portion 3.

#### 4 Discussion / Whakawhiti korero

Contract CON22093 was publicly released on TenderLink and GETS websites on 2 May 2023. Tenders closed on 30 May 2023.

Four conforming tenders were received as shown in the table below.

Engineer's Estimate	\$2,357,992.00

These tenders were evaluated using the Lowest Price Conforming Method in accordance with the NZ Transport Agency's Procurement Manual.

Asset Construction Ltd was the winning tenderer with the lowest price and a conforming tender.

The Asset Construction Ltd tender price was 37% higher than the engineer's estimate. A review of their tender price indicated that a substantial amount of this cost increase was due to the concrete construction works and appears to be due to the rapid escalation in concrete costs over the past year. Asset Construction's tender price is deemed to be the current market rate given that three higher priced tenders were received from competent experienced contractors.

#### 4.1 Financial/budget considerations

Separable Portion 2 is funded wholly through Transport Choices and does not require any Council funding.

This is the recommended option. It allows the completion of the works started under Separable Portion 3 and requested by the community and makes the most of the Transport Choices program that is fully funded by NZTA.

Don't Award Separable Portion 2 – Raumanga South

If the Infrastructure Committee chooses not to award the works, the Transport Choices funding for this portion of the package will not be utilised and the community will need to be informed as previous communications had indicated that the works would be going ahead.

Extra costs associated with crane hire and unloading activities incurred due to the delay caused by the Brynderwyn closure. Expenses related to originally intended for the physical works contractor, amounting to \$21,448.23. The increase amounts to \$21,448.23, bringing the new total contract value to \$308,148.49, exclusive of GST.				

CON23063	Contract Award: Phase 3 EW Slips Programme – Investigation & Design – WDC Work Package 1	The contract for CON23063: Phase 3 EW Slips Programme – Investigation & Design – WDC Work Package 1 has been awarded to WSP for \$132,647.00, excluding GST.
		This professional service contract includes investigations, optioneering and detailed design to remediate two priority slip sites in Whangarei. The procurement method involved a Direct Award to WSP, as part of a Regional Procurement Plan, which supports the Emergency Works fully funded by Waka Kotahi. WSP's price is 10% lower than the engineers' estimate, and their offer was deemed competitive and valuable to the council and NTA. The contract value includes a provisional sum (Geotech Investigations) and risk. The total budget remaining for this project is \$147,638, with no local share required for WDC under the Investigation & Design stage.
CON23037	Contract Award: 23/24 Safety Projects	The contract for Separable Portion 1 & 4 of CON23037: 23/24 Safety has been awarded to WM Construction Limited for the tendered sum of \$478,540.58, excluding GST. The scope of work includes intersection improvements at 81 rural road intersections and upgrading an existing raised platform to a new zebra crossing on Vine Street. The total budget for the projects is \$1,705,356.00, with \$101,765.22 already committed. The procurement method was open tender through Tenderlink, with WM Construction offering the lowest conforming tender among four received, below the Engineer's Estimate of \$1,550,000.00.
CON20049	Contract Award: Traffic Counting	The 3-year extension of contract CON20049: NTA Traffic Counting Contract – Kaipara and Whangarei District Council, has been awarded to WSP for \$844,379.85 excluding GST. WSP scored 67 in the latest performance evaluation, indicating performance above the required standard as per NZTA's Z/11 guideline. The contract shows value for money as WSP's bid was significantly below the Engineers Estimate. The contract scope includes various traffic count sites structured around the districts, meeting NZTA's Traffic monitoring for State Highways SM052. Financially, the contract is split between Kaipara District Council (KDC) and Whangarei District Council (WDC), with budgets outlined for each council year by year.

CON23056	Contract Award: Takahiwai Sports Field Lighting Renewal	The contract for CON23056, Takahiwai Sports Field Lighting Renewal, has been awarded to Davco Electrical Services Ltd for \$276,403.00 excluding GST, which includes a risk allowance of \$30,000.00 excluding GST. The project aligns with the Active Recreation & Sport strategy adopted by Whangarei District Council in February 2021 and was included in the 2021 Long Term Plan. The project's budget is \$318,545.45. An open tender process was conducted, resulting in five received tenders. Davco Electrical Services Ltd emerged as the successful supplier following evaluation using the Price Quality Methodology. The contract price is within the Engineers Estimate of \$319,700.00 from September 2023.

CON21050 Contract Variation: Professional Services Lovers Lane Bridge Replacement		The total contract amount of CON21050 for Professional Services for Lovers Lane Bridge Replacement has been increased by \$69,770.77 to \$362,010.77 excluding GST. This contract, awarded to Hawthorn Geddes Engineers and Architects Limited after an open tender process, initially valued at \$292,240.00 excluding GST, necessitates additional work due to various factors. These include integrating landing areas and lighting with adjacent projects, extended construction periods, consenting requirements, crane access amendments, and pending final inspection tasks. The variation costs are broken down into landing area and path linkage with lighting, extended construction period, crane access and bridge delivery access ramp, and estimated completion of all contract deliverables. Financially, savings from the CANAM construction contract for Lovers Lane Bridge are expected to cover this variation, remaining within the total project budget.
CON23026	Contract Award: Kamo Reservoir Additional Capacity – Physical Works	The contract for CON23026 for Kamo Reservoir Additional Capacity – Physical Works has been awarded to Steve Bowling Contracting Limited for the tendered sum of \$5,654,616.57 excluding GST. A contingency of \$678,554.00 excluding GST has been recommended to increase the contract value up to \$6,333,170.57 excluding GST if required.

The contract value for Precast Box Culvert Supply for CON21039 Mangapai Road Culvert No 133 Replacement be increased by \$21,448.23 (Twenty-one thousand, four hundred and forty-eight dollars and twenty-three cents) to a total new contract value of \$308,148.49 (Three hundred eight thousand, one hundred forty-eight dollars and forty-nine cents) excluding GST.

#### **Contract Scope**

The contract is for the supply of precast concrete box culvert units and associated components that are intended to be used in replacement of an existing culvert at Mangapai Road.

#### **Contract Variation Detail**

**VO 1** – Extra and over rate for delivery and unloading to WDC's Salesyard Road storage yard.

The Mangapai culvert replacement work was programmed to be delivered in the 2023/24 FY. Waka Kotahi subsequently introduced the Brynderwyn closure and despite best efforts it was not possible to start prior the Brynderwyn closure.

Culvert units were procured separately and in advance of the construction contract to reduce timeframes and on-costs from the Contractor. The original contract scope allowed for the culverts to be delivered directly to the Mangapai Road site. We have now had to securely store the culvert units

at the WDC Salesyard Road storage yard, ready once construction commences in early spring on the 2024/25 FY.

Noting there is no cost associated with storage as this yard is owned by WDC.

A provisional sum (VO 1) for delivery to WDC's Salesyard Road storage yard was included in the original Tender schedule, allowing the supplier to price this item in case the delivery to WDC's Salesyard Road storage yard was required (see attached HUMES Form of tender Item 1.1 for its rate). This extra over is specifically for the crane hire and unloading activities originally planned to be undertaken by the physical works contractor if the culverts were delivered to site. This is a lump sum item, so specific costings of individual items are unknown.

#### **Procurement Method**

A Regional Procurement Plan for Stage 1 of the Emergency Works Slips Site Investigations & Design approved by council Chief Executives and Waka Kotahi supports the Direct Award of six packages of work to six pre-qualified suppliers.

WSP is one of these suppliers and WDC Package 1 (this approval), is one of the six packages.

WSP have provided a price and Offer of Service. NTA is happy that the package provides value to the council and NTA. NTA have had the benefit of six tenders across Northland of the same nature and scale to compare, thus providing assurance of the market level for these services.

WSP's price is 10% lower than the engineers estimate for these sites, where in this instance the EWA was also completed by WSP through the initial Emergency Works Assessments (EWA).

Engineers' estimates have informed the budgets and were completed through an Emergency Works Assessment (EWA) process that WSP carried out across all EW slip sites in Northland. The goal of the EWA was to take a systematic and consistent approach that included a simple visual inspection, three options to remediate each site and a recommended option, along with high-level estimates for each. These have guided funding forecasts for NTA and NZTA across Northland. NZTA accepts that there will be changes and is comfortable for NTA to continue work and adjust funding as appropriate. The Emergency Works Programme is meeting with NZTA regularly to keep communication open regarding funding and to avoid any surprises.

There is no local share for WDC under the Investigation & Design stage.

The recommendation is to award WSP their work package as they have provided a thorough and complete Offer of Service that is very competitive relative to the other five proposals received providing value for Whangarei District Council.

The Procurement Plan for the Phase 3 EW Slips Programme dated 13 November 2023 approved a value of \$147,638.00 (One hundred forty-seven thousand, six hundred and thirty-eight dollars and zero cents) for WDC's Stage 1 priority sites. This recommendation has come under this value while still including contingency at a value of \$132,647.00 (One hundred thirty-two thousand, six hundred and forty-seven dollars and zero cents), a difference of \$14,992 (Fourteen thousand, nine hundred and ninety-nine dollars and zero cents).

#### CON23037 Contract Award: 23/24 Safety Projects

#### Chief Executive Approval

The contract for Separable Portion 1 & 4 of CON23037: 23/24 Safety be awarded to WM Construction Limited for the tendered sum of \$478,540.58 (Four hundred and seventy-eight thousand, five hundred and forty dollars and fifty-eight cents) excluding GST.

#### Chief Executive Approval

To award the 3 years extension of contract CON20049: NTA Traffic Counting Contract – Kaipara and Whangarei District Council be awarded to WSP for the tendered sum of <u>\$844,379.85</u> (Eight hundred and forty-four thousand, three hundred and seventy-nine dollars and eighty-five cents) excluding GST.

CON20049 allows for a 3-year extension based on performance. WSP have performed well during the initial period as demonstrated in WSP's latest performance evaluation they scored 67, with a score of 60 and above indicating "performance above the required standard" as per NZTA's Z/11 guideline.

The contract has demonstrated value for money as original contract was tendered by 3 organisations, with WSP coming in significantly below the Engineers Estimate. The extension of this contract is based on the original rates, but with a cost fluctuation adjustment applied, as per NZTA's Procurement Manual.

#### Contract Scope

The Contract is for Kaipara and Whangarei District Council traffic counting programme which is structured around the various catchments within the district. The count sites are split into several types and have the following count frequencies:

Standard Site Counts:

- Monitoring Traffic Count Sites Four times per year
- o Control Traffic Count Sites Twice per year
- o Annual Traffic Count Sites Once per year
- Additional Traffic Count Sites Once every five years
- Holiday Site Counts:
  - o Holiday Traffic Count Sites Once per year
- Pavement Rehab Site Counts on request
- Others on request

The scope of the traffic count is largely based on NZTA's Traffic monitoring for State Highways SM052. The scope of works is appropriate as this is required to provide accurate data and achieve quality results when it's used for pavement designs, traffic delay calcs, etc.

The budget listed above reflects the Long Term Plan and Land Transport Programme submission being put forward for the next 3 years.

#### 2.0 Parks and Recreation

#### CON23056

Contract Award: Takahiwai Sports Field Lighting Renewal

#### Chief Executive Approval

The contract for CON23056, Takahiwai Sports Field Lighting Renewal be awarded to Davco Electrical Services Ltd for the tendered sum of \$276,403.00 (Two hundred and seventy-six thousand, four hundred and three dollars and zero cents) excluding GST which includes a contingency of \$30,000.00 (Thirty thousand dollars and zero cents) excluding GST.

#### Background

In February 2021 Council adopted the Active Recreation & Sport strategy (the Strategy) to provide a high-level direction for WDC on how to meet current and future active recreation and sports facility needs for the District.

Takahiwai lighting replacement is aligned with this strategy and was included in the 2021 long Term Plan.

#### **Financial**

The Takahiwai Lighting project budget is \$318,545.45 (Three hundred and eighteen thousand, five hundred and forty-five dollars and forty-five cents) (PJ-00874-CX-6480)

#### **Procurement Process**

An open tender process was followed with an advert placed on Tenderlink inviting suppliers to tender. The tender opened on 12 January 2024 and closed on 16 February 2024.

#### Tenders Received and Evaluated

Five tenders were received from the following companies:

- Aotea Electrical Ltd.
- Davco Electrical Services Ltd
- Coll Electrical Ltd
- DWH Ltd
- McKay and MGENZ Ltd

The initial shift of qualifying tenders removed DWH Ltd from further evaluation as they had not provided a qualifying SiteWise accredited certificate or any alternative H&S professional body qualification.

The tenders were evaluated using the Price Quality Method Methodology.

The tender evaluation took place on the 26 February 2024 and consisted of the following panel members:

On quality the following scores were recorded following moderation as follows.

## 3.0 Capital Programmes

#### CON21050

Contract Variation: Professional Services Lovers Lane Bridge Replacement

#### Chief Executive Approval

It is recommended that the total contract amount of CON21050 for Professional Services for Lovers Lane Bridge Replacement is increased to by \$69,770.77 (Sixty-nine thousand, seven hundred and seventy dollars and seventy-seven cents) to \$362,010.77 (Three hundred sixty-two thousand, and 10 dollars and seventy-seven cents) excluding GST.

#### **Background**

This contract is for Professional Services for Lovers Lane Bridge Replacement. It was awarded to Hawthorn Geddes Engineers and Architects Limited after an open tender process. The original contract amount was \$292,240.00 excluding GST.

A number of additional pieces of work have been required of the engineer throughout the construction phase for various reasons outlined below.

Landing areas either side of the bridge were originally out of scope but have had to be integrated with designs for works being done at either end. External budget became available for the adjacent Cafler Park boardwalk and path linkage to Second Ave after this contract was awarded, which has required additional work. Additional lighting design had to be done to integrate the bridge lighting with this adjacent project.

The construction period has been longer than originally estimated when the contract was awarded, requiring additional site visits, meetings, and inspections. Additional work and costs were incurred to determine the consenting requirements and obtain approvals for exemptions from WDC and NRC. This has saved on other consenting costs.

The type of crane, access requirements, and methodology for delivery of the crane itself and the bridge structure had to be amended and agreed through the contract implementation. This required the engineer to undertake additional inspections and verification of the crane access ramp behind the library.

In order to get to the end of the contract works there is approximately \$15,000 of work yet to be done for final inspection, as-builts, and producer statement.

All costs have been scrutinised by the project manager and have been assessed as reasonable and necessary. A breakdown of the variation costs is provided in the following table:

The separate CANAM construction contract for Lovers Lane Bridge is currently estimated to come in approximately \$100,000 under the awarded contract value. Those savings will be sufficient to cover the cost of this variation and remain within the total project budget.

Contract Award: Kamo Reservoir Additional Capacity – Physical Works

#### General Manager Approval

It is recommended that the contract for Kamo Reservoir Additional Capacity - Physical Works (CON23026) be awarded to Steve Bowling Contracting Limited for the tendered sum of \$5,654,616.57 (Five million, six hundred and fifty-four thousand, six hundred and sixteen dollars and fifty-seven cents) excluding GST. It is also recommended that contingency management of \$678,554.00 excluding GST be delegated to the Manager Infrastructure Programmes, with associated delegated authority to increase the contract value to a maximum of \$6,333,170.57 (Six million three hundred and thirty-three thousand, one hundred and seventy dollars and fifty-seven cents) excluding GST.

## Background

The Kamo Reservoir is situated at 90 Dip Road, just below the Onoke Scenic Reserve. The site is occupied by two existing water tank structures and associated infrastructure, which supplies potable water to the northern part of Whangarei City, in particular the reservoirs provide water to the fast-growing areas of Tikipunga and Three Mile Bush.

The two existing tank structures include a 4,500m³ concrete tank built in 1963, and a smaller 600m³ concrete tank built in 1941. Historically, the smaller tank served as the sole storage facility in Kamo until the construction of the larger reservoir. In recent years, its utilisation has been limited to periods when the main reservoir tank required dewatering for maintenance and repairs. The older tank has now out lived its useful life and is unable to be satisfactorily maintained It is too small to meet the increased demand, consequently, it is now due for replacement with a new tank of increased capacity.

The Kamo Reservoir Additional Capacity Project is to replace the 'Dip Road Upper Reservoir (600m<sup>3</sup> concrete tank structure outlined above), with a new larger (4,280m<sup>3</sup>) concrete tank, which will be connected to the existing tank, thereby providing a greater water storage capacity for Whangarei City. Additional improvement works for this reservoir site include a new accessway, earthworks, drainage improvements and the construction of a new retaining wall.

#### Financial

The project has spent a total of \$607,219 to date, mainly on investigation, design and consenting costs, with around \$50,000 spent on asbestos removal and site remediation. The remaining budget is \$5,995,617 made up of \$4,075,617 in the current financial year, and \$1,920,000 Year 1 of the draft LTP.

The remaining budget is sufficient to award the contract for the tendered amount and to cover the projected remaining professional fees through the construction period (refer to Table 4 below). This leaves \$221,268 available now for contingency, however it would not be prudent to allocate such a small contingency to a large construction contract with a variety of risks attached as outlined above.

To bridge the potential budget gap of \$457,286 (all in contingency) it is proposed to award the contract and provide delegation to the Manager Infrastructure Programmes to manage the contingency. Prior to confirming the LTP in June 2024, the construction contract will be analysed to determine the remaining risk profile, remaining contract amount, and the contingency remaining necessary to complete the contract works. If any additional budget is required, it will be recommended for addition to this project for the final LTP figures. The alternative is for the project to potentially go over budget in financial year 2024/25.

#### **Procurement Process**

The Procurement Plan for these physical works was approved by the Infrastructure Committee 12 October 2023. The procurement process has followed the approved procurement plan.

#### Delivery model and Supplier Selection Methods

In accordance with the Procurement Plan and Councils Procurement Policy, the Request for Tender for CON23026 Kamo Reservoir Additional Capacity Physical Works (Head Contractor), went to open tender and was advertised on Tenderlink on 30 October 2023 and closed on 8 December 2023.

This was a two-envelope process. Envelope One containing Pre-conditions and non-price attributes was evaluated and scored for each tenderer. Then Envelope Two – Price, was opened and the scores evaluated for each tendered. The total scores are then combined following the formula to determine the preferred supplier.

The supplier selection method used is Price Quality Method (PQM), where the tenderers are scored against a series of pre-conditions, non-price attributes and the price as shown in Table 1 below.

The pre-conditions are assessed on information provided from the tenderers for a specific criterion and scored on a Pass/Fail. A fail score will eliminate the tenderer from further consideration.

The non-price attributes are scored against evidence and information provided from the tenderers on a series of questions to demonstrate value that corresponds to the Supplier Quality Premium (SQP) calculated for quality difference in attribute scores.

The SQP is determined for each tenderer's submission, then deducted from the tenderers price. The lowest adjusted price becomes the preferred supplier.

#### Tenders Received and Evaluated

Four tender responses were received, the tenderers included United Civil Construction Limited (UCCL), Fulton Hogan Limited (FH), HEB Construction Limited (HEB) and Steve Bowling Contracting Limited (SBC).

All tenderers passed the pre-condition criteria and then each option was scored based on the weighted attributes evaluation criteria. The four submissions were evaluated by the Tender Evaluation Team (TET).

The evaluation for pre-conditions and weighted attributes were completed and scored as shown in Table 2 below.

The pricing envelope was then opened and the SQP formula was applied. The lowest scored proposal was then assessed by the TET, and as the proposed methodology had some alternate options for constructing the retaining wall these were provided to the design team for review before a final recommendation could be made.

A meeting with the preferred supplier and design team was held on 7 February 2024 to address these items, and to agree on the best design solution for this project. The design team has confirmed that these methodologies are acceptable, and that any variance on design can be completed post-award. As a result, the project lead has forecast some additional design fees into the contingency to cover these costs should they arise.

The tenderer's proposed prices were entered into the calculation table and the results are shown below in Table 3.

Due to the 30-40% variance on the Engineers Estimate an evaluation of the proposed prices by all tenderers was undertaken to get a better understanding of market costs, the engineers estimate was \$4,378,530 including contingency. The analysis confirmed that the engineers estimate was only a high-level desktop review, and it did not unfortunately reflect current market costs (as shown in the table above "Proposed Prices")

The preferred and recommended supplier is Steve Bowling Contracting Limited at a contract value of \$5,654,616.57 excluding GST. Contingency of 12% or 678,554.00 excluding GST is considered appropriate for this physical works contract due to the higher risk underground works, uncertainty about the adjacent land development and the resulting potential need for an alternate stormwater design solution.

The total expenditure approval recommended is therefore \$6,333,170.57 excluding GST (including 12% contingency). The contingency amount will be held outside the contract and used only as approved by the Manager Infrastructure Programmes under delegation.

#### Contract Risk Analysis

As shown above during the tender evaluation process risks were identified and assessed, these have been outlined below and will need to be managed to minimise impact.

- Earthworks & Cultural Monitoring
  - Cultural workshop was held 21 February with Ngāti Kahu o Torongare to discuss their level of involvement with cultural monitoring during earthworks, totara felling & stormwater works.
- Stormwater Discharge
  - The stormwater has been designed to discharge into the neighbouring property's proposed drainage system, however they have not agreed to this yet as they wanted to wait for a commissioner decision from their Onoke Height Subdivision Hearing. If the Onoke Heights development does not go ahead the stormwater will be redesigned to use the existing outfall.
- Piling Design & Construction Methodology
  - Temporary/Permanent Pile Casings there is a low risk that temporary and/or permanent casings will be required, but should this risk arise an allowance has been made within the contingency to cover the casings, labour, and additional design
  - Shotcrete Reinforcement the contractor has proposed an alternate methodology, which has been endorsed by the design team. This will require more detailed design which can commence post-award. The total costs are unknown and may require the use of contingency. Note that this alternate methodology results in cost savings compared to the original and is already reflected in a reduced contract price.

Hapū have advised that they have a neutral position in relation to this project because the site is already disturbed, and the water reservoirs already exist. However, due to its location above the contentious Onoke Heights development there is an additional risk that the WDC project works may

be confused for the developer commencing works and cause an adverse reaction from hapū members. We will provide additional communications in a best effort to avoid this situation, but it does pose additional risk in terms of delivering this contract smoothly.

The nature of NZS3910 construction contracts is a risk sharing between the client and contractor. Normal practice for simple works is a 10% contingency, while more complex and riskier works should have at least 15% contingency. The proposed 12% contingency recognises that some of the more major risks are resolved during the initial earthworks and retaining wall construction phases, so the risk profile reduces early in the contract.



# **Procurement Activity**

#### **Market Conditions**

Starting to see increased competition in the industry as pipeline of work is starting to reduce in other areas. This is resulting in increased tenders and greater price tension.

We are seeing a lot of movement in personnel within the industry however Contractor capacity to deliver work remains good.

Constraints are largely within the planning phase where hapū capacity is challenging. We are working with mana whenua to work as effectively as possible and ensure that remuneration is not a barrier.

A particular focus this month is reducing the extent of traffic management works within our projects. The opportunity to change the risk profile on projects as part of the movement away from the Code of Practice for Traffic Management (COPTM) is a piece of work that we are developing with CCNZ Northland.

# **Procurement Pipeline**

A draft three-year programme has been issued to the CCNZ Exec. This includes an indicative Procurement Strategy for Professional Services and Physical Works.

The National Infrastructure Pipeline information has been updated in March.

# 6.2 Procurement Strategy Review

# **Executive Summary**

This is the Infrastructure Operations Report for February 2024.

**Health & Safety** – we had one incident on the Kotuitui Whitanga footbridge, where a member of the public was injured. Report has been completed and lessons to be leant in terms of how we plan for changing conditions as part of temporary works will be taken on board.

**Wastewater** – There were no spills during February. Waste & Drainage Contract concludes in November 2024 and Council Paper on options for extension/retendering being prepared.

**Hikurangi Land Drainage Scheme** – New flood gate to be installed at Junction station to improve flood discharge capacity and the possibility of retiring the pocket's pumpstation.

**Laboratory** - Routine sampling and testing continues, no significant issues.

**Water Services** - The dry start to the year is beginning to impact on operations. Staff have been reducing use of the Whau Valley dam and increasing use of other sources to ensure the dam remains at a reasonable level over winter.

**Transport -** End of March signals the conclusion of the sealed pavement season and the onset of preparations for winter conditions. Road maintenance operations have been active in addressing key priorities and challenges. Despite facing difficulties, including safety concerns and budget constraints. Key Achievements:

- Improved Health & Safety Performance: The North Area has shown improvement in Health & Safety performance, with reductions in lag measures such as traffic management audit scores and incidents. This underscores the team's dedication to prioritizing safety amid challenging conditions.
- 2. Refreshed approach to inspections: The North Area team have rephased their inspection delivery schedule to take a more geographic approach in efforts to stream line inspection outputs in the routine works space, which should yield improved response times, and more time on ground rather than "hopping" around the network.
- Completion of Sealing Operations: The South Area has completed the majority of sealing works, marking the end of the traditional construction season. Additionally, the completion of SH1 detour works ahead of the Brynderwyns closure demonstrates successful efforts to maintain essential routes and manage ongoing maintenance levels effectively.

**Solid Waste** – The team have been busy promoting and communicating the national standardisation of kerbside recycling services which came into force on the 1<sup>st</sup> of February. Although the changes for our district were relatively minor there were a number of queries from residents to respond to.

**Parks & Recreation** – March saw the continuation of the aggregate replacement program on our walking tracks after the high loss levels from cyclone Gabrielle. Helicopter operations to drop aggregate on the Western Hills took place and renewals to tracks completed.

Staff are currently developing an internal process around managing applications under the newcoastal erosion policy. Additional resources have been bought on to respond to coastal querries. Work with residents in Whangaumu Bay and One Tree Point, (Karoroa Rd) is ongoing to help develop options for erosion risks to their properties.

# **Employee incidents**

The occupational health exposure occurred when water dripped out from the sealed ceiling at the wastewater treatment plant, where there is known friable asbestos. The risk would have been very low.

# **Contractor incident explanations:**

#### Kotuitui Whitanga Incident

The Worksafe notifiable event, that was also reported in the Northern Advocate, occurred on the Kotuitui Whitanga bridge, which is part of the town basin loop, over the Hatea River. A piece of the 'scrim' attached to the bridge structure, while maintenance work was underway, became suddenly loosened from the attached structure, due to high winds and struck a person walking past.

A full internal investigation has taken place and with agreed actions now finalised (April 24).

The Mayor and several senior staff met with the injured person and family to discuss how this occurred.

<sup>&</sup>lt;sup>1</sup> Scrim is a material used in the construction industry to protect the work from others and attached to structures such as scaffolding.

An industry safety alert will be sent out about considering wind as a hazard in such a situation and a health and safety guideline is to be developed on managing the set up of temporary barriers on walkways, which will be then provided to contractors.

One of the lost time injuries involved a rubbish pick up runner who got a bad cut from something sharp sticking out of a rubbish bag. Another strained his shoulder after repetitive movement of swinging up recycling items.

One contractor near miss incident involved a grinding disk flying off at speed. The expiry date of the disk had not been checked and was out of date. Fortunately, no one was hurt.

Note – not all our contractor's incidents have been received at the time of writing this report.

# Whangarei Wastewater Treatment Plants (WWTP)

In the first week of March there was a spike of 14,489m³ with a corresponding rainfall of 19.3mm. After that the inflow remained steady between 10,000m³ and 12,200m³ per day.




Figure 1: NRC image depicting the percentage of normal rainfall daily average flow in Whangārei WWTP in March 2024

#### Reticulation

There were no spills to waterways in the March 2024 period.

#### **Contractor Performance**

We continue to work with our contractor to ensure that reporting is timely and accurate. This is a work in progress and as a result, the Performance measures have not been updated this month. There are also internal system issues that need to be worked through to allow reporting to be done.

### **Whangārei Wastewater Treatment Plants (WWTP)**

Thickener 1 pumped down and fat chunks removed that were causing a partial blockage. Primary clarifier 1 pumped down and inspected, no issues identified. Slew ring replaced Trickle Filter 4, mercury checked next day. Archimedes screw gearbox mount worked loose now that coupler has been welded, new cable to be ordered so spare gearbox can be installed. RAS pump 1,2 yearly inspection completed, no issues. Blend tank high level alarm failed to activate, Henwood electrical to investigate.

Oakura - Summer peak tank pumped out.

Tutukaka - Tutukaka UV's cleaned.

Waipu - Waipu RIB cleaning completed.

Ngunguru - Ngunguru UVs cleaned.

Ruakaka - Ruakaka wetland 2 filled and rafts installed.

#### Significant Risks and issues

NRC issued an Infringement notice due to smell from milk fermented products received from septic contractors received from Puihoi Cheese, and Fresh Valley. WDC planned to prohibit disposal of these dairy waste products at our plant. However, with huge economic impact to these business' and no other alternative environmentally friendly practices to dispose milk product to land, we have permitted this activity. WDC also updated NRC that odour control project has been awarded and expected completion date in mid 2025



In March we completed the annual compliance report for the Taumata Arowai Water Quality Assurance Rules. We also completed an external Audit of the rules to provide independent confirmation of the results. All areas fully met the rules except for some of the requirements for source water sampling. It appears that there was a scheduling issue at the laboratory which resulted in some sampling being missed. The lab is investigating obtaining some software that is able to schedule the sample runs as well as flagging missed samples to avoid non compliances.

#### Rainfall


Another dry month with only 32mm of rain falling in at the Whau Valley Dam during March. For the first three months of the year, we have had only 97mm of rain compared to an average of 348mm and last year's record total of 1,021mm. The lack of rainfall has seen the Whau Valley Dam drop to 69% by the end of March. This is below the average for the time of year of 81%. Wilsons Dam as finally stopped filling and now sits at 98% full as there is significantly less demand in Bream Bay without the refinery. The long-range forecast for the next few months indicates below normal or below normal rainfall with an El Niño weather pattern beginning to ease. Our groundwater and spring sources remain at good levels but some of the rivers have significantly reduced flows. We remain in a reasonable position as we head into Autumn. However, if the dry weather continues, we may have to consider asking users to voluntarily conserve water sometime in May

As a result of the continuing dry weather there has been steady use of tanker water deliveries during March. The average daily volume of water delivered was 232m, down slightly from 259m3 in February. This equates to an average of 24 loads per day. The busiest filling point was the newly complete site at Kauri which averaged about 9 deliveries per day.

We have also had to deliver water to our treatment plant at Mangapai by tanker as the stream became too low to take water from. So far this year 6 tanker loads have been delivered. However, it does not take much rain for the stream to rise so this is unlikely to continue into winter.

#### **Water Distribution**

Repaired leaks have decreased slightly during March as we head into Autumn. The number of leaks per month for the last year is shown in the graph below.



# 6.4 Key activities in the last month

The subcontractors for this year's main replacements have been appointed and work completed on Jordan Street, Arcus Street and Tauroa Street. Work is underway or planned for Pah Road, Grant Street, Huapai St, Graham St, Chester Ave and Hassard St.

The Kiripaka/Ngunguru Road water main upgrade work is due to be awarded in April. Work started on investigation for Poroti Trunk Main upgrade and Onerahi Trunk Main upgrade.








# Customer requests and feedback



# **Corridor Access Requests (CARs)**

CARs and Temporary Traffic Management (TTM) Applications 209 new Corridor Access Requests were received for works in the road reserve across Whangārei District in March. Electricity works made up 33% of the application. There was a reduction in the number of road construction and maintenance applications from 70 in February to 44 in March making up 20% of CARs. Northpower programmed multiple electrical jobs on Sundays during the month to minimise impact and risks to the public when working on priority roads such as Porowini Road.

Collaboration between the Corridor Access and Events teams in the planning of events ensured that Beach to Basin, Fritter Festival, Taste Whangarei and Northpower Wild Kiwi Run Walk Multisport events were safe and compliant.



There were 192 CAR applications approved in March for work on Whangārei roads.

## Work Completion Notifications, Reinstatement Inspections and Traffic Management Audits

This month there were 74 Corridor Access Request (CAR) completion status updates. 27 excavation sites were set into a two-year warranty period, 17 of those reinstatement inspections were onsite inspections with the remainder updated via desktop review.

5 temporary traffic management audits were completed by the CAR team in March. Of the audits, two worksites scored 'High', one site scored 'Acceptable' and two sites scored 'Needs Improvement'.

A TTM Review Panel was held on 12 March to review unacceptable, unsafe, Stop Work or non-compliant traffic management sites. An Improvement Notice (IN) issued to Downer NZ Ltd initiated a review into quality systems across Downer's temporary traffic management and chipsealing operations. Downer's National traffic management and health and safety teams were pulled in due to a number of Corrective Action Plans (CAPs) being received that did not satisfy Council requirements to give confidence that work on the Whangārei road network would be completed safely and compliantly. A new CAP has been received and looks to address the root causes. The review should lead to close out in April.

#### Other TTM Updates:

TTM Industry Steering Group (TTM-ISG) – The Commercial and Procurement workstream, chaired by Ryan Cooney, NZTA's Programme Director Road Works Safety, met in March to review problem statements and objectives to work toward a strategy for improving traffic management and cost efficiency in contract tender processes and contract documents. Rachael Mannion is also a member of the working group which provides Whangārei with opportunities to develop a national commercial and procurement strategy.

The new TTM training framework is currently out for consultation. With NZTA moving away from the compulsory TTM warrant system and non-compulsory NZQA qualifications being rolled out there is a lot of change in this space. A Q & A Webinar held in March provided some much needed answers to industry on what training will look like in the future and answered questions from RCAs who have been considering not moving to the risk-based approach – in short, it is not an option without Councils taking on the risk.

A temporary traffic management and corridor access newsletter was distributed to Northland contracting and traffic management sectors on 5 March. The focus of the newsletter was on building trust in the public that traffic cones and signs are there for a reason and to only put out what is needed.

Rachel Taylor, NTA Road Corridor Management Lead was a speaker at the annual Roading Infrastructure Management (RIMS) Conference on 14 March presenting on a national transition to a risk-based approach to temporary traffic management (TTM) and RCA Collaboration.

Transport Minister, Simeon Brown was also a speaker at the conference and with the Government Policy Statement (GPS) just released, traffic management was a hot topic. The Minister expressed his commitment to balancing safety and the rollout of the risk-based approach to TTM as quickly as possible. He also expressed the need to get the balance right between the safety benefits and cost imposition. Measuring the cost of

traffic management and making smarter decisions with the likes of the Brynderwyns closure was flagged as a good example of getting in and getting out for more efficient TTM. The messaging NTA CAR team are trying to get out to Whangārei and Northland contracting industry aligns with the Minister when he verbalised his thoughts on excessive TTM - "We're so used to seeing TTM with no

explanation, it reduces the impact to the traveling public because we are so used to seeing road cones everywhere that we don't care about them anymore, which has a safety impact on roadworkers."

Innovations – Chevron Traffic met with CAR team members to discuss their operations and opportunities to set up business in Northland. They are well-established in Auckland and now have a yard in Whangārei. They have been working on reseals with Fulton Hogan bringing more competition to the Northland market. Chevron have been trialling Artificial Intelligence (AI) technology with a camera on the back of the truck that alerts the driver when crew at the back of the truck are not harnessed in. With another big player up here opportunities for innovation are a positive for TTM safety in Northland.

#### **Road Maintenance & Renewals**

As the end of March signals, the conclusion of the sealed pavement season and the onset of preparations for winter conditions, both the North and South Areas of road maintenance operations have been active in addressing key priorities and challenges. Despite facing difficulties, including safety concerns and budget constraints, the teams have demonstrated resilience and commitment to delivering quality work while engaging with the local community.

Key points of note for the month included:

- Improved Health & Safety Performance: The North Area has shown improvement in Health & Safety performance, with reductions in lag measures such as traffic management audit scores and incidents. This underscores the team's dedication to prioritizing safety amid challenging conditions.
- Enhanced RAMM Data Management: The North Area has taken proactive steps to improve RAMM data management, including recruiting additional dedicated resources and providing refreshed training. These efforts signify a commitment to optimizing data-driven decisionmaking and operational efficiency.
- 3. Refreshed approach to inspections: The North Area team have rephased their inspection delivery schedule to take a more geographic approach in efforts to streamline inspection outputs in the routine works space, which should yield improved response times, and more time on ground rather than "hopping" around the network.
- 4. Completion of Sealing Operations: The South Area has completed the majority of sealing works, marking the end of the traditional construction season. Additionally, the completion of SH1 detour works ahead of the Brynderwyns closure demonstrates successful efforts to maintain essential routes and manage ongoing maintenance levels effectively.
- 5. Focus on works completion quality with 153 individual work items audited in March:
  - 14.9% of ordered works items being audited for compliance (59 jobs audited) of which 83.05% passed, and
  - 2.8% of the routine works items being audited for compliance (94 jobs audited) of which 90.43% passed


Despite facing challenges such as budget constraints and changing seasonal priorities, both areas remain focused on delivering quality service to the community and achieving stretch targets in the final quarter. The dedication and proactive approach of the teams bode well for continued success in maintaining road infrastructure and ensuring safe and efficient travel for all road users.

#### **Looking Ahead:**


As the road maintenance teams transition into winter operations for the remainder of the 23/24 FY, key areas for monitoring include operations efficiency, delivery of cyclic spraying and road remarking, as well as the completion of large drainage, unsealed pavement, and seal pavement rehabilitation works. Despite facing a challenging operating and financial environment, the teams remain committed to achieving the best possible outcomes for the road network.

The combined efforts of the South and North Areas reflect a shared commitment to quality in road maintenance, despite encountering various challenges.


# March 2024 Inspection completion overview

#### Phase 2 Delivery

Minor works, less than \$100,000 (generally), per site, low risk, reinstatement of roads to pre-event condition (may require geo-tech assessment to support outcomes). Waka Kotahi funding approval through report applications.

The vast majority of Phase 2 works are completed, and the initial approved funding for Phase 2 recovery activities has been exhausted in line with contractors' initial recovery programmes. There is limited Phase 2 recovery work being reconciled at present. We are working closely with Waka Kotahi through this reconciliation process, providing transparency around funded values and refined contractor estimates and claim values.

#### **Phase 3 Delivery**

The Phase 3 programme is valued at \$12.2m under current engineers estimate, noting these values will be updated following detailed geotechnical investigations. Of the \$12.2m, \$8.6m is in the 'complex' and 'strategic' categories. At this stage a number of sites in these categories may prove to be uneconomic to repair back to previous condition before the weather events.

Investigations and analysis continue the complex sites to determine the remediation method and level of investment required. More information will be available to council in the coming months.

Stage 1 - Contract agreements are being finalised between NTA and consultants for work packages for the Investigation & Design works across five priority slip sites with a 'Recommendation to Award' with WDC for approval currently. The investigations and designs will take approximately 3-4 months to complete.

Stage 1b - A procurement process for the remaining professional services is being developed alongside a strategy for the physical works procurement across Northland (Stage 1/Stage 1b).

An updated funding application has been submitted to Waka Kotahi reconciling previous funding applications with current funding needs as more information is understood about our sites. Staff officers will advise on local share funding requirements as the outcome of site investigations is understood.

It is noted that the Draft LTP 2024 only includes \$2.5m for Phase 3 works. This is because the \$8.6m has not been verified however it will be discussed with Council in the LTP Issues and Options discussion.

#### **Operations**

# Streetlighting

The Streetlight Central Management System (CMS) project – [Contractor - Schreder Australia Pty Ltd]. Of the 2,000 Light Point Controllers (LPC) 1,974 have now been installed and tested. The project is tracking well and is 98.7% complete now.




Figure 1 CMS dashboard

A total of 64 streetlight outages were attended to and rectified in Feb 24 that were identified as part of previous night inspections. The remaining have been attended and rectified by end of March 24.

An annual day inspection for WDC streetlights is being carried out by the contractor and inspections started in Feb 24. This will include pedestrian crossing, arterial, collector & minor roads as well as amenity lighting in the district. This is part of the annual asset condition assessment.


Other streetlighting activities such as joint site inspections for sub-divisions within Whangarei district for streetlight handover and lighting design reviews for new subdivisions and other lighting assessments related to early planning are on-going.

#### **Traffic Signals**

- Rust Ave Rail bridge Over height Warning signal The new detection system is now essentially
  complete and operational, with formal handover and commissioning to be completed by the end of
  April.
- There are ongoing improvement works to the traffic signals network, which include: user operation
  instruction stickers placed in selected CBD locations, together with telecommunications improvements
  which are currently in the planning stage.
- Maintenance works which are ongoing include graffiti removal and pole painting. The new paint system requires warmer temperatures and so further painting will be completed as weather permits.

## **Mechanical Bridges**

- Kotuitui Whitinga bridge H&S incident investigation has completed, the final report will be released once corrective actions are finalised. The project was to address corrosion resulting from paint deterioration.
- Te Matau a Pohe W1 machinery pit: The final design for the engineering controls from Grit Engineering has been received and this will now be reviewed and priced for implementation by our bridge contractor, together with hydraulics refit work.
- Kotuitui Whitinga bridge handrail LED lighting completion is expected mid-May, once the reminder of the ducting installation is completed.
- The CCTV and PA upgrade for Te Matau had been pending for a while. WSP have provided
  the technical specification for the CCTV & PA upgrade RFT and this is being worked on by the
  team for tendering.
- Te Matau a Pohe and Kotuitui Whitinga bridge operations have been continuing. In the month of March 24, Te Matau a Pohe operated 183 times whilst the Kotuitui Whitinga 21 times.







## **Vehicle Crossing Inspections**

The Road Safety Team took over management of Vehicle Crossings in Mid-2023. Over this period Vehicle Crossing Inspections management has been moved from an antiquated paper-based system to a modern and efficient system. Below is a summary of the key improvements implemented.

- Development of comprehensive vehicle crossing inspection guide. Which has led to improved quality assurance, training of staff and understanding of requirements from customers and suppliers. With positive feedback from suppliers and customers.
- Inhouse development of a bespoke Vehicle Crossing Inspection APP. Which has led to a 65% reduction in time taken to complete an audit and the associated paperwork, and improved accuracy of data collection. This APP has now been rolled out for Kaipara District Council.
- Cross-department understanding of Vehicle Crossing requirements with; Customer Service, Property Assessment, Stormwater Engineers, Development Engineers, and Planning teams. The outcome is improved processes and understanding of other requirements which will impact a vehicle crossing permit.
- Closing out all historic Vehicle Crossing Permits (dating back to 2010) that had not had a Final Inspection. All historic Final Inspections were completed by December 2023.






#### **Active Transport**

#### **School Travel Planning**

The School Travel Planning Pilot is now underway. The pilot, and potential future programme, aims to enhance student safety, improve infrastructure around schools, reduce congestion and promote sustainable travel. Partner council are liaising with throughout the pilot include NZ Police, Sport Northland, Enviroschools, Ministry of Education and Ritchies.

Council is working with Onerahi Primary and Whangārei Intermediate this term, and potentially bringing on Whau Valley School in term 2.

To date we have completed a travel survey (identifying how children are travelling to school, and how far they are travelling) and a site audit (reviewing both drop off and pick up from multiple points) at Onerahi Primary, and Whangarei Intermediate, which will help to inform custom maps and travel plans for the school, along with any recommendations to planned infrastructure changes and improvements. The school and school board are heavily involved in developing and reviewing the plans, and the deputy principal has commented "We believe there's a real opportunity to make positive change in our community through this process."



Walk2Work Day, Living Streets Aotearoa's annual pedestrian event, ran on Wed 13 March. Council set up a table with fruit, hot cross buns and refreshments for walkers during the morning commute, supported by Living Streets Aotearoa, WDC Crs Scott McKenzie, Gavin Benney and Nicolas Connop, and the Mayor. The event went well and the team engaged with about 40 to 50 walkers.

Consistent messages heard from walkers were 'please continue to improve footpaths' and to push back more on people parking cars and scooters on the footpaths.

#### **Bike Skills Training**

#### **Speed Management**

Phase 1 of the Whangarei Heads Catchment has been fully implemented which includes new speeds along Whangarei Heads Road from Onerahi to Ocean Beach. The remainder of the Catchment will be implemented over the coming few months. Based on public feedback, staff will be re-evaluating speed limits in Parua Bay Village. This will include limited consultation with the school and surrounding nearby community members. When this evaluation and consultation are complete, staff will bring options to elected members which may include a variation to the current speed management plan. Final approval of any variation will need to be completed by Waka Kotahi. It is anticipated that the investigation and consultation will take approximately four-six weeks to complete.

2024-27 Regional Speed Management Plan – Council have endorsed the draft objectives and three-year implementation plan for consultation which includes the Tutukaka Coast Catchment, Whangarei City and schools, however it has been placed on hold subsequent to the Government announcement on speed limits. An Information Report will be provided to Council in March outlining the current situation and options available to Council.


#### **Road Maintenance & Renewals Contracts**

Fulton Hogans (WDC North Contract) performance score this month is the result of the continued accumulation of 1 primary metric, with 23 out of 29 metrics achieving their target compliance scores including KPM 19 for unsolicited written positive feedback received for watertable restoration works completed on Ngunguru Ford Road.

The main failed metric were KPM20 and KPM25 – noting that KPM25 failure is tied to recurrent failures of any other metric.

The achievement for KPM20, which measures routine response time compliance was 92.11% with a target of 95%.






# Key activities in the last month

#### **Public Tree Maintenance**

A key performance target of the contract is to undertake 80% proactive planned maintenance and 20% reactive and responding to Customer Requests.

March saw Treescape continuing to work on closing open requests and completing proactive work. The more settled weather has seen the reserves start to dry out allowing Treescape to get trucks and chippers onto them without damaging the turf and complete routine maintenance work on the reserves.

Treescape have been updating information within the request system and contacting customers around expected timeframes for the minor works.

#### **Walking Tracks**

March saw the continuation of the aggregate replacement program on our walking tracks after the high loss levels from cyclone Gabrielle. Helicopter operations to drop aggregate on the Western Hills took place and renewals to tracks completed.

Kauri die back track improvements have commenced which will see better protection for the Kauri. This work is funded by central Government Drummond track was be inspected for alternate routes as the original slip face is not stable enough to re-establish a track across. A report with costings for to alternate routes is being prepared. This track remains closed, although a high number of public appear to be still using the track and making their own way across and up the slip face.

#### **Coastal Structures**

Staff are currently developing an internal process around managing applications under the newcoastal erosion policy. Additional resources have been bought on to respond to coastal querries. Work with residents in Whangaumu Bay and One Tree Point, (Karoroa Rd) is ongoing to help develop options for erosion risks to their properties.

#### **Sports Parks**

Drier conditions continued in March with rainfall increasing in the latter part of the month and forecasting for April will see even more rain. The required irrigation at William Fraser Rugby and Football, Otaika and Kensington Trigg Arena ceased in mid-March.

Cricket finals were a success Cobham Oval. All cricket blocks throughout the district have been sprayed out in preparation for Autumn renovations beginning with Kensington.

Initial line marking of senior fields have been completed and all Junior fields to be marked before the end of the school holidays in April.

During the month of March 99 % of fields were open for sporting and recreational play.

The field upgrade has begun at Onerahi Airport B and will continue for the next 4 months. The sports park lighting installation and upgrade to the outdoor courts has also begun at Takahiwai. William Fraser Rugby 2 remained closed as gravel banding was delayed due to lack of maturity of turf now rescheduled for late April.






New field at Parua Bay – image on the right with the new mobile irrigation system


# **Sports Parks Issues**

13 Burials for the Month of March and 56 Cremations.






The team has been busy carrying our annual grounds maintenance like road edging and road cleaning, as the grass growth has slowed allowing for other jobs to be carried out in between burials and cremains interments of which there was 17.

14 families have been contacted regarding their loved one's plots, and the use of the burial plot to create their own personal garden. As it was impacting greatly on the team's ability to carry out their job, the families were

asked to remove their gardens and seats from the current burial area. Most were positive in their response and the area is much improved, making our maintenance and grave preparation much easier and it is now more in line with a lawn cemetery.

#### **Parks and Gardens**

March continued our dry start of the year with only 42 mls falling during the month. Everything is dry, with grass growth slowing down and gardens needing watering. Quite a few younger trees are suffering around the district, with a number dying.

City Care are working through their Autumn tidy up with hedge and shrub trimming underway. There has been an increase in leaf drop as we enter Autumn, resulting in more blowing and clearing in the areas with deciduous trees in the public spaces. The dry weather has continued, and we are still watering areas in the town basin by hand. We are looking at upgrading irrigation systems to reduce the need for hand watering.

Bedding has been completed on the roundabouts, Forum North, the Town basin, Cafler park and the Airport. Bedding was removed from Laurie Hal Park earlier than usual, to give a longer window for weed control, which has helped to reduce down most weeds, but there is significant oxalis still evident in the main beds.

The hanging baskets were removed at the end of the month after a good display all summer. The display at Tikipunga was collected in early due to vandalism.

The Putahi pump house is having issues with its chemical dosing control, resulting in inefficient chemical usage. A new controller has been ordered.

Town Basin and Putahi toilets have received a deep clean, but we are noticing a damp smell setting in in the new disabled toilets by the clock museum. There is no ventilation in that space and with the shower being used frequently the humidity is building up in the room. The utility cupboard in these toilets is not fit for

purpose and we are waiting for the project manager to organise alterations to improve the usability of the cupboard.

We will continue to explore alternative and more robust umbrella sources for the town basin and playground areas as the recent experiment was not positive.

Citycare are making progress to meet contract standards in the gardens area, especially in the city. There are still some issues in the districts. Parks Officers continue to meet with City Care in an effort to get all the garden sites back in specification.
