4.1 Alcohol Control Bylaw - Hearing

Meeting: Whangarei District Council

Date of meeting: 7 November 2024

Reporting officer: Will McNab (Strategic Planner – Bylaws)

1 Purpose / Te Kaupapa

To receive and hear feedback on proposed amendments to the Alcohol Control Bylaw (the Bylaw) and related alcohol bans.

2 Recommendations / Whakataunga

That Council:

1. Receives the feedback on the proposed amendments to the Alcohol Control Bylaw and alcohol ban areas in Attachments 1 and 2;

2. Hears the oral feedback on the proposed Alcohol Control Bylaw and alcohol ban areas from the submitters listed in Attachment 3;

3 Background / Horopaki

Council began reviewing the Alcohol Control Bylaw in late 2023. Early engagement sought feedback on the existing rules and the prevalence of alcohol-related crime and disorder in public places from Police and over 100 organisations including hapū, residents' and ratepayers' associations, Community Safety Network members, Te Whatu Ora/Health New Zealand, sports associations, schools and environmental groups.

Based on this feedback, Council then adopted a Statement of Proposal to consult on amending the Alcohol Control Bylaw and related alcohol ban areas on 29 August 2024.¹

4 Discussion / Whakawhiti korero

Statutory consultation began on 20 September 2024 and closed on 21 October 2024. Council received 70 items of written feedback from the public (Attachments 1 and 2). A total of four people asked to present their views in person to Council. The draft schedule of oral submitters is provided in Attachment 3. Staff will provide the final schedule of confirmed oral

5 Significance and engagement / Te Hira me te Arawhiti

Council has consulted with the community on the proposed Bylaw and alcohol ban areas following the requirements of section 83 of the Local Government Act 2002 (LGA). The community was notified of the consultation via a Council News story published in the Northern Advocate and on social media. The Have Your Say webpage went live on 20 September 2024. Social media posts summarising the proposal and inviting submissions were showed over 14,000 times on Facebook and reached around 10,000 individual user accounts.

Written submissions were invited through multiple channels until 21 October 2024. This hearing fulfils the specific requirement under section 83(1)(d) of the LGA for Council to offer the opportunity for spoken interaction with submitters.

Council is scheduled to deliberate on all feedback received during consultation at the Council meeting on 28 November.

These area bans should be reviewed and reinstated by the community by vote every 5 years. The data are not clear in New Zealand, yet, but international studies have shown that alcohol ban areas have been used in a discriminatory way around the world. They are most likely to be used against racial and ethnic minorities or as an initial point of escalation and/or arrest. In addition, local control bans have been found to be most effective when instituted by the community, and less effective when imposed by a governing body. The Australia Human Rights Commission discusses this in a piece: https://humanrights.gov.au/our-work/chapter-4-human-rights-practice-alcohol-policy Lastly, New Zealand already has laws in place about public inebriation and other anti-social behaviors. These area liquor bans are duplicative and merely give additional powers to police to search someone, even with no other reason.

Tell us more	I strongly oppose the amendment to lift the blanket coastal ban that applies to areas 300m of the low tide mark. If this is to happen, the Onerahi foreshore (in particular, Beach Road) and the Beach Road Reserve and playground, needs a specific 24-hour alcohol ban like that to be put in place at Okara Park, Cobham Oval and beneath Te Matau a Pohe bridge. Given the number of people living in their vehicles in these areas, I am guessing this is a contributing factor which has led to the alcohol ban remaining in these areas. Like these areas, Onerahi foreshore, including the Beach Road Reserve and playground, also has people living in their vehicles here who regularly consume alcohol and engage in antisocial and illegal behaviour. This has worsened since the change in the freedom camping legislation in July 2023. We are also a coastal area, and therefore, should be treated, at the very least, like the other coastal areas with alcohol bans between 7pm - 7am. The agenda from 29 August 2024 shows the Beach Road Reserve did have a proposed alcohol ban for these hours during daylight savings. Here is an acknowledgement for the need for one. I am a resident of Cliff Street, Onerahi. This amendment will mean there is no alcohol ban for the area, though, given what we have experienced over the past year, we need one. The residents here are regularly subjected to the antisocial behaviour of those who consume alcohol. This includes property damage, drink driving, intimidation, domestic violence, arson, sexual activity, drug use, yelling and loud music through the night. Here are some specific examples: On 13/11/23 a male burnt a post on the Onerahi Yacht Club property and intimated club members while consuming alcohol. From this date and for the period of the next three months, he would continually consume alcohol on Beach Road. Early in the morning on 5/12/23 he trespassed onto our property. In mid February 2024, he was eventually trespassed after he was witnessed masturbating. - Around the same time, a female also be

	by people drinking at 8:00am in the morning but that is what happens here. Alcohol use is also said to have played a role in the burning of the scout hall in January. The proposal states alcohol control bylaws are to "address problems of alcohol-related crime and disorder." This is consistently prevalent here where we experience a high level of crime and disorder so why is our area excluded? The impact this has had on our community has been extensively reported to the Whangarei District Council. The Council has had to set up twice-a-day patrols by Amourguard because of it. Why would Beach Road not be included as an alcohol-ban area? The Onerahi foreshore and Beach Road Reserve needs a 24 hour alcohol ban. This should extend the length of Beach Road, inwards of the low tide line for 300m. There is a children's playground and space for families to picnic. These areas should be protected from those who abuse our public spaces with their disorderly and threatening behaviour as a result of alcohol consumption. The residents too deserve to not be subjected to this. I am imploring the Whangārei District Council to protect my community, my family and I who have already suffered enough because of those who consume alcohol in our area.

She has intimidated Amourguard officers, been seen drink driving (December 2023), driving recklessly (November 2023 - ongoing) and broken into the roof of the Onerahi Yacht Club (17/18 July 2024) while consuming alcohol. Her drunken behaviour has kept my family and I up for too many nights. - Approximately 08/01/24, two warning letters were issued by the Whangārei District Council to people who regularly consumed alcohol and engaged in disorderly behaviour in the area. They would join in with the two above and continue to come to the area and drink here present. This group attracted others to also get drunk in our area.

I would suggest our experience would be similar in other beach side communities that would be affected by lifting the existing blanket coastal ban that applies to public places within 300m of the mean low-tide mark. Beach Road is a popular family location used for picnics, exercise, and by freedom campers. We want to keep this a safe, family-friendly area. Currently, large groups can enjoy this space without concerns about a few irresponsible people drinking to excess and causing noise, crime, and disruption. However, we already face issues, particularly from Thursday to Sunday nights, with graffiti, littering, drug use, and anti-social behaviour. I personally pick up bottles, cans, nitrous oxide canisters, point bags and even condoms left behind. Allowing alcohol consumption in this area without restriction would likely worsen the situation. If it becomes known that drinking is permitted so
	close to town, we'll see an increase in these behaviours. We already struggle on weekends with reckless driving, racing, and burnouts (evidenced by the tire marks on the road) and increasing graffiti. Earlier this year, a car and the Scott Hutt was set on fire near Johnson Street,

creating significant concern for public safety.

In addition, there is a community of people who live in their cars along Beach Road, most of whom are quiet and responsible. If this becomes an area where people gather to drink during the day and at night, it will create an unsafe environment for them.

The alcohol ban allows police to intervene early in disruptive behaviour before it escalates. Without it, we will have to wait until the situation gets out of control, making it harder to manage and more dangerous for everyone.

Lifting or reducing the alcohol ban could lead to an increase in drink driving, which is especially dangerous in an area where children and families walk close to the road, often near blind corners, steep cliffs, and narrow one-lane sections. I do not need to list the number of fatalities on the roads from Onerahi out to the Whangarei Heads.

Furthermore, there are plenty of licensed establishments nearby where people can enjoy a drink responsibly in a controlled environment. This helps keep public spaces, like Beach Road, safe and pleasant for families and visitors. It's crucial that we maintain the alcohol ban to preserve the safety, peace, and community spirit of this area for all who use it. Tell us more	I strongly oppose the WDC proposed amendment to lift the blanket coast alcohol ban that applies to areas with 300m of the low tide mark. Should the ban be lifted, the Onerahi foreshore, in particular Beach Road, including the Beach Road Reserve and the playground area, require a 24 hour alcohol ban due to the negative impact alcohol has on this area.
	As a rate paying resident living near the Onerahi reserve and playground area, I can only hope that this amendment is not passed due to the what we have experienced in the passed year. The Onerahi foreshore area has gone from a relatively peaceful area at night to an area where we are frequently (multiple times per week) having to contend with load music, loud voices yelling and swearing, dogs barking, beeping their car's horns and burnouts, while groups of individuals gather to consume alcohol at all times of the day and night. While some of these individuals choose to leave the area afterwards (often drink driving), others remains in the area sleeping in their vehicles only to continue with the same behaviour the next day.
	The groups of individuals who are choosing to overnight in their vehicles is increasing. These individuals are also occupying the parking leaving no parking available to people wanting to use the playground or the elderly who come to the area to relax.
	It is a well documented fact that alcohol consumption is linked with mental health problems and other drug abuse - https://www.otago.ac.nz/news/newsroom/alcohol-causes-more-harm-than-meth-and-other-illegal-drugs-study . This is something which is occurring within our area. As an early morning riser, who exercises before work, I not only have to regularly clean up alcohol containers (beer, RTD, wine), but have also recently (within the last 6 weeks) found the remains of a broken glass "bong" and a homemade bong-like device near the jetty (Beach Road/Mason Street area). I have also previously found tiny plastic zip-lock bags containing a crystalloid substance, which I can only assume to be a drug of some sort. Within the last month I pick-up no less that 10 nitrous oxide (NOS) canisters in one area along the beach front.
	On 25 June 2024 is another incidence where I can attest to the negative affect of alcohol within this area. At 6 am I came across a vehicle parked at the jetty with its doors and boot open and the contents of the vehicle strewn across the road. The owner of the car was passed out and snoring within the car. I believe he could only have been drunk to have not been aware of what had happened. We notified the WDC to come and clean up the area as this was hazardous.
	Your proposed amendment include full or partial bans for other coastal areas,(Waipu, Oakura, Whananaki, Pautua North and South , Matapouri, Langs Beach) which generally are areas where there are predominantly holiday homes. Why is

it that residential coastal areas are excluded? We are the people who have to get up and go to work in the morning after being kept up by noisy, drunken parties on the beach area having kept us awake until 2:30am. I believe that when gathering their data the WDC has failed to canvas local residents and also to consider the impact that the change in the Freedom Camping Laws in 2023 has had on the area. It is noted that there is a proposed 24 hour alcohol ban for the areas such as Cobham Oval and the Te Mautau a Pohe bridge, how come this has not been considered for the Onerahi foreshore. While the council has gathered data from the police and local organisations, has it bothered to gather its own data with regard to the amount of complaints put in by the local residents to the WDC with regard to alcohol related issues? Why is it that there is a proposal for a 24 hour ban in Onerahi along Onerahi Road from Sherwood Road to south of the Onerahi Primary school, however this does not extend to the Raumati School zone or the Onerahi foreshore? Does the WDC think that people only consume alcohol where they buy it and fail to realise that this is easily transportable to areas where people want to party or cause public nuisance. Alcohol is readily available from no less that 2 shops within the Onerahi business area. The WDC is proposing improvements to the children's playground near the toilet block on Beach Road. 	I am a senior community dentist working for the Oral Health Services, Northern Region, Te Whatu Ora. The Oral Health Services provide dental care to children, adolescents and adults in a community dental clinic in Kamo, rural community clinics, dental clinics at Kaitaia and Whangarei Hospital and the Ngawha Corrections Facility. Therefore, I am daily exposed to the harmful affects of alcohol on children, adolescents, adults, families and communities.
	Professor Michael Escudier, Dean of the Faculty of Dental Surgery at The Royal College of Surgeons in 2019, warns that drinking alcohol carries serious oral health risks, including oral cancer, tooth decay, tooth erosion and accidental dental trauma. Alcohol consumption is known to significantly increase the risk of liver disease and this has a 'knock-on' effect for dental treatment. Some commonly prescribed drugs and antibiotics can only be used at lower doses by those who have liver disease – potentially prolonging or reducing the success of dental treatment and, or recovery. Other dental affects of alcohol on people include: increased risk of dental caries and infections, poor oral hygiene and oral health, adversely alter the bacterial symbiosis in the oral cavity and rest of the intestinal system, periodontal disease and osteonecrosis. Some of the indirect affects of alcohol on dental care includes delay seeking dental care, high rate of failed appointments, arrive late for dental appointments and challenging behavior during dental procedures.
	Sir Ian Gilmore, Chair of the Alcohol Health Alliance UK, said: "Alcohol is linked to more than 200 health conditions, including oral health problems such as tooth decay and oral cancer" Also, every year up to 3000 Kiwi babies are born with fetal alcohol spectrum disorder. It's permanent brain damage caused by alcohol exposure in the womb.
	The World Health Organization (WHO) estimates that excessive alcohol consumption is the third largest life style risk factor in the developed world. It is also evident that an excessive intake of alcohol can seriously damage health. Furthermore, alcohol consumption has adverse physical, psychological and social consequences.

Action Point Communities Targeting Alcohol Harm states on their website the following: Casual gatherings are non-specific events where people drink in public places, carrying a high risk of alcohol-related violence, vandalism and public disorders. Alcohol bylaws can be especially useful to restrict this type of drinking and therefore reduce harm. Drinking in public places is associated with significant harm and disorder and is an important setting to take action. Police data in 2007/08 identified public places to be the last place for drinking in 18% of alleged offenders who drank alcohol before their offending (14,838 apprehensions). Almost half (47%) of the alleged offenders were assessed as moderately affected by alcohol and 13% were extremely affected by alcohol at the time of arrest. In other words, around 60% of offenders were assessed at the higher end of intoxication.

There are also significant costs to councils and ratepayers associated with public drinking, due to the costs resulting from litter, vandalism, noise control, animal management and other disorderly behaviour. Cleaning up in CBD areas can come at a considerable cost in some towns and cities.

Alcohol misuse is estimated to cost New Zealand society \$9.1 billion each year. Over half of this 'cost of harm' is attributed to Fetal Alcohol Spectrum Disorder (FASD) (\$4.8 billion), and the rest is due to non-disordered alcohol use (\$3.1 billion), and alcohol use disorder (\$1.2 billion). The overall estimate includes costs resulting from lost productivity and unemployment, alongside justice, health, ACC, welfare costs, etc. Costs of alcohol harm exceed that of other drug harm. Cost to society: It is estimated that, in 2023:

- Alcohol-related harm costs impacted the health system more than other Government sectors, amounting to at least \$766 million in 2023.
- The fiscal cost of incarceration for alcohol-attributable impulsive crime was between \$57,398,022 and \$424,717,521.
- Alcohol-attributable road crashes cost over \$2 billion (of which loss of life & loss of quality of life due to permanent disability were the main contributors).

		Whananaki Beach Residents & Ratepayers Association (WBRRA) would like to formally submit our opposition to the proposed changes to the alcohol laws that would reduce the alcohol bans at Oakura, Whananaki North, Whananaki South, Matapōuri / Whale Bay, and Pataua North and South from 24 hours a day to 7pm to 7am.
		We believe this change would negatively impact the safety, wellbeing, and environment of our communities for the following reasons:
		1. Public Disorder and Unruly Behaviour Prior to the imposition of the 24-hour liquor ban, our community regularly witnessed disruptive behaviour from individuals consuming alcohol in public spaces. There were numerous instances of intoxicated individuals causing disturbances, which disrupted the peaceful and family-friendly environment that our community values. The current 24-hour ban has significantly reduced such behaviour, and we fear that relaxing these restrictions will see a return to these issues.
		2. 		INTRODUCTION
		It is with dismay that Whangaruru South Residents & Ratepayers Association Inc. (WSRRA) recently learnt of the proposed changes to the Alcohol Control Bylaw relating to coastal areas. We were aware that consultation on the Bylaw opened earlier in the year and subsequently the issue was discussed at a WSRRA Committee Meeting around that time. We made a decision not to submit on the Bylaw, as our membership was wholeheartedly in agreement with the status quo, i.e. a blanket ban applying to public places within 300m of the mean low-tide mark for all coastal areas, and specifically the 24 hour, seven day a week alcohol ban as it pertains to Oakura set out in Map 5 - Oakura - within the Alcohol Control Areas addendum to the Bylaw.
		Although I endeavour to regularly visit the WDC website to check on current bylaw consultations and engagement, unfortunately in this instance I failed to do so within the required timeframe and as a consequence, the opportunity to inform our members in sufficient time to allow for a period of meaningful engagement was missed. Instead, I was made aware of the proposed changes purely by chance when a WDC Facebook post on this subject appeared in my timeline the afternoon prior to the closing date for submissions.
		Given this is a significant change proposed for all coastal areas, including Oakura, we feel disappointed that neither our
		Councillors, nor any Council Officer, saw fit to notify WSRRA of the proposed changes. We note on Page 4 of the Statement of Proposal that the review "was informed by Police data of alcohol-related offending over the past three years, historical Police evidence from before the Bylaw was last reviewed in 2018, conversations with key stakeholders and a survey sent out to over 100 local organisations." This Police data and evidence that supposedly supports the review has not been made available to the public to read and analyse. We believe it should be. At no time have we, as a key stakeholder, been in conversation with WDC and don't recall being part of the 100 local organisations that were sent a survey. This is not an acceptable level of engagement. I would also add that the timeframe between publicly making the Statement of Proposal available and the closing date for
		submissions (i.e. four weeks) seems truncated and rushed. The proposed changes are not minor; rather they are consequential and the impact of these changes on residents and visitors to the Bay alike are likely to be far greater and more widespread than can be anticipated.
		That said, when we became aware of the proposed changes, we immediately emailed our membership to let them know and within a 24 hour timeframe, we received an overwhelmingly response, all unanimous in their support of the Bylaw remaining as it currently stands, i.e. a 24 hour, seven

		day a week alcohol ban for all public places on the coast pertaining to Oakura Bay. Members from Ohawini Bay have also confirmed to us that they are strongly opposed to the lifting of the blanket alcohol ban for the coast and are concerned that should the proposed changes be implemented, they are exempted from the protections afforded by the 7pm-7am alcohol ban.
		Accompanying the WDC Facebook post detailing the changes to the Alcohol Control Bylaw is an idyllic photo of a couple enjoying a picnic at the coast, the intent made clear behind the choice of this photo that this couple should be able to enjoy a wine/beer (or two) with their picnic meal at the beach. Although none of us would (or do) object to a degree of responsible drinking occurring, the reality can be somewhat different. Our lived experience is that some within our society will take advantage of the diminished
		protections afforded by the proposed bylaw to partake in alcohol-fuelled, antisocial behaviour that is not conducive to our desire to remain a family-friendly beach. Behaviour that currently occurs infrequently, would become commonplace. In a time of
		diminished policing and a health system in crisis, the changes to the Alcohol Bylaw as it pertains to the Coast feels regressive. We have enough problems with bad behaviour already. Adding alcohol to the mix can only make matters worse, not least being drink driving. After spending the day imbibing alcoholic beverages at the beach, we can only imagine what the repercussions might be when it comes to driving back to Whangarei on our narrow, windy road. We are also mindful of the increased risk to our volunteer First Aid Responders of dealing with any accidents resulting from alcohol. Although I can't speak for others, I can confidently state that I will not attend any incident as a First Aid Responder where alcohol is involved.

		As it currently stands, our members accept that on rare occasions, for example New Year's Eve, excessive drinking will occur on the beach and in the Pohutukawa Reserve. Attempts by local residents to 'educate' others on the alcohol ban are often met with hostility and outright abuse in some instances. Despite hostility, we accept that there is not much that we can do to ameliorate this behaviour. Whilst occurrences of uncontrolled drinking in public spaces are limited and infrequent, residents quietly get on with cleaning up the mess, dispensing with the rubbish, bottles and cans, including glass from broken bottles, to ensure the beach is safe again, in particular for our children. We are of the view that should the current 24 hour alcohol ban be dispensed with in favour of a 12 hour (7pm to 7am) ban, carte blanche will be given to alcohol-fuelled, antisocial behaviour to occur all year round. Enforcing a 12 hour ban after the consumption of alcohol will be more difficult for our members and could potentially give rise to threatening and/or violent behaviour towards members, other residents and visitors to the Bay. With the closure of the Hikurangi Police Station, policing in the area has greatly reduced over recent years and we are mindful that given limited Police resources available and the distance between Oakura and the Whangarei Police Station, it will be impracticable to expect any infringements will be addressed at the time they occur.
		CONCLUSION
		In conclusion, Whangaruru South Residents & Ratepayers Association Inc. membership unreservedly DO NOT endorse the proposed changes as set out in the Statement of Proposal for the coast, namely the lifting of the existing blanket coastal ban that applies to public places within the 300m of
