Purpose

1 Purpose / Te Kaupapa

To provide Elected Members with visibility of upcoming approvals, events and gateways in Infrastructure. This includes approvals that will be completed under delegation.

2 Recommendation / Whakataunga

That the Infrastructure Committee notes the Infrastructure Looking Forward Paper for December 2024.

Next year the Infrastructure Committee will be supported by two General Managers – Waters and Transportation & Community Infrastructure. Sarah Irwin will be the Acting GM Waters. Separate reports will be developed for the two Groups.

3 Business Case / Strategy

Tikipunga Business Case is nearing completion. Stakeholders are on board with the concept and recognise that the fees associated with the level of service will be higher. Fees and charges are being reviewed as part of the Annual Plan.

Local Waters Done Well – consultation on the regulation and funding of regulation is open over December/ January as well as the third bill. Staff will be developing responses where required.

The Parking Strategy and Implementation Plan is being updated and expected to be presented to Council early next year. In the meantime we are looking at implementing some short term wins including free parking for shoppers on the top level of the John Street Carpark during December.

Waka Kotahi have provided further guidance and direction on changes to Traffic Management and Speed Limit Reviews. A paper is being developed which will set out what changes we need to make and how these will be funded and prioritised.

4 Engagement / Events

Engagement on the review of the four Reserve Management Plans has commenced and closes on the 10 January.

5 **Procurement**

The delivery panel for Transport Resilience is being awarded. This will see three contractors for High, Medium and Low risk works being appointed to the panel. Work will then be tendered within this closed panel for works. It is intended that this panel will improve the efficiency of delivery and allow for earlier contractor engagement.

Procurement is underway for Waipu Caves Road Bridge; Poroti Trunkmain Replacement

Other contracts awarded that will commence shortly include Te Matau a Pohe and Kotuitui Whitinga Bridges – Cleaning & Minor Works; Professional Services Oakura Sports Facilities and Wetlands Enhancement; Waikaraka Pipe Bridge; and Springs Flat Box Culvert.

Variation for the Airport location project has been received to support the extended timeframes and delivery of the Cultural Values assessment including additional technical input and engagement.

6 Delivery

The Ruakaka Wastewater team are working at speed to identify short term options for disposal. This includes activating some areas that have been used historically. Once we have a level of confidence in the timeframes, we will be able to consider a more risk based approach to approving land use consents.

The Future Airport Protection project is going well with the Cultural Values Assessment underway. A paper will be coming to Council in the new year to provide feedback on the findings of the multi-criteria assessment.

Parua Bay Infiltration and Inflow (I&I) study is underway.

Finance and Infrastructure continue to work closely together to minimise carry forwards and improve the efficiency of how we deliver the programme. A paper will be coming to Council in December to seek new delegations which allow for budgets to be managed more effectively.

5.1 Contract extension & variation CON21034 Community Road Safety Promotion Activity Services

1 Purpose / Te Kaupapa

To seek approval for the extension of Contract 21034 for Community Road Safety Promotion Activity Services for the 2024-2027 Long Term Plan (LTP) period.

2 Recommendation/s / Whakataunga

That the Committee:

- 1. Approves a 3-year extension to contract CON 21034 Community Road Safety Promotion Activity Services; and
- 2. Approves an increase in total contract value to \$4,173,968 (four million one hundred seventy-three thousand nine hundred sixty-eight dollars) excluding GST.

3 Background / Horopaki

Contract 21034 – Community Road Safety Promotion Activity Services was awarded to the Northland Road Safety Trust (Trust) in July 2021 for the promotion of road safety activities over three years from 01 July 2021 to 30 June 2024. The original contact term was for three years with a possible two-year extension, and a further one-year extension (i.e. maximum six years) based on performance (PACE score).

The total contract value is \$2,283,968 spread evenly over the 3-year period for 2021-24. This is a joint contract between Whangarei District Council (WDC) and Kaipara District Council (KDC), with WDC managing the contract and invoicing KDC for their share monthly.

The Trust have been delivering Road Safety Education in the Whangarei and Kaipara districts since 1995. Over this time, they have successfully delivered a variety of safety campaigns as well as providing driver licensing courses, impaired driving course to support recidivous offenders, child seat installation and checks and community events highlighting the risks of unsafe driving behaviours.

The Road Safety Promotion Activity programme is guided by the Northland Regional Road Safety Action Plan (RSAP) prepared each year in collaboration with NZ Police, NZTA, ACC, Road Controlling Authorities (NZTA and Councils), and other key stakeholders to support key safety messages and education programmes. The programme aims to influence road user

behaviour, support enforcement and to ensure alignment of messaging across the sector with a focussed effort on key areas of concern and emerging issues of public concern.

4 Discussion / Whakawhiti kōrero

Council has the following three options -

Option 1 – Extend the contract for three years (preferred)

Option 2 - Extend the contract for two years (as per the Contract conditions), or

Option 3 – Retender the contract

The current Contract allows for a two year extension to be awarded based on meeting performance conditions. Approval is being sought to extend contract 21034 for a further three years to include the current 2024-2027 financial years with a completion date of 30 June 2027. Providing the three-year extension will make provision for the Trust to continue to deliver Road safety Promotion activities within existing approved budgets.

Extending the contract for three years is considered best value for money for Council and ensures that Road Safe Northland Trust and their key suppliers can resource the provisions for Whangarei and Kaipara districts. Noting that most of the suppliers are voluntary or not for profit organisations that rely on grants and fundraising to ensure these activities and services can continue to be provided for our community. When the contract went to tender, the Northland Road Safety Trust were the only providers to submit a tender as this work is unique and the Trust have built up a comprehensive group of suppliers to support them in delivering better outcomes for communities in Whangarei and Kaipara.

The contract extension has been delayed due to funding confirmation being late from NZTA, however, the Trust has continued to deliver key programmes utilising a combination of their own reserves and funding from Council through purchase orders through this transition period.

The Contract will be retendered in mid-late 2026 to enable commencement in the 2027-28 financial year.

Staff have reviewed the performance of the Trust using NZTA non-engineering consultants PACE scoring method. The Trust PACE scores are on average 71% to 85%, which rates them as exceeding requirements.

4.1 Financial/budget considerations

This is an activity that is subsidised by New Zealand Transport Agency Waka Kotahi (NZTA) with a financial assistance rate of 53% for WDC and 62% for KDC. NZTA only funded part of the bids from each Council. The breakdown for each funding partner is tables below.

Approval is sought for a variation of \$1,890,000.00 (one million eight hundred ninety thousand dollars) excluding GST to Contract 21034 for Community Road Safety Promotion Activity Services for the 2024-27 financial years. Increasing the contract value from \$2,283,968 (two million two hundred eighty-three thousand nine hundred sixty-eight dollars) to \$4,173,968 (four million one hundred seventy-three thousand nine hundred sixty-eight dollars) excluding GST. No additional funding is required to facilitate this contract variation.

Table 1 below summarises the funding from each funding partner.

Kaipara District Council Staff will formally confirm the funding for Road Safety Education activities at their Council meeting on the 27th of November. The funding above is based on the amount sought by staff based on the Kaipara District Council LTP bid. This is the maximum that Kaipara will contribute towards Road Safety Education, if Kaipara District Council resolve a lesser amount, the contract sum will be adjusted accordingly.

Table 2 below summarises the total additional funding per financial year.

4.2 Options

Council has the following three options -

- Option 1 Extend the contract for three years (preferred)
- Option 2 Extend the contract for two years, or
- Option 3 Retender the contract

Staff recommend that the Council approves the 3-year extension to Contract 21034 with the Northland Road Safety Trust for \$1,890,000 with the completion date of 30 June 2027.

4.3 Risks

By extending the current contract term there is a continuation of services from an established provider with a network of local educators who are embedded in the community. Declining the contract extension would result in a gap of road safety services resulting in a risk of losing the local provider network.

There is a risk that KDC do not support their funding allocation. However the contract is subject to funding being available and therefore this can be managed at an operational level.

Background / Horopaki

5.1 Litter Control and CBD Custodial Contract Extension

That the Infrastructure Committee approves a 12 month contract extension with Green by Nature from 1 October 2024 to 31 September 2025 of Contract CON19021 for Litter Control and CBD Custodial Duties.

Staff have now completed negotiations and are requesting an approval to increase Contract Value.

Discussion / Whakawhiti kōrero

Council officers and Green by Nature developed a 12-month proposal for the delivery of services which we anticipate will meet community needs but also reduce costs to the ratepayer.

Proposed changes for the contract extension:

- Removing litter bins where it is known they are seldom used
- Increasing service in CBD
- Increasing street furniture cleaning
- Increasing shared paths cleaning
- A more efficient delivery of graffiti control
- Align graffiti control with CON19021 contract for greater savings

The net savings to Council for 12 months is \$48,000

Council officers recommended to extend the current contract for 12 months before tendering a longer-term contract with variations to allow Council to explore different ways of delivering the service whilst exploring best value to Council and the rate payer.

The variation of CON19021 for \$788,201 requires the Infrastructure Committee approval as the variation takes the total contract from \$3,384,845.60 to \$4,173,046.60 (excluding GST) which is beyond the Chief Executive's delegated authority.

1.1 Financial/budget considerations

Parks and Recreation Litter Control cost centre has an External Contractors budget of \$864,000 (2024/25 budget) and \$883,007 (LTP year 2 budget, used as basis for 2025/26 Annual Plan) available to cover this contract over the 12 month period 1 October 2024 to 30 September 2025.

The variation amount to be approved is \$788,201 which is within the budget spanning the last nine months of the 2024/25 financial year and first three months of the 2025/26 financial year.

1.2 Policy and planning implications

There are no planning or policy implications

1.3 Options

No options have been considered as the Infrastructure Committee has approved the contract extension.

1.4 Risks

Not approving the contract variation will result in Council unable to pay the contractor for services resulting in non-delivery of the services.

5.1 Litter Control and CBD Custodial Contract Extension

1 Purpose / Te Kaupapa

The purpose of this report is to seek approval for a 12 month extension to Contract 19021 with Green by Nature for Litter Control and CBD Custodial Duties

2 Recommendations / Whakataunga

That the Infrastructure Committee:

1. Approves a 12 month contract extension with Green by Nature from 1 October 2024 to 31 September 2025 of Contract CON19021 for Litter Control and CBD Custodial Duties

3 Background / Horopaki

Green by Nature (formerly Recreation Services) successfully tendered for the existing Litter Control and CBD Custodial Duties contract CON19021 for the term 1 July 2019 to 30 June 2024.

The contract value over the 5 year period of the existing contract was approximately \$3.6m.

The contract with Green by Nature expired 31 July 2024. A procurement strategy was developed which would have seen this contract terminated and the services redistributed amongst other contracts. However, during the development of the Roading Maintenance Contracts Procurement Strategy it has become clear that there is benefit in waiting until these contracts – which includes a Central Contract – are let before redistributing tasks.

Council officers would like to negotiate a 12 month extension to the contract to allow for a continuity of service and to allow time to explore alternative ways of delivering services efficiently. Beyond the 12 month extension it is intended the contract will go to tender or be consumed (in full or in part) within the Roading Maintenance and other contracts.

4 Discussion / Whakawhiti kōrero

The contract CON19021 Litter Control and CBD Custodial Duties includes the following services to Council:

- servicing of all the litter bins in the city (approx. 355 bins)
- picking up loose litter within CBD and suburban shopping centres

- sweeping and scrubbing of the CBD
- street furniture cleaning
- cleaning the Rathbone St and Rose St public toilets
- removal of fly tipping from across the district
- roadside litter collection

The contract budget in 2023/24 was \$745,000.

Council officers seek to extend the current contract for 12 months before tendering a longerterm contract to allow Council to explore different ways of delivering the service whilst exploring best value to Council and the rate payer. In addition, a number of changes to the CBD environment are happening which requires time to properly scope such as the Civic Centre environment.

To this end Council officers and Green by Nature have worked up a 12 month proposal for the delivery of services which we anticipate will meet community needs but also reduce costs to the ratepayer.

Proposed changes for the contract extension:

- Removing litter bins where it is known they are seldom used
- Increasing services in CBD
- Increasing street furniture cleaning
- Increasing shared paths cleaning
- A more efficient delivery of graffiti control
- Align graffiti control with CON19021 contract for greater savings

The net savings to Council for 12 months is \$48,000.

The current contract with Green by Nature expired on the 31st July 2024. Green by Nature are currently delivering the services of the existing contract on a month by month basis. Green by Nature have performed well in delivering on the requirements on CON19021 over the past 5 years. They know the contract very well and what is required to deliver the required services. The experience Green by Nature brings will allow Council to adapt its services, over the next 12 months, in a trial looking for best value for money before tendering for a longer term contract.

4.1 Financial/budget considerations

The existing contract CON19021 had a contract value of approximately \$3.6m over the 5 years.

The 2023/24 budget for the contract was \$745,000 and a separate contract for Graffiti removal for \$90,000. Rationalising services and developing efficiencies is anticipated to net a \$48,000 savings in 2024/25.

4.3 Options

The following options are present:

1. Do not award contract extension

Not awarding a contract extension will result in Council officers negotiating with the contractor to deliver services on a month to month basis. This provides little security for the contractor and Council. This is also not best practice.

2. Award 12 month extension to Green by Nature

Awarding a 12 month contract allows for continuity of service and for Council to implement proposed changes with an experienced contractor on a trial basis. The information gained from this trial will shape the scope for the tendering of this contract in 2025.

4.4 Risks

Given Green by Nature have delivered these services of CON 19021 for the past 5 years and Council officers are confident they are qualified and suited to delivering a 12-month extension.

There is a risk that some community members may complain about rubbish bins being removed however this risk is considered low given the infrequent use of the bins to be removed. Feedback will be used to determine service levels going forward.

Not awarding a contract extension will result in Council officers negotiating service levels with a supplier on a month by month basis which puts the service delivery at risk.

A contract extension with Green by Nature mitigates a number of risks by ensuring continuity of service and the ability to explore new ways of delivering the service to provide best value to Council.

1 Purpose / Te Kaupapa

To inform Elected Members of the response to a Petition received from Kensington business owners to change parking in Davies Street and Kamo Road.

2 Recommendation/s / Whakataunga

That the Committee:

- 1. Receives the petition and
 - a. Confirms no changes to the existing parking on Kamo Rd
 - b. Confirms no changes to the existing parking on Davies St
 - c. Instructs staff to consult with business owners in Kensington regarding the introduction of time restricted parking
 - d. Instructs staff to advise the petition organiser of this course of action.

3 Background / Horopaki

The Kamo/Kensington/Nixon Intersection was upgraded back in 2016. This project was undertaken to improve the safety and capacity of the intersection. It involved increasing the number of lanes at the intersection, 4-laning Nixon St and realigning the Kensington Ave leg of the intersection.

As a result of this project approximately 20m of parking in front of the Adriatic Fisheries/Kensington Refrigeration was relocated. This parking relocation was to enable the two northbound lanes on Kamo Rd to be extended (to improve the capacity of this leg of the intersection). This was discussed with the local businesses at the time, and the bus stop was moved further south, and the existing parking was also relocated further south as a result of these discussions. (**see attachment 1**)

The petition received also requests Council to alter the parking arrangements on Davies Street from the existing parallel parking to angled parking to provide more parking for the Kamo Road businesses due to the parking that was relocated as part of the project described above.

4 Discussion / Whakawhiti kōrero

Reinstatement of Kamo Road parking - This option has been investigated but has been determined not viable as it detrimentally effects the function of the left turn lane, and the stacking capabilities from the traffic lights.

Angled parking on Davies Street - Davies Street is approximately 10m wide with existing parallel parking on both sides of the road. Davies Street is too narrow to provide angled parking, as this would only be able to be provided on one side of the road, and Davies Street would have to be made into a one way system street to enable this if parking were to remain on the opposite side. It was also concluded this would not increase the parking availability as you would lose parking on one side of the road for it to remain a bi-directional street. (see Attachment 2).

Parking Demand - Surrounding streets such as Henry Street have wide carriageways with parking available on both sides therefore it has been concluded that there is sufficient parking within these streets to cater for the increased parking demand in the Kensington Business Area. (see Attachment 3).

All of the roadside parking in the Kensington Business area is currently "all day" parking. One of the concerns raised is the lack of short term parking availability for the business's customers. Staff will approach the business community to see if there is any interest in the introduction of time restricted parking in certain areas to address the short term parking shortfall.





Key risks to delivery

• Poor or missing asset condition/performance information leads to redesign or scoping in the execution phase. Examples of this include Parua Bay where the piping arrangements into and out of the storage tank were re-surveyed as part of the design process and found to differ from the as-built drawings we hold on file. Furthermore, asset data in the form of flow information, level sensors, and volumes at pump station storage chambers is either missing, not easily accessible, or contrary to what is on site. This makes it difficult to calibrate the wastewater model with a high degree of confidence for planning purposes. Additionally spill volumes from this chamber were not known until a flow meter was installed. Another recent example is at 31 Hatea Drive where our GIS information showed a wastewater line as 300mm dia. whereas CCTV survey of the pipe subsequently confirmed this to be 525mm dia. This discrepancy will have a significant effect on the wastewater model accuracy. An increased focus on asset information is being applied with a proposal being developed by the team.

- Wastewater Scope development There is a lot of work to be done to develop the right response to capacity constraints in our wastewater system. Focus is on increasing resources and ringfencing those resources on these areas.
- **Project delivery team capacity constraints will slow down delivery**. Additional consultant project managers have been brought in and critical support resource (engagement, project controls, administration) are being brought on through external contractors.



Reporting Structure

Investment Management Framework




Figure 1: NRC image depicting the percentage of normal rainfall daily average flow in Whangarei WWTP in Oct 2024

The Investment Management Framework (IMF) replaces the previous Project Management Framework from 1 July 2024. The overarching IMF phases are shown in Figure 1, and the construction sub-phases are shown in Figure 2.

The new IMF has more emphasis on strategic alignment and Business Cases so that whole of life costs, risk and procurement strategy is considered earlier in the process.

The IMF will be further supported with the implementation of a Project Lifecycle Management (PLM) System in early 2025 that will enable enhanced reporting of project performance.




Across the Portfolios, there are a number of Programmes consist of groupings of projects that have a common set of measurable strategic objectives, integration requirements, or common funding and reporting structures. This includes the Northern Growth Area and Blue Green Network.





Delivery against Capital Programme

At the end of October delivery against the forecast capital programme was below budget. This is largely due to the budget being phased equally over 12 months rather than reflecting the increased investment during the construction season (roughly October to March).



Major projects and programmes of renewals are progressing at pace including Kioreroa Road Wastewater Renewal, Kioreroa Road Wastewater Odour Control, Dip Road Reservoir, Three Mile Bush Reservoir and Road Rehabilitation programmes.

Of the \$120m capital programme in Infrastructure

- \$70.2m is in implementation or being delivered through maintenance contracts
- \$28.5m is being developed but still to be awarded
- \$10.9m is likely to be carried forward (only circa \$7m currently being forecast)

Offsets against the carry forwards include Kepa Road (\$6m) which is under construction.

A proportion of the Transportation budget reflects NZTA Subsidy that is not available.

The RAG status of the Kamo Priority Lane is Red as it is going to Council to seek additional funds through the reallocation of Roading Budget.

Section 1 (bottom of Bank to 96 Kamo Road) has started on site in the first week of November. There is little residual risk (budget and programme) for this construction project now it has been awarded

A Council Paper will be coming to Council in the new year to seek legislative powers to enforce the priority lane as well as an increase in the Regulatory Contract to enable the enforcement. It is noted that the financial costs of enforcement are at worse cost neutral as enforcement fees are likely to exceed costs.



Infrastructure Acceleration Fund

Projects that unlock future housing areas, partly funded via Kainga Ora through the Infrastructure Acceleration Fund.

Funding for the Springs Flat project has been approved by Kainga Ora. This project is broken into three separate projects as detailed in the table below.

All projects are in design and progress to construction is dependent on confirmation in the wider Tikipunga Growth Infrastructure Response Plan.

Although a twelve-month extension of time for this element of the project has been negotiated with Kainga Ora, RAG status was amber due to the need to align with Council decision making, consent timeframes.

RAG status is currently RED as additional funding is required to be confirmed by Council in the reallocation of funding. There is also a need for Council to approve the Contract Award.

The detailed design is approximately 95% complete and the resource consent applications are currently being processed by NRC and WDC. Consultation has been undertaken with the local community with drop-in sessions held on the 10th and 17th October.

Quotes for the manufacture of the box culverts that are required for the roundabout have been received and a recommendation for award is being processed. Noted that if the project did not go ahead, then the culverts would be used for other projects.

Quotes for relocating two houses have also been received, and opportunities for moving these onto surplus land for resale are being investigated. The first house removal may occur in the next two months.

Flood mitigation has confirmed that the project has no impact on existing flood levels. Clearing of the stream below the State Highway culvert is being undertaken to reduce the current flooding on Springs Flat Rd.

The purchase of three properties has been completed. Another partial property purchase was approved at the October Council meeting and will be settled in November. Further land negotiations are ongoing.



Application to extend the directive date for Whau Valley, Ruddells, Ruakaka and Ahuroa Water Treatment Plants to the end of March 2025 has been approved by the Director General of Health. To comply with this timeframe fluoride would need to be added to water supplies from end of February 2025.

This is the Infrastructure Operations Report for October 2024.

Health & Safety – another relatively quiet month in health and safety. Contractor safety location hazards are being entered into our health and safety software.

Wastewater – Upgrade work continues at Hikurangi WWTP while an additional 3 weeks of sampling will be done at Ruakaka WWTP to check for any negative environmental impacts, following erports of elevated ammonia levels at sampling bores.

Hikurangi Land Drainage Scheme – No significant issues.

Laboratory – No significant issues.

Water Services – Work is underway on the on the first section by the golf course and this part is expected to be completed before Christmas. The main replacement works are progressing well, as are the reservoir projects on Three Mile Bush and Dip Road.

Transport - Key activities included commencement of preseal repairs and finalisation of unsealed rehabs for the spring season. A total of 5250 dispatches (individual works items) were completed across the network between 30 September and 31 October 2024.

Parks & Recreation

Issues with rough sleepers and PVD's are raising their head as we move into the warmer months. Current hotspots include:

- Blue Goose: New PVD moved into park and now demanding Council make good the environment for her enjoyment. Long residing PVD's issued Notice to Vacate by the end of November
- Parua Bay: Tent community of approx. 12 tents set up camp and beginning to show signs of unruly and disruptive behaviours
- Beach Road, Onerahi: ongoing disturbances of residents by PVD's and people congregating on coastal esplanade
- Tikipunga sports Park: Rough sleepers moved back into area previously cleared.
- Cobham Oval: Preparing for restricted parking enforcement


3. Wastewater

3.1 Health & Safety

3.3 Network Performance

Whangārei Wastewater Treatment Plant (WWTP)

During the first 5 days of October, the Whangarei Wastewater Treatment Plant (WWTP) experienced a peak flow of nearly 20,000 cubic meters per day (m³/d). This peak coincided with 20.9 mm of rainfall on the same day and was followed by a rapid decline in flow. After this initial period, the flow fluctuated between 12,000 and 16,000 m³/d, showing a gradual decrease over time.


3.4 Reticulation

There were no recorded spills to waterways in the October 2024 period.

3.5 Contractor Performance

The graph below illustrates the median actual and target response and restore times for wastewater services in July, August, September and October 2024

In July, the Response time was 117 minutes, and the Restore time was 163 minutes. In August, September, the contractor improved performance to successfully meet the target response and restore times. In October, it took only 55 and 179 minutes to response and restore service respectively.



Whangārei Wastewater Treatment Plants (WWTP)

- Both thickeners no 1 and 2 received Calcium Aluminate Cement (CAC) coating, part of odour control project.
- All inlet work structure were coated with Calcium Aluminate Cement (CAC) coating.
- High flow UV bank 2A was serviced.
- Turbidity analyser was calibrated.
- Grit classifier 1 vacuumed, agitator repaired
- Confined space entry procedure was used to allow operators to clear debris from the grit vortex
- Barfoote Construction are sealing some historic hair line cracks in the digester roof No2 that have begun weeping again. They have been there since day one, just require periodic sealing.

Hikurangi

- Procurement policy for desludging project has been approved. A tender shall be released to various contractors to obtain quotes for construction of polishing pond (settlement pond) to address the total suspended solids (TSS) in the plant treated effluent.
- Expected contract award date is mid-November. Project to be kicked off in early Jan 2025 subject to weather conditions.
- Dosing pump reconfiguration completed. Dosage shall be adjusted to optimize salt quantity to be used.

Ruakaka

- Intensive testing shall be carried for 3 weeks to determine the cause and effects of the non-compliance.
- Pond performance shall be evaluated for BOD, soluble BOD, TSS and NH³ removal.
- In November, dye testing shall be done to check for pond short circuiting.

Oakura

- NRC agreed with the new proposed soil testing method proposed by GHD. Soil sampling to be carried out in November.
- New temperature sensor for UV system to be ordered as it was damaged by Xylem while they were changing the drive nut on the wipers.
- UV system serviced.

3.6 Significant Risks and issues

Overspills at Parua Bay - Proactive works have been undertaken to reduce the impact of overspills

Development constraints – Ruakaka project team are exploring short term opportunities to increase capacity to enable land use consents to be approved. This will increase risk exposure in the time between the consents being awarded and the works being completed.



5. Laboratory

5.1 Key activities in the last month

For October 2024, 1108 samples were analysed for 5534 tests. This represents a 37% increase in test volumes in the year to date compared to 2023. 56% of testing was completed and reported within five days.



Above chart key refers to financial year end.

There has been a significant increase in work for the laboratory across Wastewater and Water services regarding consent renewals. Teams effort appreciated during a period of leave.

Recruitment – The Laboratory Quality Coordinator role has been filled internally as a developmental role in which they will be coached and mentored as she grows into the role.

External recruitment is underway for a new Laboratory technician.

5.2 Significant Risks and Issues

Long days are continuing for the team just getting the work done.

There remains a significant amount of work required to bring the laboratory inventory and stocks up to optimal levels following this month.

Health and safety: One incident last month where a technician slipped over while sampling, no injury was recorded.

The internal incident related to a nut that was noted as missing from a chlorine cradle during transportation. The nut was immediately replaced.



Rainfall


Yet another below average month with only 87mm of rain falling in at the Whau Valley Dam during October, compared to the monthly average of 114mm. Total rainfall for the year to date is 846mm which is 549mm below average for the time of year and the second lowest total since our records began. The graph below from the NRC hydrology team. This indicates rainfall in the Glenbervie catchment for the year is close to record lows.



Despite the continued low rainfall, the dams are still mostly full due to reduced demand over winter and the continued good flows from springs in the catchments. However, as we head into summer it has been necessary to utilise our run of river sources more and conserve Whau Valley Dam. This will result in an increase in operational costs as more pumping will be required. The long-range forecast for the next few months is for normal rainfall with the potential for heavy rainfall events but also extended dry spells. Staff will be closely monitoring the levels to ensure actions are taken early in the event drought conditions start to develop.

Water Distribution

The number of leaks repaired continues to climb slowly as the weather improves and the ground begins to dry out. The quantity of leaks is not significant although it is considered slightly above normal for this time of year. The number of leaks per month for the last year is shown in the graph below.



6.4 Key activities in the last month

This year's main replacements work is with Downer, who have tendered the work and have subcontractors working already. The mains have been replaced on Churchill Street, Fisher Terrace and Lovatt Crescent. Work is still to be done on George Point Road, Grey Street, Griffin Street, Kamo Road, Pentland Road, Russel Road and Seaview Road.

Tenders have closed for the Whangarei Heads water main replacements. This involves three areas of work, by the golf course, from Pepi Road to the Tavern and from the Manaia Club to Taurikura. Work will start on the mains before Christmas. Work has started on investigation for Poroti Trunk Main upgrade and Onerahi Trunk Main upgrade. Work is also underway on updating the Water Network Model. Once complete this will be a valuable tool in assessing growth requirements for the networks and be an important input into the Water Services Strategic Plan.







7.3 Key Activities

Road Maintenance & Renewals Contracts

Key Achievements:

- Key activities included commencement of preseal repairs and finalisation of unsealed rehabs for the spring season. A total of 5250 dispatches (individual works items) were completed across the network between 30 September and 31 October 2024.
- 163 individual work items audited in October:
- 16.58% of ordered works items being audited for compliance (94 jobs audited) of which 86.17% passed, and
- 1.69% of the routine works items being audited for compliance (79 jobs audited) of which 87.34% passed.
- Works delivered across 1185 out of 1564 local roads giving 75% network coverage for October.
- Programme Completion Compliance on both maintenance contracts 80% target
 - 93.23% WDC North Fulton Hogan
 - 74.47% WDC South Downer
- 19 culverts cleared and flushed to maintain drainage flow paths and minimise pavement damage.
- 7.1km of surface water table cleared and restored to ensure free draining table drains and prevent pavement failure due to standing water.
- 44 sump grates cleared to provide a clear path for urban stormwater to enter the reticulated system.
- 1229 unsealed potholes repaired using a mixture of lime and GAP40 aggregate.
- 30 footpath trip hazards identified and remedied.

- 1871m of high shoulder removed across the network to promote positive drainage from sealed pavements and prevent pothole formation.
- 1491.89m² of sealed pavement repairs completed, including digouts, stabilised patches, mill and fills, and AC levelling.
- 416 sealed potholes repaired using industry best practices, including removal of surrounding damage, emulsion tack coating, and waterproofing.
- 119 damaged signs replaced, including street name blades, chevron boards, speed signs, and regulatory signage.
- 8635 road edge marker posts cleaned, straightened, replaced, or newly installed to provide clear delineation of the road edge.
- 970.167m³ of maintenance aggregate spread across the unsealed network in conjunction with:
 - 110 km of maintenance grading across the 677.5 km unsealed network, providing 16% network coverage.





October Programme Completion Summary




October saw the North contract achieve 93.23% of its approved programme, and the South contract achieving 74.47%, falling slightly short of the 80% target.



Monthly Performance Summary

Fulton Hogan's performance score for the WDC North Contract this month reflects the cumulative results of 3 key metrics. Out of 26 metrics, 20 met their target compliance scores, including KPM 30, which pertains to the completion of the agreed programme of works. KPM 39 which cover response times across the lowest levels of network criticality, did meet its compliance target with a compliance score of 99.07% (95% target), KPM 37 and 38 however which is for response times on C5 and C4 critical roads (C1 = lowest, C5 = highest) missed the mark at 93.42% contributing 17 points to the overall score.

Ultimately, a final "at risk" score of 44 was recorded. Notably, the 6 metrics that did not meet their targets were all within 2-3% of the compliance thresholds, indicating only minor improvement or refinement opportunities across the board.






Downer's performance score for the WDC Central/South Contract this month is based on the accumulation of 6 failed metrics, with only 17 out of 26 metrics meeting their target compliance scores.

KPMs 37 and 38 which cover response times across the most critical roads in the central southern network did not meet their compliance target with an average compliance of 84% (95% target). It is worth highlighting however that KPM 39 for C1-3 critical roads met compliance with a score of 95.17%. While there has been a positive trend towards compliance over the last 9 months, there is still an gap of non-conformance being actively monitored and discussed.

Quality KPMs, triggered by inspections of completed works, also failed to meet compliance targets for both ordered works — which resulted in withheld or rejected claims — and routine works, which are paid under a lump sum agreement. The main factors driving non-conformance in this space are the quality of potholes and preseal repairs as audited through pre claim checks. This is the main focus of contract meetings, and additional meetings with key staff are to be had to further assist with this shortfall.

Road Lighting

 Council is working on the final stages of implementation for the streetlight central management system. This is a control system like the traffic signals that allows for the operational status of the lighting to be reviewed and faults communicated through a web portal. We expect that this will reduce the need for night inspections going forward.

Traffic Signals


- SH1/Kamo Rd closure: WDC assisted NZTA and their contractors to complete a road closure of Te Rauponga Dr on 4/11/24. This was successful, however a fault did occur post closure which was resolved the following evening (traced to a software mismatch).
- CSL did well to complete temporary software to allow special event closures of a section of Porowini Ave in 72 hours. This was used on 12/11/24 to make the area safe for marae visitors involved in the hikoi.
- A new initiative is underway (Art on Boxes) in association with Venues & Events and Creative Northland to apply art to selected traffic signal control cabinets. This is to improve the appearance of the streetscape and to assist with managing graffiti on cabinets. Local artists are being used for this work and CSL is assisting with their safety while in the road corridor.
- Rust Ave Rail bridge Over height Warning signal The new detection system is essentially complete and operational; commissioning review has been completed. The contractor is installing additional communications equipment to improve remote access and viewing at this location, expected completion end November.

- Works at Whau Valley to address communications is now complete and the connection of this site to fibre has successfully treated the drop-outs experienced with the weak cell reception. There have been no further drop-outs of communications since the migration to fibre.
- The power outages over recent times have highlighted there is a need for resilience work to enhance security of power supply by providing backup supply at selected sites. This is being considered for future works.
- We have been experiencing an increase in graffiti on all traffic signals equipment and this is taking quite a bit of time to remove. Stickers are a particular problem. It is hoped that the Art on Boxes mentioned above will assist with this on cabinets, going forward.

Mechanical Bridges

- Contract 24042 Cleaning and Minor Works is currently being evaluated.
- Kotuitui Whitinga bridge project to address handrail corrosion resulting from paint deterioration is now completed. The additional health and safety monitoring and measures have ensured a safe and successful completion.
- Routine cleaning of both bridges has been completed.
- Te Matau a Pohe W1 machinery pit: The structural steelwork for the platforms is currently being fabricated in the contractor's workshop in modules, this is approximately 30% complete.
- Installation will be scheduled once this process is completed.
- Te Matau a Pohe hydraulic lines under the bridge has been inspected using a barge and cherry picker this month and we are awaiting the contractor's report.
- Kotuitui Whitinga annual routine maintenance has been completed.



Road Safety Promotion activities

Road Safety Partners are working in collaboration with NZ Police, ACC, Auckland Transport and Waikato road safety partners to deliver a campaign aimed at drink driving. With record breath testing from NZ Police, the initiative will look at encouraging people to think about their drinking and to make an appropriate plan keeping everyone safer on the roads.

The Uretiti Driver Reviver stop season has kicked off again with the first one being held over Labour Day weekend. The stop had 82 vehicles stop with 174 people (compared to last year with 50 vehicles and 110 people) take advantage of what was available, including a free coffee or cold drink and something to eat. There is a toilet available, and it provides people an opportunity to stretch their legs and discuss their journey ahead. The dates for the rest of the season are as follows:






Public Tree Maintenance

A key performance target of the contract is to undertake 80% proactive planned maintenance and 20% reactive and responding to Customer Requests.

October saw a continuation of September with Treescape having a good month on the proactive street tree cycle programmed work. CTN work has slowed down due to access issues with Treescape being able to get onto Northpowers network to complete reclose block requests to work around 11Kv (high voltage) lines.

The completion of the request work will slow down as the cost of traffic management is high and the allocated budget for this is fast disappearing. Treescape and trying to manage this cost with different ideas and trying to complete whole streets, rather than just heading to a site to complete one tree and then moving on.

Improvement in the number of requests completed and closed. Treescape have been talking to Rachel Thomassen at council about requests as they are currently having issues with extending time frames and requests being closed and then reopening several days later. This continues to be an issue, but Treescape continue make progress in this area.



Walking Tracks

Regular maintenance is occurring on the tracks and walkways at present.

Drummond track report was received in May which has two alternative routes highlighted in it. This report has been passed onto Hapu and we received feedback from the hapu advisory group in June. WDC, Frame group, NRC and Hapu representatives meet in August and walked the two options for the Drummond track realignment. The discussion was positive, and it was supported by Hapu to proceed with option 1 traversing over archaeological sites as this was the most resilient long-term option. We are progressing with the design and engineering stages of this work. This track remains closed, although a high number of members of public still using this track. We anticipate the track reopening in March 2025

Coastal Structures

Maintenance is slowing down due to budget running out. We will have all our main boat ramps due to be steam cleaned before the Christmas period.

Touch rugby is growing capacity and now starting to look for more availability of fields.


Match report excerpt - New Zealand Cricket:





A quite month for us with fine weather and only 8 burials. Maintenance has been going well, and everything is growing well.

We have planted Sunflowers at the Stillborn baby's memorial wall this year and they have just started to flower now so will look fantastic soon.

Kioreroa cemetery has been the only cemetery with minimal maintenance due to it being land locked and we have struggled to get access. Previous discussions with the only drive access available to us has resulted in a flat "not to be used". The owner of the driveway is hopefully going to grant us access (awaiting and email) so we can schedule in regular maintenance again.

Parks and Gardens

For the 2nd month in a row, we saw lower than usual rainfall totals, with October adding up to 60mm for the month. This has led to the ground drying out earlier than usual and the grass growth is already slowing down.

We are currently changing over the annual bedding displays, removing the winter bedding and preparing the sites and planting the summer bedding displays. Compost is being added to a number of sites where the soil is starting to be a little degraded.

Citycare had a teaml involved in assisting Blomfield Special School with a tree planting event at Raumanga Valley Reserve. The area was pre sprayed and all 50 trees were planted by the children with staff from Citycare and Blomfield assisting them.

Grass growth rates which have been high, have plateaued and are starting to low with the dry weather. This could well change if we have a wet spell. Turf spraying is underway, with high profile sites been targeted for turf weeds including Onehunga weed. This spraying starts at 4am in the high-profile sites, finished by 7am. The contractor then goes to sites with little use to continue spraying. At all sites signage is displayed and left on site until the spray is dry.

We will be starting a number of renewals in Waihoi hoi reserve on the 18th November. This will include a number of path and furniture replacements

At the Maritime festival, Citycare worked with Wasteless to reduce the amount of waste taken to the Resort by about 2/3. This partnership is proving to be very effective and promises large reductions of waste going to our landfill from events.

There seems to be a spate of theft and vandalism in the playgrounds area with recent issues including the theft of a basket swing at Totara Parklands, an overhead mono rail stolen from Kamo Sports Park and a large amount of paint splashed around the Potter Park playground.

We are planning on renewing the Beach Rd playground this year and will be carrying out consultation in November, with a plan to construct the new playground in March.

9.6 Significant Risks & Issues

- Home owners encroaching onto Esplanade Reserves for personal gain identified. Most notably One Tree Point where homeowners have built fences across the reserve limiting community access. Encroachment policy being developed.
- The four existing reserve management plans (Kensington Park, Parihaka and Hatea River Reserves, Pukenui Forrest and William Fraser Island on Pohe Island) have all expired. They are now being renewed.
- Ongoing issues with homelessness on parks. Parks and Recreation continue to manage the situation as per the adopted framework.
- An increasing number of fields and parks are being accessed by small vehicles and motorbikes and causing damage to sports fields and parks. It is logistically impossible to stop motorbikes accessing parks and sports fields.
- Permanent Vehicle Dwellers (PVD's) in Cobham Oval carpark. Bylaw has been changed and signs will be installed before the end of November.
- Future investment and ownership structure required to maintain Aquatic facilities for the community needs to be considered based on asset considerations. A report on future ownership options will be brought to Council in 2025.

This attachment provides a summary of the award process and works being undertaken for Infrastructure contracts awarded under Chief Executive and General Manager delegated authority.

1 Water

CON24031 Contract Award: Whangarei Heads Water Mains Renewal

Chief Executive Approval

The contract for CON24031: Whangarei Heads Water Mains Renewal be awarded to Northern Pipe and Civil Ltd for the maximum sum of \$2,199,608.45 (Two million one hundred and ninety-nine thousand, six hundred and eight dollars, and forty-five cents) excluding GST, which includes a risk allowance of \$286,905.45, (Two hundred and eighty-six thousand, nine hundred and five dollars and forty-five cents) excluding GST, that will be managed by the Engineer to the Contract in accordance with the terms and conditions of the NZS3910 and the Construction Contracts Act of 2002.

Contract Scope

The water mains along Whangarei Heads Road are severely aged and have surpassed their functional lifespan. Frequent pipeline breaks have caused numerous unplanned water shutdowns, directly impacting the Whangarei Heads community. In addition to this, Taurikura area suffered damage from road slips caused by Cyclone Gabrielle in February 2023, necessitating urgent repairs and upgrades to ensure resilience against future extreme weather events. The temporary polyethylene pipeline installed above ground post-cyclone is rapidly deteriorating due to UV exposure, posing an imminent threat to water supply integrity.

This project is part of the Council's Long-Term Plan, where infrastructure upgrades are prioritized to cope with current needs and deficiencies. The design for this project has been completed prior to tendering of the physical works contract. The contract will be separated into three (3) Portions, with Portion 1 running from Scott Road to The Pines Golf Course, Portion 2 from Pepi Road to Crisp Road, and Portion 3 in Taurikura where the above ground pipes will be replaced.

Financial Details

The project has spent a total of \$25,736 (Twenty-five thousand, seven hundred and thirty-six dollars) year to date, on design and professional services. A further \$96,839 (Ninety-six thousand, eight hundred and thirty-nine dollars) is committed for pipe purchase (under an agreement with Waters and Farr) and design costs yet to be invoiced. The remaining budget is therefore \$1,935,425 (One Million, Nine hundred and thirty-five throusand, four hundred and twenty-five dollars) under the Water Reticulation Renewals in the current year of the LTP.

The deficit of \$264,183.45 (Two hundred and sixty-four thousand, one hundred and eighty-three dollars and forty-five cents) will be taken from the Emergency Renewals and Minor Projects as agreed with the Water Services Department, which has a remaining budget of \$514,500 (Five hundred and fourteen thousand, and five hundred dollars.).

The revised budget is sufficient to award the contract for the tendered amount and to cover the projected remaining committed costs through the construction period (refer to Table 2 below).

Procurement Process

The procurement plan for the Physical Works was approved on the 1 August 2024. The procurement process has followed the approved procurement plan. The procurement process followed a single stage open tender, publicly advertised on Tenderlink for 3 weeks, starting on 22 August and was due to close on the 13 September. Upon request from prospective tenderers for extension, the tender closed on the 20 September 2024.

The supplier selection method used is Lowest Price Conforming, containing Pre-conditions. The lowest price tender is opened, and pre-conditions are assessed and scored as a Pass/Fail. A Fail score will eliminate the tenderer from further consideration and the next lowest price will then be assessed until a conforming submission is determined.

Tenders Received and Evaluated

The submissions were opened on the 23 September and all the price submissions were recorded. A total of 8 submissions were received. The tender price of each tenderer is summarized below:

Northern Pipe and Civil (NPAC) submitted the lowest price at \$1,705,265.00, (One million seven hundred and five thousand, two hundred and sixty-five dollars and zero cents) which is \$405,345.40 (Four hundred and five thousand, three hundred and forty-five dollars and forty cents) cheaper than the next lowest price. A post tender meeting was held with NPAC team to discuss their tender submission, including the assumptions made and tagged items, and other items that are anticipated to be encountered but were not included in the SoP. Separate rates for rock breaking, water carting, excavations for >1.Sm depth, and disposal of above ground pipes were negotiated, as well as additional quantity for asphalt reinstatement. A total of \$207,438.00 (Two hundred and seven thousand, four hundred and thirty-eight dollars and zero cents) was added to NPAC's Schedule of Prices, making their total tender price at \$1,912,703.00, (One million nine hundred and twelve thousand, seven hundred and three dollars and zero cents) which is still cheaper than the next lowest price. All tags were resolved at this point.

The preferred and recommended supplier is Northern Pipe and Civil Ltd (NPAC) at a tender price of \$1,912,703.00 (One million nine hundred and twelve thousand, seven hundred and three dollars and zero cents), excluding GST. A risk allowance of 15% or \$286,905.45 (Two hundred and eighty-six thousand, nine hundred and five dollars, and forty-five cents) excluding GST is considered appropriate for this contract due to the risk of unknown extent of rock breaking, additional traffic management, and hard surface reinstatement required. This amount will only be used as approved by the Engineer to the Contract.

The tender price \$1,912,703.00 (One million nine hundred and twelve thousand seven hundred and three dollars and zero cents) is not too far off the Engineer's Estimate of \$1,878,580.00, (One million eight hundred and seventy-eight thousand, five hundred and eighty dollars and zero cents), which only included \$50,000 (Fifty thousand dollars) in risk allowance and did not account for additional rock breaking and hard surface reinstatement. The total value for this contract is \$2,199,608.45 (Two million one hundred and ninety-nine thousand six hundred and eight dollars and forty-five cents), excluding GST

Contract Risk Analysis

During the tender evaluation and post tender meeting, the risks below were identified and assessed and will be managed throughout the contract:

- Rock breaking There is a possibility that rock will be located during pipe laying along the Whangarei Heads Road as some of the sections are reclaimed area, built with rock and other materials. This was tagged by NPAC and a separate rate was provided for rock breaking. As the quantity is unknown, only the rate is provided. This rate will be used in lieu of the standard pipe installation rate if rock is located. A risk allowance of 15% is deemed enough to cover this additional cost, if there is any.
- Traffic management The traffic management costs allowed for in the contract is for normal conditions only. If rock breaking and excavation is required, the project schedule may be delayed which means that traffic management will be extended as well. Since this is a measure and value contract, payment is made only when necessary and based on a preapproved rate. WDC will be working closely with the Contractor to ensure that a

appropriate level of traffic management is provided and maintained throughout construction.

 Hard surface reinstatement - The estimated quantity for asphalt reinstatement in the original SoP is conservative and NPAC raised that this might not be enough. NPAC has provided an estimate quantity in lieu of the original quantity. If the estimated quantity is not enough, the risk allowance can cover the additional cost.
