Purpose

To oversee the management of council's infrastructural assets, utility services and public facilities.

Key responsibilities

- Oversight of services including:

 - Three Waters
 - Wastewater
 - Stormwater

 - Solid waste, waste minimisation and recycling services
 - Parks and reserves
 - Cemetery

- Regular reporting on service delivery
- Compliance

Committee will receive:

- Procurement oversight general procurement relating to the areas of business of this committee, within delegations.
- Shared Services investigate opportunities for Shared Services for recommendation to council.
- Council Controlled Organisations (CCOs) monitoring the financial and non-financial performance of CCOs whose functions would otherwise fall under the scope of this committee. Includes trading CCOs (CCTOs) and those CCOs exempted under the LGA. Responsibilities include:
 - o advising on the content of annual Statement of Expectations to CCOs
 - agreement of the Statement of Intent
 - monitoring against the Statement of Intent
 - o for exempted CCOs, monitoring and reporting as agreed between Council and the organisation

Delegations

- (i) All powers necessary to perform the committee's responsibilities, including, but not limited to:
 - a) the approval of expenditure of less than \$20 million plus GST.
 - b) approval of a submission to an external body.
 - c) establishment of working parties or steering groups.



- d) adoption of strategies and policies relating to the key responsibilities of this committee (except for those that cannot be delegated by Council under Clause 32(1)(f) of Schedule 7 of the LGA).
- e) the power to adopt the Special Consultative Procedure provided for in Section 83 to 88 of the LGA in respect of matters under its jurisdiction (this allows for setting of fees and bylaw making processes up to but not including adoption).
- f) the power to delegate any of its powers to any joint committee established for any relevant purpose under clause 32, Schedule 7 of the Local Government Act 2002.

The Committee does not have:

- i. The power to establish sub-committees.
- ii. The powers Council is expressly prohibited from delegating as outlined in Clause 32(1)(a)-(h) of Schedule 7 of the Local Government Act 2002; being:
 - the power to make a rate
 - the power to make a bylaw
 - the power to borrow money, or purchase or dispose of assets, other than in accordance with the long-term plan
 - the power to adopt a long-term plan, annual plan or annual report
 - the power to appoint a chief executive the power to adopt policies required to be adopted and consulted on under the Local Government 2002 in association with the long-term plan or developed for the purpose of the local governance statement
 - the power to adopt a remuneration and employment policy.

1 Purpose / Te Kaupapa

To provide Elected Members with visibility of upcoming approvals, events and gateways in Infrastructure. This includes approvals that will be completed under delegation.

2 Recommendation / Whakataunga

That the Infrastructure Committee notes the Infrastructure Looking Forward Paper for April 2025.

3 Business Case / Strategy

A draft concept has been developed for Ruakaka Cemetery. This is being developed so that costs and the number of plots that can be achieved on the land can be determined. Once this is complete the sign for Business Case stage will be progressed.

Consultation on a new Marine Hub has been undertaken. The analysis is being undertaken and a report will be brought back to Council to determine whether the project progresses to design.

There has been good engagement with Hapu on the development of Reserve Management Plans. A Council Briefing will be coming later this year.

Council is assessing tenders from short-listed consultants to undertake the technical assessment of flooding risks and mitigation for the urban area.

4 Engagement / Events

April will be a big month for consultation with the Annual Plan, Local Waters Done Well, Parking Management Plan and John Street being the most significant.

Council has identified its preferences for Local Waters Done and these will be discussed with the community on the back of direction from Council. Whangarei is co-ordingating is consultation with Far North and Kaipara councils.

5 Procurement

WDC continue to share the latest Procurement Pipeline with the Civil Contractor industry. The March Pipeline is included in Attachment A.

The Procurement for Renewals is being developed. This will allow more contractors to tender for renewals work outside of the Road Corridor Maintenance contracts.

Procurement and contract awards are underway for

- Whangārei Urban Flood Strategy Shortlisted tenders being assessed
- Northern Growth Area Flood Attenuation project. Preliminary design works awarded, Engagement with the landowners progressed.
- Wastewater renewals. Relining works approved for current contractor under existing contract,
- Ruakaka Wastewater Professional services awarded for outfall and treatment plant. Alternative discharge options tenders closed.
- Stormwater level of service improvements and renewals (Hatea Dr/ Rurumoki St) under tender.
- Caravan Dump Station being designed
- Poroti trunk water main
- Fairway Drive water pump station and reservoir
- Otaika water main renewal in co-ordination with Waka Kotahi
- Loop road water urgent pipeline renewal awarded

6 Delivery

Next month we expect to see work commence on site at Wharf Road Wharf, following the production of materials, and stage 2 Morningside subject to council approval.

Renewals and reseal activity on the roading network will continue at pace as long as the weather and temperature are favourable. Once the weather changes we will see a transition to the unsealed network.

Contract Scope

This Procurement is for the construction of a pavement rehabilitation along 215m of Flyger Road (RP 20-235).

Flyger Road between RP 20 and RP 235 has been identified through the pavement rehabilitation programme as needing rehabilitated.

The site is located approximately 3.5km north of SH1 / SH15 intersection and is considered a low volume road with an ADT 100-500.

The site has been deferred several times and is now at the end of its life and is in urgent need of rehabilitating.

Procurement Process

The pavement rehabilitation programme is traditionally delivered through Councils existing maintenance contracts. Due to programming and resource issues, staff have determined there is a significant risk of this work not being delivered this financial year if it were to continue progressing this work through the established maintenance contract.

The rehabilitation works for Flyger Road have been pushed out previously and the road is now in a state where it can no longer be deferred. This has led to significant frustration from residents and road users. To alleviate these frustrations and ensure maintenance funds are not spent trying to hold this road for another year staff would like to procure this work through a closed contest process.

Five contractors were identified as having the skill set and resources to undertake this work and being able to price and accommodate a shortened tender duration of 2 weeks. Downer and FH are excluded as they are operating at capacity.

- United Civil Construction Itd
- Earthworx
- Ventia
- Asset Construction Limited (ACL)
- Higgins

The risk of having a closed rather than open procurement approach (as per policy) is that we do not get a full competitive process – however inviting 5 rather than 3 mitigates this risk.

There is also a risk Contractors may feel excluded. However, the five chosen have demonstrated past performance or are NZTA pregualified with a local interest.

The benefit of this approach reduces the procurement timeframe meaning that the works can be completed and sealed early April, within the construction season.

Scope of Procurement

Break up and remove the existing fatigued, over stabilised pavement, remove 150mm and replace with 300mm of new basecourse material. Stabilise with 1% lime & 1% cement then seal with a grade 3/5 chip seal surface.

This report covers the operational and capital works for the month of February 2025

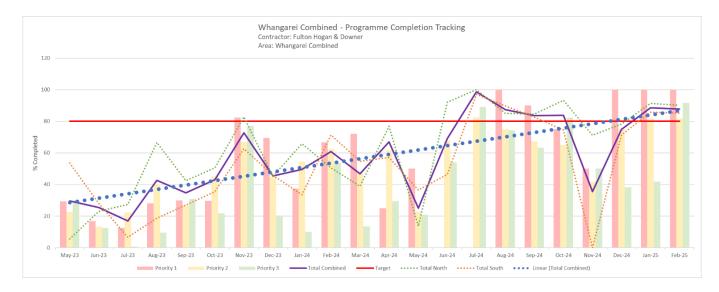
Planning

The Parking Strategy and Draft City Centre Parking Plan has been developed. This will be a Council Briefing in April.

We continue to work with Community Groups in One Tree Point to assist in the development of the shared path.

Maintenance

With both contracts achieving programme completion targets for February its worth displaying historic completion results to provide context to the improvement over the last 21 months. With continual and consistent involvement from WDC supervisors, both contractors now improving their forward works planning outlook to annual and seasonal programmes and minimising the amount of ad hoc reactive programmed works from reducing efficiencies and enabling more holistic approaches to corridor works.



The team are continuing a focus on quality. 159 work items audited in February including 60 ordered works (of which 98.3% passed) and 99 routine works items (97.0% passed).

Capital Programme delivery

Continuation of preseal repairs and resurfacing works.

The Rose Street Bus and T2 Lane projects have a funding end date of end of June and therefore there is significant focus on completing these projects on time and budget.

The Springs Flat Project is a significant portion of the upcoming work and the construction phases is expected to commence over coming months.

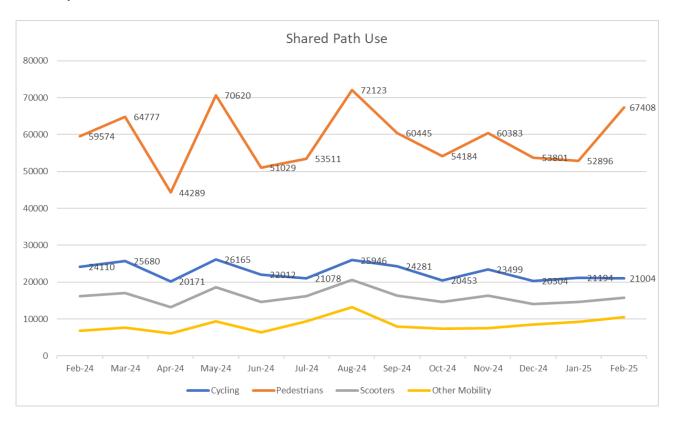

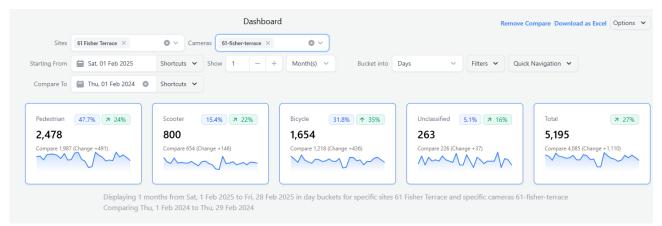
February 2025 saw an overall 7% increase in movements across the network compared to February 2024.

5 Key Activities

5.1 Network Coordination Team (NCT)

NZGTTM Presentation

Hosted a presentation of WDC's direction and approach adopting New Zealand Guide to Temporary Traffic Management

Representatives from Hamilton & Auckland TTM companies (who have satellite offices here) attended, along with local NZTA, FH, Downer, Northpower, local civil company representatives, and Luke Colmer from our Safety team attended. The invite also went to and was accepted by the Corridor Managers of FNDC & KDC.

Discussion Highlights

The Network Team raised and discussed two key topics being competencies and auditing. Meeting representatives validated WDC's direction, as some are already following this approach.

Competencies

This again was validated by representatives at the sessions ie the advice being provided from the NCT is accurate. Proving and maintaining competencies is essential in daily operations. This includes:

- Building evidence of ongoing competency
- On-the-job assessments
- Peer reviews
- Scenario-based drills
- Training refreshers and micro-learning
- Keeping a digital record

Assurance Checks (Auditing)

NZTA, TMNZ, and T8 are adopting TTM assurance checks, like WDC implemented last year. These checks ensure the TTM feels right, safe, clear, and appropriate. Unlike CoPTTM's negative auditing approach, this new method promotes consultation, collaboration, and coordination.

Global CARs

Debated / discussed Global CARs; what was invoked by the previous CAR Team was rigid, provided limited opportunity to flex or consider new ideas on how we best use them. From a risk perspective Global CARs can present an elevated risk but negated / minimised by limiting the number of traffic management diagrams that can be used.

As a result of the discussion the NCT team has been approached for one on one discussions with various attendees – it has been seen as positive for them and WDC.

Forward Work Plans

Scaling back our traditional Forward Work Plan liaison meetings, we will meet all parties on an effective and manageable scale.

First meeting will be WDC infrastructure groups ie Waters, Parks etc. The Network Coordination team has strengthened their relationship with some of the Waters Project Managers over the last six months. We meet for a pre-tender discussion which presents an opportunity for the Coordination team to advise the Roading Managers of proposed work that may be intrusive. From there we will reach out to the likes of Northpower, Chorus etc of their forward work plans which then can be shared to parties that may be affected. This meets the requirements of the Utility Act and National Code of Practice.

Contractor Monitoring Assurance Checks



Nine physical H&S assurance checks of a worksite under TTM were completed by the Network Coordination team.

The team is committed to increasing the number of TTM visits in Mar as this is a mechanism to be visible and validate that we TMDs we review are safe and fit for purpose.

No alarm bells, however, opportunities of considering other methods of TTM continue to be offered.

Events

One rally with no reported issues.

Facilitated a start location change for the Beach to Basin event due to an incident. Collaborated with Sport Northland and TMNZ to safely relocate the start line within 24 hours.

Bouquet

Independent Traffic Control were recognised for their management of a WDC street lighting site: A group of 10 four-year-olds needed to cross the road to the walking track by the site. Your team ensured the path was safe for them, stopped machinery, and even asked what time they would be returning. When the children came back, the same precautions were taken to ensure their safety.

Streamlining CARs

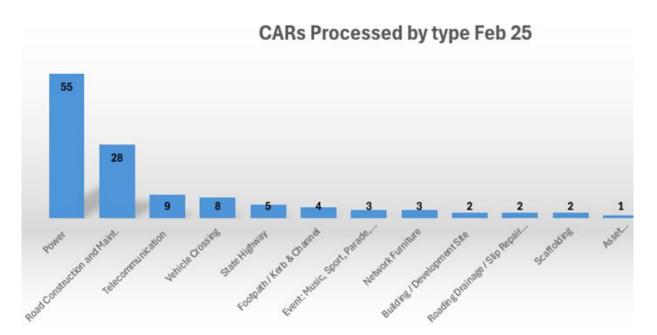
Downer Water

Met with Downer Water to reduce their Child CAR submissions; each time Downer reacted to a water damage they would create a Child CAR and TMD to capture the reinstatement. Discussed with Downer to spreadsheet this with a programmed reinstatement date; Downer has now opened a portal in Microsoft teams where the NCT can view outstanding reinstatements with a due date.

Northpower

Started working with Northpower (and NP Fibre) to reduce their CARs last year; on the back of the NZGTTM presentation they have arranged for the NCT Lead to a meeting 5th Mar with TMNZ. WDC does not require separate CARs for "working at a cabinet" as non-intrusive, no carriageway impact, and minimal pedestrian impact. Wind the clock back three odd years ago CARs weren't submitted for this work as covered under the Global CAR (all low-risk work). With NZGTTM we are taking the opportunity to rethink how Northpower manage this work which again will reduce the NCT input.

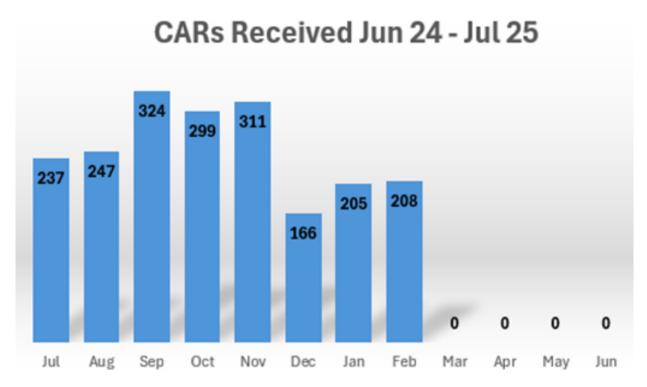
CAR Applications by Type

5.2 Road Maintenance & Renewals Contracts

Key Achievements:

- Key activities included continuation of preseal repairs and resurfacing works. A total of
 <u>5281</u> dispatches (individual works items) were completed across the network between 31
 January 2025 and 28 February 2025.
- 159 individual work items audited in February, of which 4 were found to not be up to standard, resulting in held claims, and rework ordered – Noting that there are works items that do not meet quality standards that are not included within this metric as they are identified and intercepted prior to contractors' claims being presented such as the Pipiwai Road Rehabilitation site.
 - 15.83% of ordered works items being audited for compliance (60 jobs audited) of which 98.33% passed, and
 - 2.02% of the routine works items being audited for compliance (99 jobs audited) of which 96.97% passed.
- Works delivered across 947 out of 1564 local roads giving 60.5% network coverage for February.
- Programme Completion Compliance on both maintenance contracts 80% target
- 90.11% WDC North Fulton Hogan
- 85.25% WDC South Downer
 - 8 culverts cleared and flushed to maintain drainage flow paths and minimise pavement damage.
 - 4.8km of surface water table cleared and restored to ensure free draining watertables and prevent pavement failure due to standing water.
 - 681 sump grates cleared, and chambers inspected and sucked to provide a clear path for urban stormwater to enter the reticulated system.
 - o 64m of damaged and unfunctional cross road culverts replaced
 - 426.091km of kerb and channel swept to prevent detritus buildup and minimse weed growth
 - 15 footpath trip hazards identified and remedied.
 - o 606m of footpath vegetation encroachment cleared
 - 225m of high shoulder removed across the network to promote positive drainage from sealed pavements and prevent pothole formation.
 - 4290.7m² of sealed pavement repairs completed, including digouts, stabilised patches, mill and fills, and AC levelling.
 - 197.29 damaged signs replaced, including street name blades, chevron boards, speed signs, and regulatory signage.
 - o 152 signs straightened, cleaned, and reinstated.
 - 74 road edge marker posts cleaned, straightened, replaced, or newly installed to provide clear delineation of the road edge.
 - 2101.975m³ of maintenance aggregate spread across the unsealed network in conjunction with:
 - 135.295km of maintenance grading across the 677.5 km unsealed network, providing 20% network coverage.
 - 187442m2 of chipseal resurfacing completed to maintain surface integrity and prevent formation of potholes.

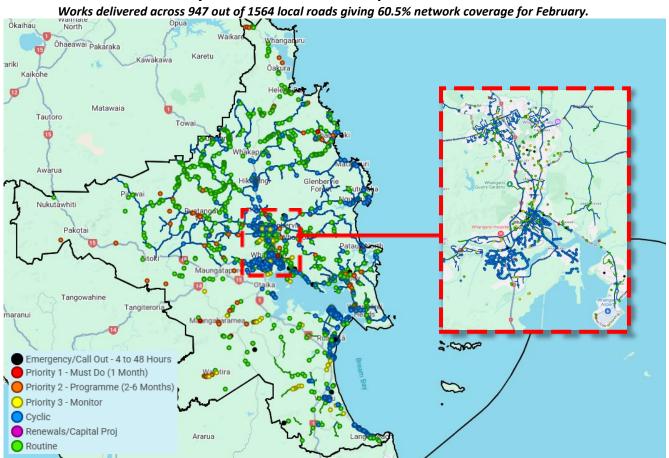




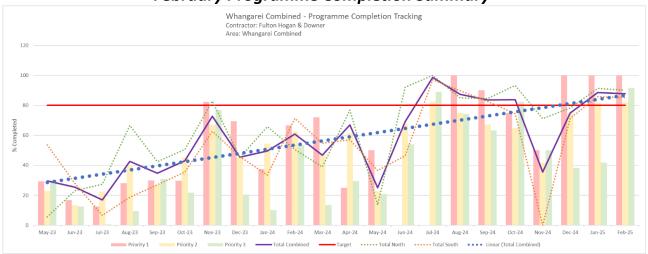

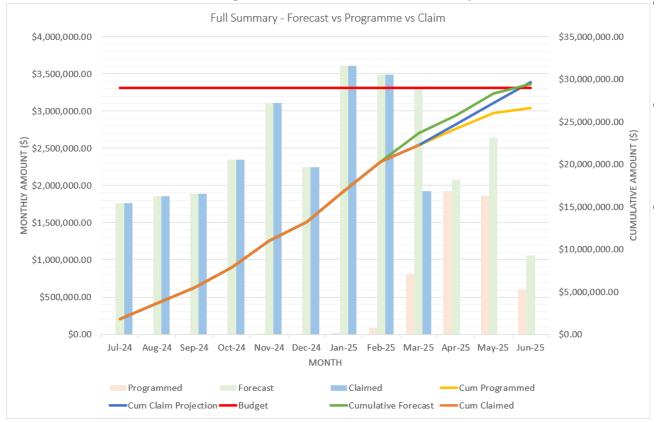
February Programme Completion Summary

With continual and consistent involvement from WDC supervisors, both contractors now improving their forward works planning outlook to annual and seasonal programmes and minimising the amount of ad hoc reactive programmed works from reducing efficiencies and enabling more holistic approaches to corridor works.

5.3 Emergency Works Recovery Programme

Phase 3 Delivery

Investigation and option reports are being reviewed for Memorial Drive. Consultants continue to work on information that will support a direction for the Whangarei Heads slips at Reotahi and Taurikura. The site at Mania Club has moved to Phase 2 delivery – this involves councils maintenance contractor re-constructing the shoulder and re-levelling the pavement. Panel agreements have all been signed and works are being priced for construction.

5.4 Road Lighting

Council has the streetlight central management system up and running and working
through some items relating to posting of faults and summary reporting are still being
finalised. This is a control system like the one we use on the traffic signals that allows for
the operational status of the lighting to be reviewed, and faults communicated through a
web portal. We expect that this will reduce the need for night inspections going forward.

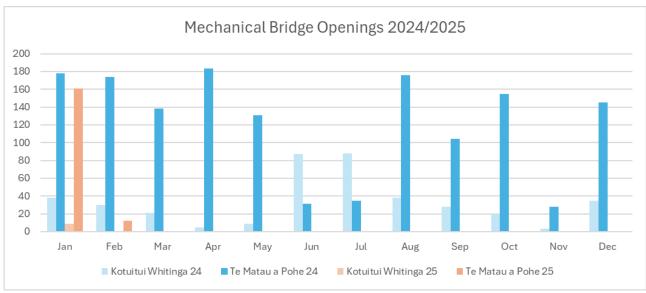
5.5 Traffic Signals & Intelligent Transport Systems

- SH1/Kamo Rd closure: WDC assisted NZTA and their contractors to complete a road closure of Te Rauponga Dr commencing on 12/1/25. This is underway at time of this report and is completed. Some further work has been done to install vehicle detection cameras on this intersection and upgrade communications to fibre.
- Sealing and detector replacement works at Bank St is now complete.
- CSL did well to complete temporary software to allow a special event closure of Vine St to ensure the safety of the Vibes on Vine event in February. This has been commissioned and been through the entire process from concept to completion of testing in 3 weeks.
- The Art on Boxes project in association with Venues & Events and Creative Northland to apply art to selected traffic signal control cabinets is now complete with art on ten cabinets. This is to improve the appearance of the streetscape and to assist with managing graffiti on cabinets. Local artists were used for this work and CSL assisted with their safety while in the road corridor.
- Since installation of the art in December we have had to address one lot of tagging at Rathbone St/Robert St, which Creative Northland removed and repainted. No further incidents have been reported.
- There has been comment regarding congestion at Hospital Rd. WDC is working with NZTA
 to install additional detection on Hospital Rd to ensure that the system registers queues on
 Hospital Rd correctly. This requires a software upgrade to the intersection which is currently
 being procured. Completion of this work is expected end April.



5.6 Mechanical Bridges

- Te Matau a Pohe W1 machinery pit: The structural steelwork module fabrication for the platforms is now complete and installed, ready for final inspection.
- Further work is ongoing in the machinery pit to facilitate future servicing requirements for the hydraulic system as we expect to need components to be refurbished going forward.

Overview

A two-day driving course was held on the 20th and 21st of February 2025, followed by the AA mobile testing unit onsite on the 25th of February .

The event took place at Te Ora Hou Northland (TOHN) in Tikipunga, Northland. The course was led by two experienced facilitators, Amanda Smith and Longi Taulafo, both from TOHN.

The course attracted a diverse range of 13 participants, while most were teenagers, there were also teenage parents (both mother and father) and an individual in their 70's. Some participants had been driving for an extended period without a license, facing various ramifications such as fines.

The primary objective of the course was to educate and assist participants in obtaining their driving licenses, thereby reducing legal and financial repercussions and promoting safer driving practices.

The event was a collaborative effort aimed at fostering safer driving habits and reducing unlicensed driving within the community.

By providing practical education and support, the facilitators contributed significantly to the participants' journey toward becoming licensed safer drivers.

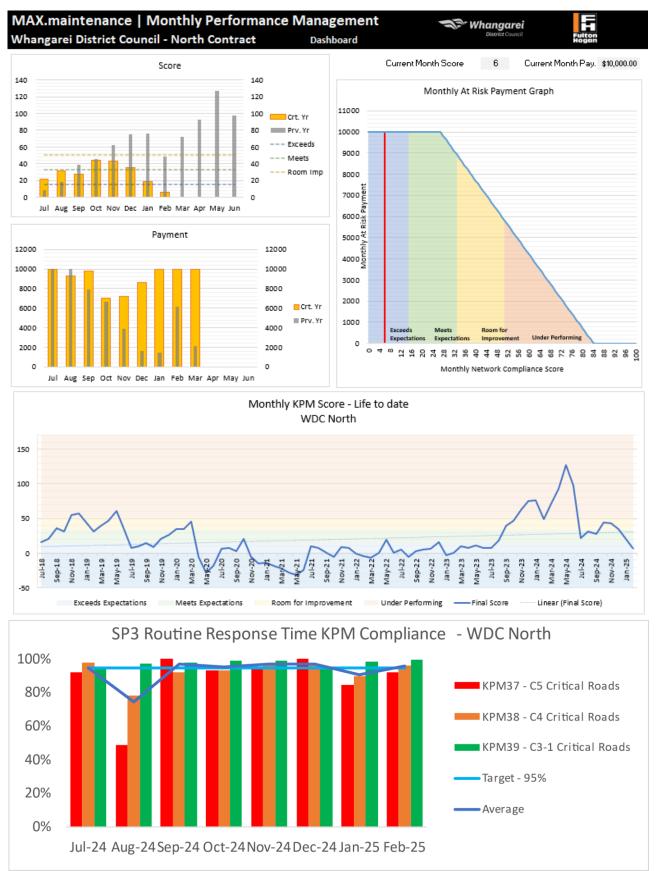
Both Downer and Fulton Hogan carried January's performance into February with ongoing strong performances. Downer achieving a near clean slate across all key metrics correcting shortfalls from last month, only just missing the targets on 2 of the routine response metrics, falling short on sealed network quality audits by **0.12%**.

Routine response times for both contracts were close to full compliance, with only a few minor jobs causing failures. These instances were primarily due to data management challenges rather than actual delivery issues. Overall, both contractors are trending positively in response time compliance and Key Performance Measure (KPM) scoring, with Downer continuing to show a clear and measurable improvement in routine response times over the past 12 months. In the North contract area, annual drainage inspections are still behind schedule; however, additional resources from their State Highway Network Outcomes Contract (SHW NOC) remain allocated to ensure targets are met by year-end.

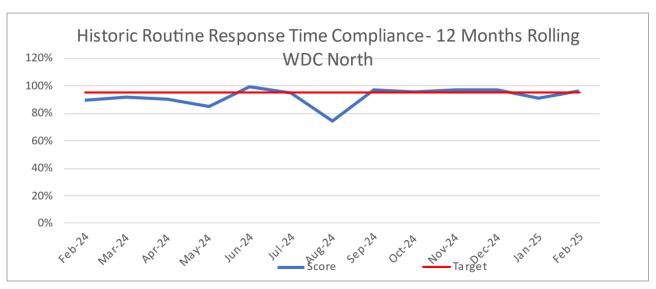

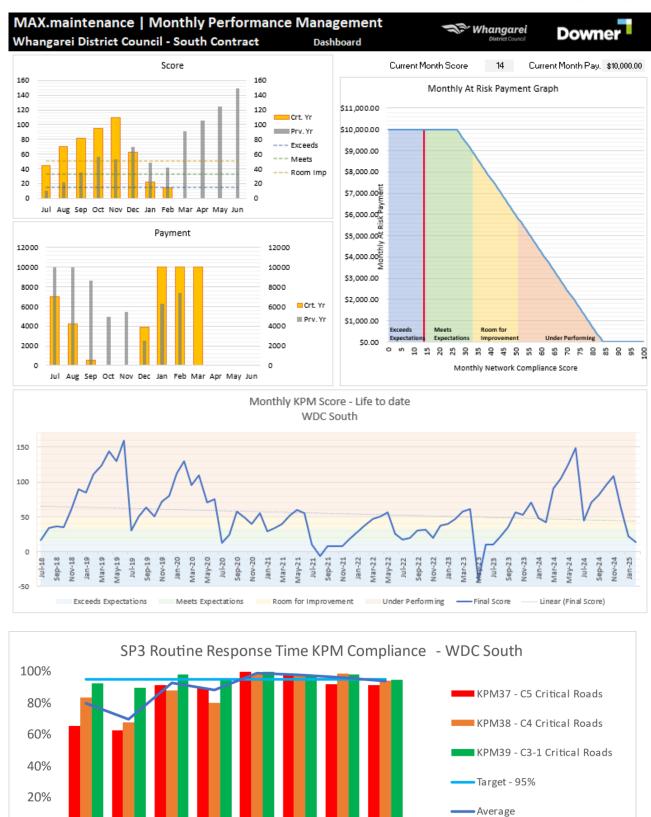

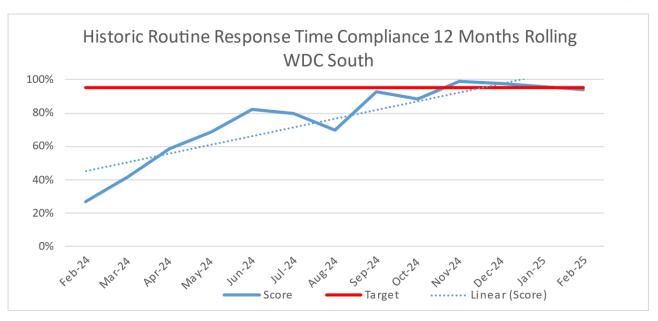

8 Capital Work

Delivery against Capital Programme

The focus has largely been on pre-seal repairs and site-specific repairs ahead of bulk renewals, reseals and drainage work. This will result in a greater spend towards the back end of the construction period.

The Rose Street Bus and T2 Lane projects have a funding end date of end of June and therefore there is significant focus on completing these projects on time and budget.

The Springs Flat Project is a significant portion of the upcoming work, and the construction phases will commence over coming months now that council approval has been granted.

RAG Status is Amber as the programme is very tight and there is a risk of the project completion exceeding the end of June deadline for funding.

The Kamo Priority Lane is approaching completion for the installation of the line marking

The priority lane will be opened in mid-June.

NRC would like the lane to be live for 3 months to see that there are no adverse effects on running times and that the passenger numbers are increasing before they start a phased increase in the bus services.

There are three other elements of the project that are underway.

There is an ancillary concrete works package of works that is currently being priced by the market, estimated to be completed in the next 6-weeks.

The signalised crossings work is being carried out by the ITS Maintenance Contractor and is programmed to be complete by the end of June. Some of these will replace zebra crossings which will allow traffic flow to be improved.

The bespoke enforcement camera poles have a 12-week manufacture lead time. We are expecting them to be installed in the first week of July and for testing to be carried out over the subsequent four weeks ready to start collecting infringement data early August.

These project works are being paid for via CERF and the additional 500k approved by Council for Section 2 (Whau Valley lights to Hailes Road).

Monitoring information for the lane will be collected after the NRC bus services have assumed their maximum frequency level as a result of the project, which may be by December 2025. (It is also collected continuously, and interim data is available upon request from NRC).

The detailed design is approximately 95% complete. Five submissions have been made to the WDC consent application. These mostly relate to noise and vibration concerns and discussions with these submitters are commencing. Two of these submissions have subsequently been withdrawn and we are currently working with the other submitters. The NRC consent application is still being processed.

The box culverts have been manufactured and delivered.

Two houses are being temporarily located onto residual Council owned land at the site (6 Pearce Dr) and a subdivision of this surplus land is being planned to maximise the value of the land and houses. This house removal work is underway.

The purchase of five properties has been completed. Another partial property purchase was approved at the February Council meeting and is to be settled in March. The final partial property purchase should be going to the March Council meeting for approval.

The Infrastructure Agreement with the supermarket developer has been finalised and is likely to be brought to the March Infrastructure meeting for approval. This includes the enabling works for the roundabout including earthworks and drainage works. The Infrastructure Agreement for the Beacondale Link developer is likely to be brought to the April Council meeting for approval.

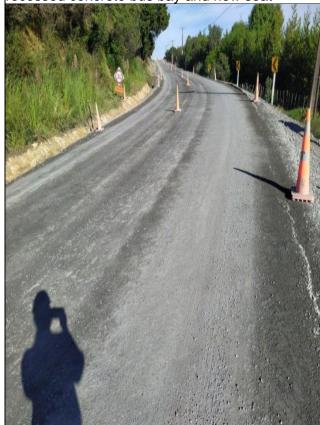

1 Executive Summary

This report covers the Operational and Capital works for the month of February 2025

Parks & Recreation

Sarah Snowden has joined the team as the Sports Development Officer replacing Gemma Aspden. Sarah came from Seminoff Stadium where she was an Operations Manager looking after Stadium Infrastructure and Pitch Management.

Vandalism and theft continue to be an ongoing frustration for Parks and Recreation. Our playgrounds continue to be vandalised with equipment stolen or damaged. We are having multiple padlocks cut off our gates to give people access to our sites. The availability of battery powered power tools is making this far easier these days.

This summer has seen a massive increase in wasps around the district and the number of requests to control nests has been well above previous years. This is having a financial implication on our Pest Management funding. We are now prioritising these Requests, only attending to nests that have significant public health and safety issues.

Planning for the new Sports Hub continues with the preferred location to be confirmed at a Council Meeting in March. Alongside the negotiation there will be an Integrated Transport Assessment.

Consultation with the community and stakeholders for a future water sports hub expired end of January and analysis of the consultation is taking place in February and March. Progress on the renewal of four Reserve Management Plan's continues with Hapu engagement planned for March.

Initial consultation with the community and Hapu on the renewal of the four reserve management plans (RMP's) (Kensington Park, William Fraser, Parihaka and Pukenui Forests) was completed in March. Next phase is to draft the RMP's for community consultation. Hapu are particularly interested in a strategic partnership for the management of Parihaka and Pukenui Forests given their cultural significance.

Waste Management and Minimisation

A solution to the leachate issue at Pohe Island has been developed. This is intended to resolve the issue caused by a stormwater pipe associated with the pump track that has allowed leachate to enter the water course. An interim solution is in place to avoid contamination.

The Minister for Environment has confirmed that they are "not currently considering policy options for a container return scheme. However... intend to *reform the Waste Minimisation Act 2008 and the Litter Act 1979* to ensure that New Zealand has a modern, fit-for-purpose waste legislation that gives us more options and flexibility to reduce and manage waste effectively and efficiently.

Contractor incidents

A concerning <u>near miss</u> occurred when a recycling truck runner was struck and knocked over by another rear loader truck. This resulted in minor injuries but could have been much worse.

Another <u>near miss</u> occurred when the safety arm of a rubbish truck lowered during travel and the runner fell off the truck onto the road resulting in only minor injuries.

Two <u>Lost Time Injuries</u> were reported – One overextended knee from stepping off a kerb resulting in 3 days lost time. The other was a back sprain moving timber wheel chocks resulting in 1 day lost time.

The two <u>environmental incidents</u> were reported from the Ngunguru Seawall replacement project – one dust complaint and one instance of midden being uncovered.

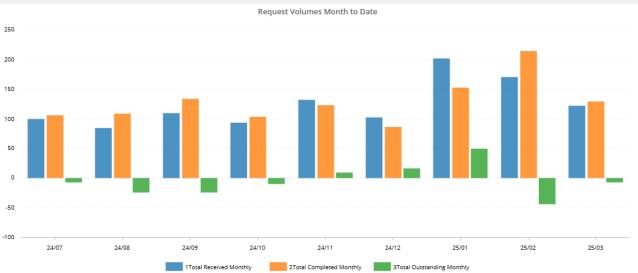

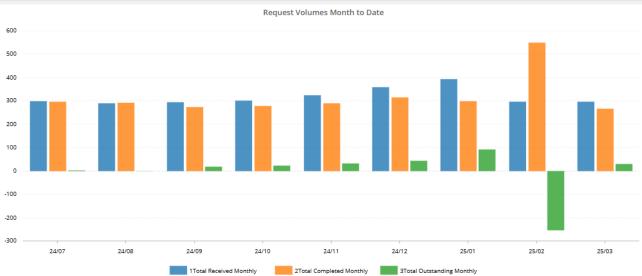

4.2 Network Performance

Over the last year we have made significant progress through the appointment of a Contractor to oversee coastal maintenance works. However there remains a large backlog of work in the Coastal Activity and work is being undertaken to quantify this so that appropriate budgets and resourcing can be applied in future Long-Term Plans.

In the cemetery area we have identified an impending lack of capacity. A request to bring forward Budget will be brought to Council.

No issues of significance across Parks, Gardens, Walkways and Tracks.

Northland Waste's performance is back up to speed after facing sudden resourcing issues requiring a number of new staff to be brought on. All staff are up to speed and the number of community requests have dropped.



4.3 Key activities in the last period

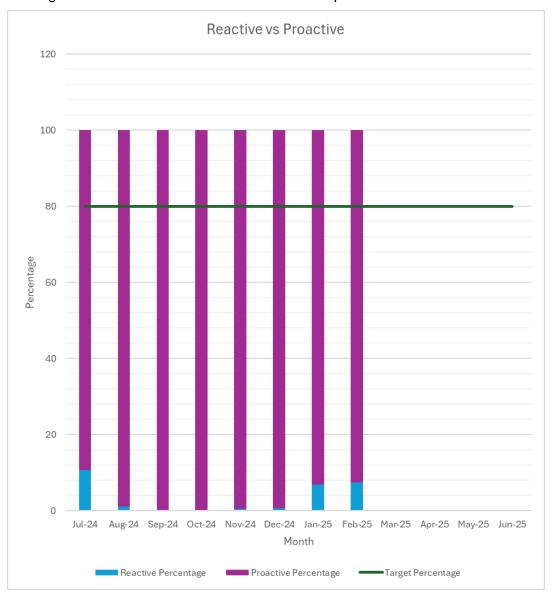
Public Tree Maintenance

Treescape were ahead of the yearly spend but over the last three months this has back to align with normal budget amounts.

Treescape began the powerline works for council trees in February, which is great, after final getting sign off from Northpower.

Treescape have been CRM focused in February and is making good progress on them, this is influencing the scheduled works program, this should improve in March.

The cost of traffic management is impacting on budgets, and we are prioritising works accordingly. We are working with then contractor on efficiencies to compensate.





Walking Tracks

Regular maintenance is occurring on the tracks and walkways at present.

The archaeological report along with Hapu support for Drummond track has been resubmitted to Heritage NZ, we will hopefully receive the archaeological authority from Heritage NZ in March.

Meanwhile, Frame Group has begun the process of applying for building consent for the staircase, which is an essential component of the new track. The goal is to go to market between late April to award the project to a contractor.

Coastal Structures:

Maintenance has been minimised in the last month to stay within budget. Hoskin Civil have stopped the 3-6 monthly inspections and Dean is trying to get around all structures before his finish date to have an up to date round of inspections. Dean will be leaving this position on the 10th April.

Urquhart's Bay Wharf: Major decay (wood worm) has been found in the piles of this wharf below the low tide mark, I have had Steve Bowling Contractors crew do a basic inspection and they feel we don't need to close it now, but we need to make a plan quickly to ensure it doesn't become dangerous. I have engaged RS Engineers to assess and give WDC some options.





Albany Rd Sea Wall update – The Sea wall has been surveyed, and concept rock revetment plans done and sent to residents for comment – 5 x emails received all opposing the rock revetment.

Met with 7 Local Residents, Councillor Halse and Cooper on the 19 February to explain why rock revetment was our preferred option (cost and longevity). Locals oppose this option due to various reasons, and it was suggested by a local if they contribute to the cost could other options be reviewed. This was a positive option which will be reviewed by the team. Local hapu will support both options.



Sports Parks

February was another warm and dry month, resulting in some grass loss on non-irrigated fields. A continued lack of rain will severely impact these pitches moving into the start of the sporting season. Delayed irrigation on sand pitches under sown has limited growth requiring additional under sowing in March. Mowing has been manageable, as much of the passive grass has burnt off.

Vandalism continues to impact our sports parks, with padlocks, fences, bollards and chains being removed/destroyed on a regular basis.

Renewals are well underway for Summer, maximising the time that we can have heavy vehicles on our fields. Koropupu Sports Park & William Fraser Memorial Sports Park (rugby fields) LED lighting installation has commenced while both parks have also had their sand slit drainage renewed.

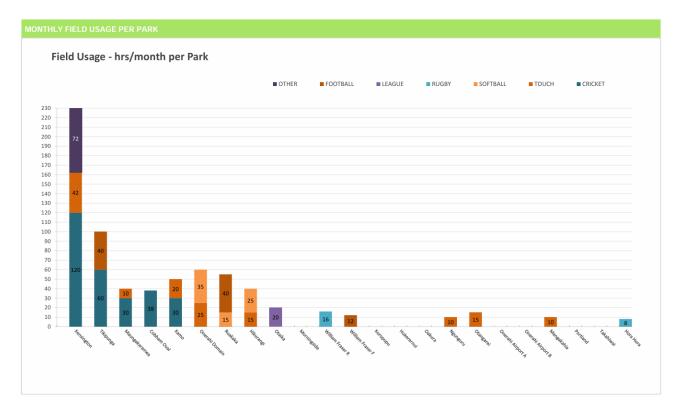
Portland drainage project was started and completed in February, with the dry weather providing perfect conditions to carry out the work.



Northland Cricket Association hosted the second and final first-class cricket match on February 10th, receiving positive feedback from NZ Cricket about the field. Specific mention given to the proactiveness and excellent communication from the grounds team.







Cemetery

February Burials 8, Cremains interments 13, cremations 65

Another dry month but with just enough moisture around to keep the lawns growing. The district cemeteries have had to suffer from lack of maintenance this month due to the mower trailer failing a WOF and needing some repairs. These cemeteries will get maintained soon. The Maunu cemetery has been maintained well with some great comments from visitors. We have had some plant loses with the lack of rain, but only a small amount of grasses lost.

The octagonal book of remembrance building has been under repair also with a new roof on its way and a fresh coat of paint.





Parks and Gardens

February was another dry month with 34mm of rain. This follows the trend for the last 5 months of lower than average monthly rainfall. The slightly higher rainfall in January (128mm) helped replenish the soil moisture content, but this effect only lasted a short time. Grass and weed growth remain slow, with areas of the district looking very dry.

Bedding displays and the hanging baskets are putting on a really good display this year. Our maintenance contractor, City Care, have brought on extra horticulture staff, in an effort to bring all the sites up to spec. Early signs have indicated a better standard in the gardens area, which is pleasing to see.

We are currently working in a more suitable auditing tool for the Parks and Gardens contact. We are creating this through IAuditor and the new audit template is looking promising.

We have completed multiple renewal sites across the district. Our focus has been largely targeting smaller assets such as bollards, furniture and footpaths, and fencing. Below are a few images of completed sites.











We are now looking at refurbishing the Library Pou on site in the standing position. This will be more difficult for the restorers and will come with some additional costs. Our Community Services Group are currently applying for funding for this work.

Playgrounds

The design for the Beach Rd Playground Renewal has been accepted by WDC construction is planned to begin early May.

We continue to receive multiple reports of vandalism and theft across the district over the past few months. All incidents have been reported to the police. In general, playground maintenance has been on track.

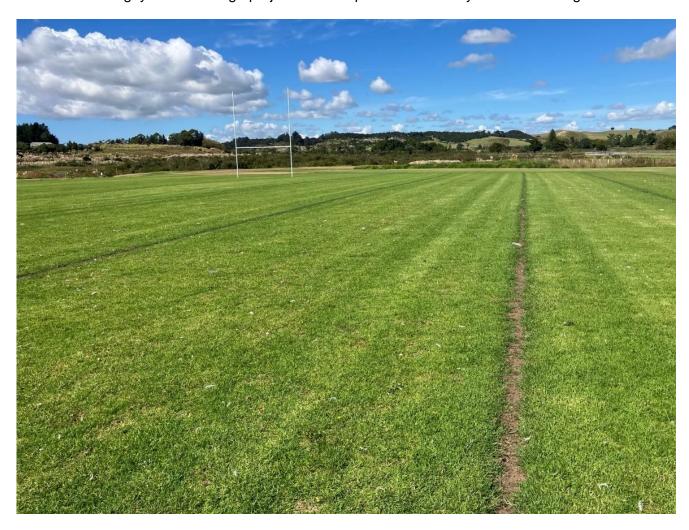
Delivery of Capital Programme

1 Executive Summary

This report covers the following activities in the Waters Group;

- Operational Activities during February 2025
- Capital Activities during February 2025

Key points

- A contractor was injured when he was hit in the head from a burst hydraulic hose. A review
 of proper use of PPE was instigated.
- The dry weather has put pressure on the Whau Valley dam and level 4 water notifications were put in place in March.
- 6 out of 9 wastewater plants were fully consent compliant.
- The Hikurangi wastewater plant is non-compliant, and NRC has issued an abatement notice. Upgrade works are underway.
- The Whangārei wastewater treatment plant has suspended solids levels above the consent standard. Capital works are planned to address this issue (new filter).
- The water supply was fully compliant.
- There were 8 dry weather sewer overflows associated with blockages, primarily fat and rags. Four overflows reached waterways. No overlays at Parua Bay.
- The laboratory processing volumes remain high although expected to drop off in March now that WWTP re-consenting work is coming to an end.
- There has been significant work advanced within our capital programme, of note
 - Morningside pumps station is progressing well. Council is to consider approval of stage 2 works to further mitigate flooding risks in April.
 - Gap analysis work on the Ruakaka wastewater treatment plant and outfall is under way. Works to secure land for the treatment plant has been escalated.
 - Wastewater resilience projects have largely been completed Kepa Rd and Kioreroa Rd rising main.
 - Improvements with our water network through improved reservoir capacity (Three Mile Bush and Kamo) and pipeline renewals (Poroti and Whangarei Heads)
 - There has been advancement in stormwater strategic projects Tikipunga stormwater attenuation and Urban flood risk analysis.
 - Wastewater discharge consent renewals are on track for Whangarei City, Oakura and Hikurangi.

Wastewater – One of employee reported near miss incidents was about a contractor worksite involving a worker in a deep manhole, when it began filling with sewage material, due to inadequate isolation of the upstream pumping station. This was thoroughly investigated and lessons taken from this. An industry safety alert is being prepared.

Hikurangi Land Drainage Scheme – There was 1 incident logged by the Wastewater Department in February involving a fallen powerline that had potentially livened a gate.

Laboratory – The laboratory reviewed all of their department hazards during February.

Water Services – There were three vehicle related incidents logged by Water Services in February. One incident reported about a broken grate sump.

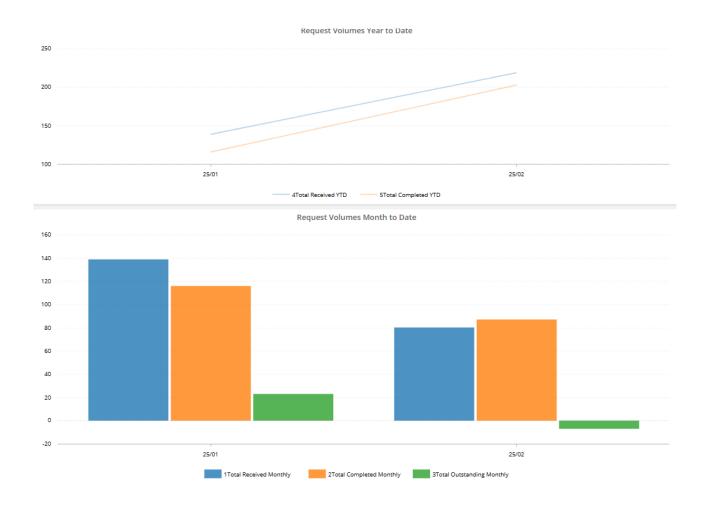

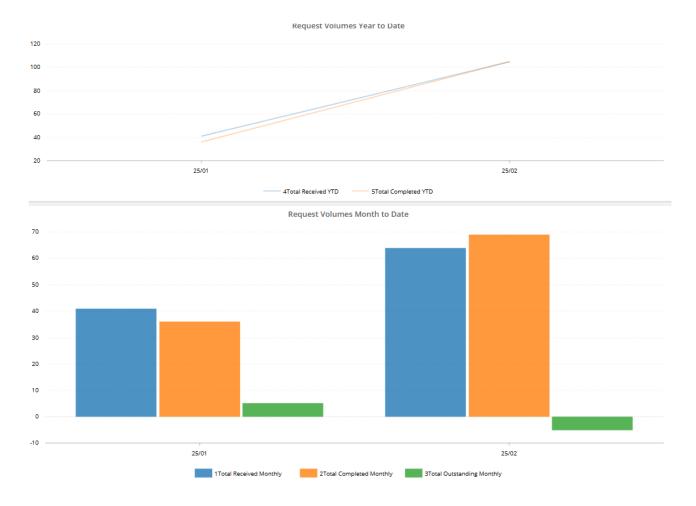
The Wastewater Department continues to receive a steady flow of new requests and staff have been working to actively address these.

Despite the dry weather the Stormwater department received a steady number of requests in Feb 2025. The department continues to work towards resolving them all.





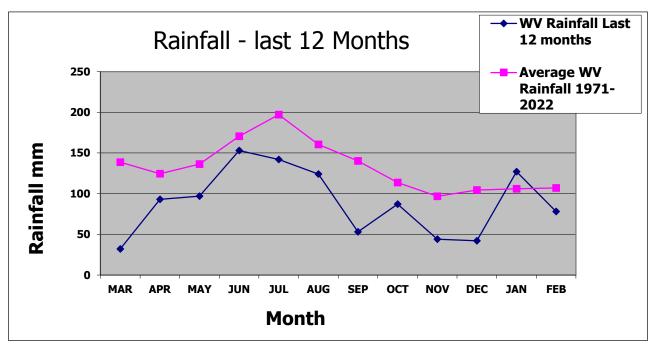
3.2 Overall Performance

Potable Water Department

Rainfall and Dam Levels

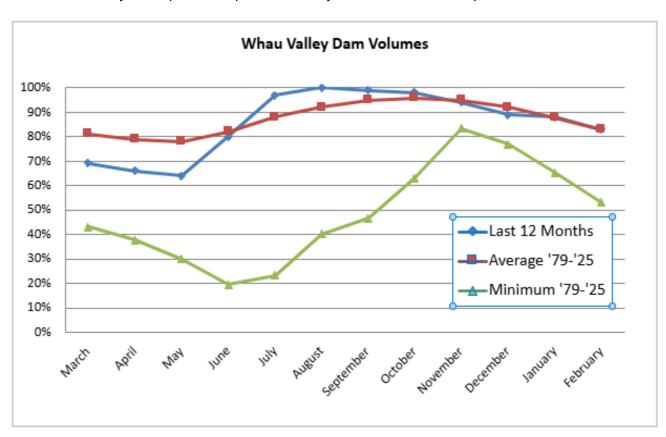
After a slightly wetter January, February, has been another dry month. A total of 78mm of rain fell at Whau Valley Dam compared to the average amount of 107mm and only 15mm fell at Wilsons Dam. Northland is officially in drought conditions with some water supplies in other districts on level 4 water restrictions. This has led to water carriers supplying Kaipara residents requesting to fill up from City or Bream Bay filling points. The long-range forecast is for average rainfall for the next three months but with a dry start to that period. It is therefore unlikely we will have availability issues heading into winter. However, we will need a few wet months over winter to avoid problems next summer.





Dam Levels

The dam levels have dropped slightly but remain around average for the time of year. The Whau Valley Dam sits at 83% and the Wilsons Dam at 94%. The reason Whau Valley hasn't fallen further even though we are in a drought is that other water sources such as Hatea River and Poroti have been used more over the last few months to conserve dam water. It is likely the dam levels will start to drop quicker now the other sources are drying up due to lack of rain. This may lead to implementation of step 3 of the drought management plan if the Whau Valley Dam level falls below 70% in April. Step 3 is to raise public awareness that water levels are getting low, and water conservation may be required. Step 4 is voluntary conservation and step 5 is water restrictions.



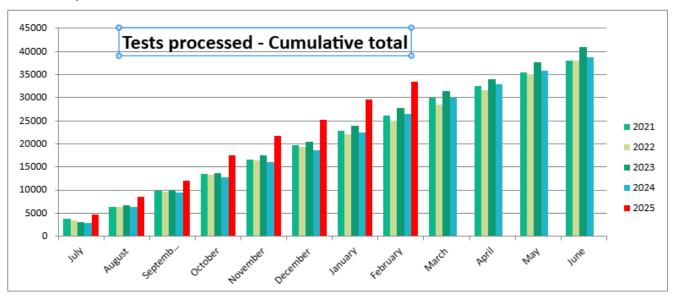

For February 2025, 954 samples were analysed for 3,985 tests. 2,825 of these tests were completed in house, while the remainder were subcontracted. 52% of testing was completed and reported within five days.

A big month from external customers, as well as continuing project work for WDC customers has continued the trend of the last 5 months.

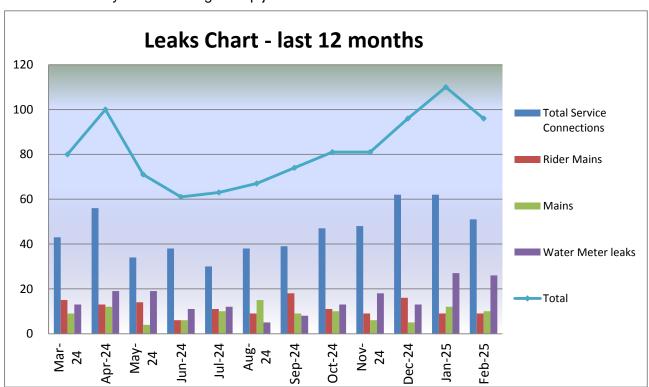

Network Maintenance

The graph below shows the number of leaks fixed in the network over the last 12 months. The rise in summer is normal as the ground dries and movement occurs that can damage the pipes. Also, leaks are easier to spot in dry weather, so we tend to get more reports of leaks during the summer months. February showed a slight drop just because it was a shorter month.



Prior to Christmas a leak was detected in the old reservoir at Fairway Drive. The reservoir was drained in mid-January and repair work was undertaken over a four week period. All visible cracks were fixed but it became apparent that there could be water seeping through the concrete in areas that were not detectable and through previously sealed joints. It is proposed to drain the reservoir again in the winter to undertake further repairs. This reservoir was constructed in 1902 and is reaching the end of its useful life. Staff are looking at options to either upgrade or replace the reservoir.



Wastewater

Parua Bay Inflow into Wastewater Investigations

Property inspections for Block 1 are complete. Block 3 being progressed. There are three blocks in total. Site records are being uploaded directly to ArcGIS using the Field Maps application. Issues identified will be actioned.

Wastewater Network Modelling

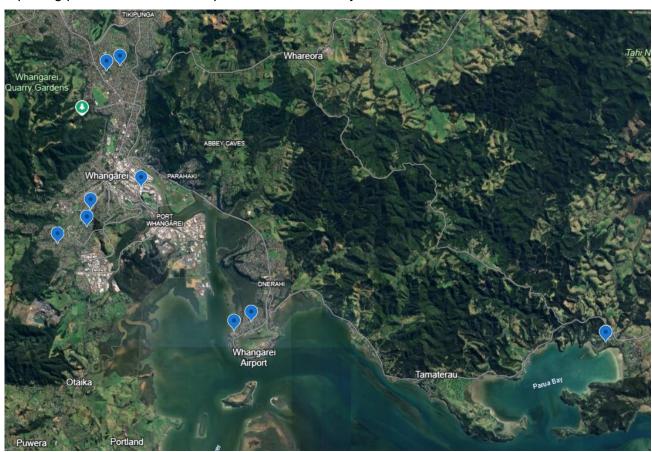
Wastewater capacity assessments are ongoing. Mott MacDonald are progressing with the system performance for the wider WDC wastewater network. This is dependent on model updates.

Gap analysis assessments are underway. Problem identification tasks are ongoing.

Work is in ongoing to improve network asset data.

Reactive Maintenance

A total of 9 wastewater service requests for dry weather overflows were recorded during the reporting period. Four of these spills were to waterways.



The table below provides details of the dry weather overflows including those that resulted in the spill reaching a waterway.



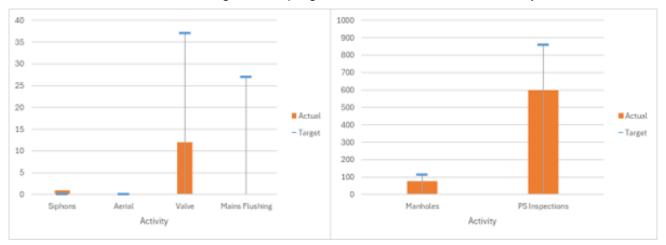

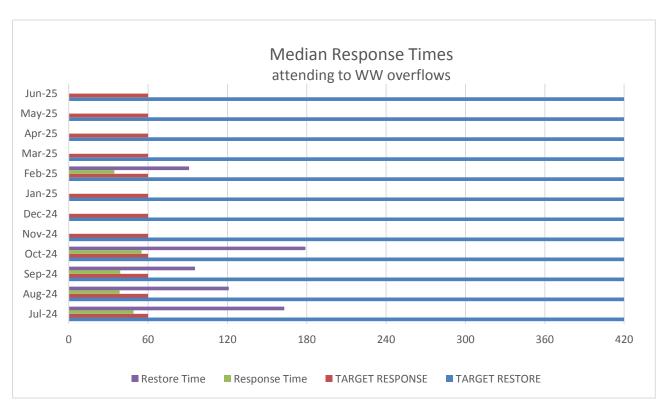

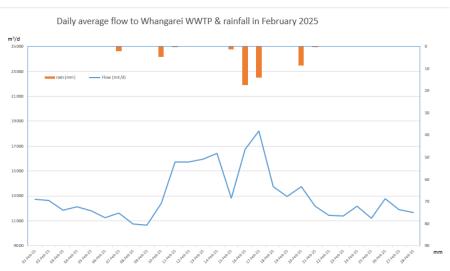
Wastewater

Whangarei Wastewater treatment plant:

During February 2025 the Whangarei wastewater plant experienced highly variable flow rates. The month commenced with stable flows, followed by a decline to a minimum of approximately 10,600 m³ on the 9th. A rapid surge occurred on the 10th and 11th, reaching 15,700 m³, the third highest peak of the month.

Subsequently, flows remained elevated for several days, peaking again at approximately 16,400 m³. A sharp drop to 12,805 m³ occurred on the 15th, followed by a rise to the month's maximum of 18,218 m³. Thereafter, flows generally decreased, stabilizing within a range of 11,000 to 12,000 m³ for the remainder of February.





Main maintenance activities:

- Blade of one surface aerator disconnected and sunk to the floor of the basin
- Dive team and crane went in 3rd week of Feb to retrieve the blade and repair the aerator



- The remaining 3 units shall be checked and inspected in March.
- A new resource consent has finally been issued for the plant.
- Okara 600mm Rising Main has been commissioned.

Hikurangi

- Polishing pond construction progress on programme. Estimate to complete by mid of March
- The receiving bund was constructed.
- The plant configuration needs to be adjusted to optimize the hydraulic retention time.
- NRC to visit the plant in second week of March to understand issues and challenges faced during the plant upgrade.

Ruakaka:

- Aeration in pond 2 restarted following repairs to faulty gearbox.
- BOD at wetland reduced. However, lab tests to be carried out for a further 4 months.
- Ops & Project team had a discussion on how to desludge the plant and moving forward.

Tutukaka & Portland

- Wetland Enhancement Programmes (WEP) have been developed with Hapu's input.
- Ops team have been working on cost/duration estimates for the planting & preparation work
- Duration to be completed 3 years from the date of new consent issued.

Stormwater and Flooding

Mechanical drain cleaning for the Hikurangi flood scheme has been completed in all pockets without any issues. Over 600 tuna were saved and transferred to their habitat.

ATV spraying shall be carried out on 31st March.
