3 Background

The Community Fund is Council's generalist fund to support a wide range of community projects.

The round was advertised for 8 weeks and two workshops were held on Council's funding during that time.

4 Discussion

Round 1 attracted 51 applications – the average previously was 20 applications per round.

In June, Council agreed on a 'modified status quo' of the community funding model. This included:

- funding principles to guide us
- a single application form and report form with more detailed information being sought, and
- widened criteria: minor operating costs, facility improvements and capital purchases up to \$10,000 can now be considered.

About a third of the applications received are requests under the new widened criteria, that would previously not have been eligible.

One application was to purchase a wheelchair for personal use. This would be ineligible as the applicant is not a charitable trust or incorporated society. To protect the privacy of the applicant, the application was declined prior to the Committee's decision and not included in the list for consideration. The applicant has been notified and directed to disability support services.

4.1 Financial/budget considerations

The budget for the Community Fund for 2018-19 is \$170,000. This includes:

- An LTP increase of \$70,000
- A carry-forward from 2017-18 of \$20,000.

The total amount requested in this Round is \$265,739.

The recommended allocation in Round 1 is \$93,293. This leaves \$76,707 for Round 2.

4.2 Policy and planning implications

The Grants, Concessions and Loans Policy (revised version adopted in July 2018) and the Community Funding Guide were applied in the assessment of this funding round.

4.3 Allocations

The applications and recommendations are discussed in the Assessment Sheet. The applications have been sorted by four main themes that will be used to compare allocation of funding from year to year:

- Arts and Culture
- Recreation and Sport
- Heritage and Environment
- · Community Connectedness and Wellbeing.

There are several good applications that have had to be recommended for no funding, as demand for grant funding always exceeds what is available to give.

In assessing the applications, staff looked for demonstrated need, impact and benefit, and the ability to deliver. In some cases, partially funding an application is recommended to show support while also acknowledging the limited budget available.

The following preferences were applied to manage the available budget:

- New applicants were given consideration over regular/repeat applicants
- Time sensitive applications were given preference over those with little or no time constraints
- Initiatives aligned with Council's community development approach were given preference over applications that could obtain assistance elsewhere.

Attachment 2 shows an alternative view of the recommended allocations – by type of request.
