1 Purpose

To allocate grants from the Performing Arts Fund 2018-19.

2 Recommendation/s

That the Committee

1. Approves grant allocations from the 2018-19 Performing Arts Fund as follows:

2. Approves transfer of the unspent budget to the Creative Communities Scheme budget for grant making purposes.

3 Background

The Performing Arts Fund exists to support community groups undertaking a major performing arts event that benefits the wider community or a sector of the community. It aims to encourage performing artists to the district, and support performances and events that may not otherwise occur, for the benefit of the wider community.

The Fund is generally for grants up to \$5,000, but the Committee may grant more in exceptional circumstances.

4 Discussion

Five applications were received this Round, requesting over \$30,000 in total. They cover dance, music, theatre and festival genres.

4.1 Financial/budget considerations

The Fund's budget for 2018-19 is \$22,000. The recommended allocation is \$20,027.

It is recommended that the remaining funds of \$1,973 are transferred to the Creative Communities Scheme budget for allocation in its second Round to support other Performing Art activity. Underspend is generally not carried over to the following financial year so transferring the remaining budget would ensure that the funds are used for their intended purpose.

4.2 Policy and planning implications

The Grants, Concessions and Loans Policy and the Community Funding Guide were applied in the assessment of these applications.

4.3 Assessment

The applications are discussed in the assessment sheet (attachment 1). The committee also has access to the applications in full.

5 Significance and engagement

This is the third end of year show for this dance school and the intent is to create a professional production on a professional stage. Costs include venue hire, pre-show videography, costumes, set, music royalties and personnel. This will provide invaluable experience for the participants. Recommend a contribution of \$3,300 acknowledging the promotional benefits to the dance school which the school can contribute to.	\$3,300
Fale Pasifika (Northland Pacific Island Charitable Trust)	Pasifika Fusion Festival 2019	Feb-19	?	\$	9,896	Established annual event celebrating Pacific culture, food and arts. Still some concerns over budget and event actuals as shown in the financial performance statement provided. Eligibility - 1) The Trust is not up to date with their Charities Services filing, however this may be due to a technical error (there is a date discrepancy on the Charities page). 2) NPICT received \$2,000 this year from the Annual Operating/Events Fund. According to our Policy, an applicant cannot receive multiple grants from us in any year. Assuming that it was not the Committee's intent to disadvantage NPICT but rather to give them the opportunity to improve their application, budget and eligibility status, it was felt that NPICT could apply to this Fund this year only. NB: generally, the maximum allowable grant from this Fund is \$5,000, although the Committee has discretion beyond this. Recommend a contribution of \$2,500 which would be consistent with other event funding provided by Council (when including the \$2,000 already granted).	\$2,500																					
Whangarei Music Society	2019 Chamber Music Concert Series	2019	Yes	\$	4,227	For 4 chamber music concerts in 2019, providing world class music to the Whangarei community. This request is also to upgrade the Society's digital marketing. The society is well-established and collaboration with Chamber Music NZ is sound. Not shown in the application but provided verbally, the Society is aware of the need to increase their membership base and audience numbers, and their first step in doing so is to upgrade their digital marketing. The Society needs support to maintain operating while they seek to address sustainability issues. Recommend full funding.	\$ 4,22																					
ONEONESIX Trust	Increase performing arts content for the Whangarei community	2019	Yes	\$	6,497	Two parts: commission development of one local production by Company of Giants, and the delivery of one touring production. It is encouraging to see that ONEONESIX is now an established legal entity in its own right and is developing a strong strategic focus to proactively programme content. The application has strong supporting documents and letters of support. Beyond providing theatre entertainment, this application seeks to provide stimulating content that provokes conversation amongst young people, and supports local theatre makers in developing their artform. NB: generally, the maximum allowable grant from this Fund is \$5,000, although the Committee has discretion beyond this. Recommend full funding (to maximum allowable).	\$5,000																					
NZ Dance Advancement Trust	Matariki for Tamariki - Northland Tour	Jul-19	Yes	\$	5,000	To bring a dance tour to Northland schools and one show at Forum North. Most of the schools benefiting are outside of the Whangarei district. Professional dance performances here are rare, so the application meets the intent of the Fund. Recommend full funding, recognising the benefit will extend beyond the Whangarei District. Alternatively, partial funding of \$3,000 for Whangarei component of the tour.	\$5,000
